MOU/Agreement Countries

- The Seychelles" Tax Inspectors Without Borders (TIWB) programme was launched in partnership with India, the Income-Tax Department said. The focus of the programme will be on Transfer Pricing cases of tourism and financial services sectors.
- The textiles ministry said it has signed a pact with Germany's GIZ to increase the value addition from sustainable cotton production in India by focusing on sustainable cotton and strengthening downstream processing. It is focusing on 4 majorly cotton-producing states Maharashtra, Gujarat, Madhya Pradesh and Tamil Nadu.
- India and Croatia have signed an agreement for academic collaboration in traditional medicine systems, especially in the field of Ayurveda.
- India and Nepal have signed two agreements aimed at boosting cross-border train services.
- India and the US reaffirmed their commitment to raising \$100 billion annually from public and private sector sources to help develop the two countries' efforts to tackle climate change.
- To stablise prices of Di-ammonium Phosphate (DAP) fertiliser and reduce dependency on the countrieslike Jordan, Morroco, China, etc, India signed a long-term Memorandum of Understanding (MoU) withRussia on DAP fertiliser supply.
- India has opened up yet another door in cooperation with its strategic energy partner Russia. Union Minister of Steel, Ram Chandra Prasad Singh, signed a memorandum of understanding (MoU) with Russia's minister of energy Nikolay Shulginov, for collaboration in the mining and steel sectors, withspecial focus on coking coal.
- Defence Ministry has signed a contract with the US Government under Foreign Military Sale (FMS) for procurement of MK 54 Torpedo and Expendable Chaff and Flares for the Indian Navy.
- India, UK agree to strengthen climate initiatives & further their green partnership.
- Comptroller and Auditor General of India and Auditor General of Maldives have signed a memorandum of understanding to strengthen the audit process of public finance.
- India-Israel Joint Working Group on Bilateral Defence Cooperation has agreed to form a Task Force to formulate a comprehensive Ten-Year Roadmap to identify new areas of cooperation.

The US-India Business Council (USIBC) has presented the 2021 Global Leadership Humanitarian Awards to top leaders of Accenture, IBM and Microsoft, for forming the Global Task Force on Pandemic Response (GTF) that helped India fight a brutal second wave of covid-19 infections earlier this year.

Four of Microsoft's top leaders — Nadella along with its president and vice chair Brad Smith, chief financial officer Amy Hood and chief environment officer Lucas Joppa — received the prestigious honour for their collaborative leadership aimed at transforming Microsoft into a carbon negative company by 2030 and to remove all its historical emissions by 2050.

PETA India has decided to confer on Meghalaya Environment Minister James P K Sangma the Progressive Business Concept Award for his plans to produce 'vegan leather' in the northeastern state.

The Indian Army won a gold medal at the Cambrian Patrol Exercise held in the UK while competing against 96 teams representing special forces and regiments from around the world.

A Delhi-based entrepreneur's agricultural waste recycling project was named among the winners of Prince William's inaugural Earthshot Prize, dubbed the "Eco Oscars", at a gala ceremony in London.

International News

- The Bangladesh economy is projected to grow at 6. 4 percent in the fiscal year 2021-22, says the World Bank. The GDP growth rate for the FY 2020-21 is estimated to be 5 percent.
- The World Bank has forecasted that the average annual growth rate of South Asia will be 3. 4 percent over 2020-23. This is 3 percentage points less than the four years preceding the pandemic.
- Mahalaya festival was celebrated across Bangladesh with devotion and piety.
- The World Trade Organization (WTO) upgraded its forecast for global merchandise trade volume to an increase of 10. 8% in 2021 from the 8% increase projected in March -followed by a 4. 7 per cent rise in 2022.
- In a historic move, the World Health Organization (WHO) has endorsed the first anti-malarial vaccine. WHO said it is recommending the widespread use of malaria vaccine among children in sub-Saharan Africa and in other regions with moderate to high P. falciparum malaria transmission.
- More than five billion people globally are expected to face a shortage of water by 2050, a United Nations (UN) agency report has warned. According to figures cited in the report, 3. 6 billion people had inadequate access to water at least one month per year in 2018. By 2050, this is expected to rise to more than five billion," the report titled "The State of Climate Services 2021: Water" said.
- The World Bank warned of a significant 12% rise in the debt burden of the world's low-income countries to a record \$860 billion in 2020 as a result of the COVID-19 pandemic, and called for urgent efforts to reduce debt levels. The report said the external debt stocks of low- and middle-income countries combined rose 5. 3% in 2020 to \$8.7 trillion, affecting countries in all regions.
- German rail operator Deutsche Bahn and industrial group Siemens unveiled the world's first automated, driver-less train in the city of Hamburg, billing it as more punctual and energy efficient than traditional trains.
- India has been re-elected to the UN Human Rights Council for a record 6th term with an overwhelming majority.
- The World Health Organization (WHO) and its partners launched the first-ever global strategy to defeat meningitis, a debilitating disease that kills hundreds of thousands of people each year.



- The world suffered huge reverses in progress towards tuberculosis (TB) elimination in 2020, thanks to the novel coronavirus disease (COVID-19) pandemic. And, India has been the worst-hit. These are major findings of the Global TB report released by the World Health Organization (WHO). The Philippines and Indonesia were also severely impacted.
- Ecuador, the South American country, has declared a state of emergency over crime wave. Ecuador's President Guillermo Lasso announced a 60-day state of emergency amidst a rise in violent drug crimes.
- An almost USD 4 trillion investment into clean energy is required to meet the Paris Agreement pledge to limit the global temperature increase to 1.5 degrees Celsius, the International Energy Agency (IEA) said in its World Energy Outlook 2021 report.
- India, Israel, United Arab Emirates and the United States have decided to launch a new quadrilateral economic forum.
- Financial Action Task Force (FATF) has retained Pakistan on its Grey List. FATF President Marcus Pleyer announced the decision was after a three-day-long plenary session of the global terror financing watchdog in Paris.
- Three other countries Turkey, Mali and Jordan have been added to the FATF Grey List.
- Saudi Arabia aims to reach zero-net emissions by 2060 and more than double its annual target to reduce carbon emissions
- A new report by the United Nations Environment Programme (UNEP) has rung alarm bells: The amount of plastics in the oceans has been estimated to be around 75-199 million tonnes at present. Without meaningful action, emissions of plastic waste into aquatic ecosystems are projected to nearly triple by 2040. It could more than double by 2030, according to the assessment.
- Invest India has been unanimously elected as the President of the World Association of Investment Promotion Agencies (WAIPA) for 2021-2023.
- Invest India is the National Investment Promotion and Facilitation Agency that helps investors looking for investment opportunities and options in India.
- Close to 14 per cent of the world's coral reef have been lost since 2019 as rising temperatures take a toll on marine ecosystems across the planet. The new figures were released as part of the Status of Coral Reefs of the World: 2020 report, which analysed global coral reef health spanning 40 years in 73 countries.
- India, along with Australia, the UK and small island developing states (SIDS) will be launching a new initiave for Infrastructure for Resilient Island States (IRIS) on the sidelines of the upcoming Conference of Parties (COP26).
- Australia, India and the UK have committed an initial funding of \$10 million for IRIS. More countries, including Japan, are expected to contribute to the initiative.
- The Ministry of Trade, Industry and Energy announced that it held the completion ceremony of 'Shinincheon Bitdream Fuel Cell Power Plant' at the Shinincheon Bitdream headquarters of Korea Southern Power in Seo-gu, Incheon.
- The Shinincheon Bitdream Fuel Cell Power Plant is a power plant with a total capacity of 78 MW constructed in four stages since 2017 by using fuel cells supplied by POSCO Energy and Doosan Fuel Cell. It is the world's largest fuel cell power plant currently in operation.
- More than 80 per cent Indians live in districts vulnerable to climate risks, while Assam, Andhra Pradesh, Maharashtra, Karnataka and Bihar are states which are most vulnerable to extreme climate events such as floods, droughts and cyclones in India, said the Climate Vulnerability Index released by the Council on Energy, Environment and Water (CEEW).
- The report has cited Dhemaji and Nagaon in Assam, Chennai in Tamil Nadu, Khammam in Telangana, Gajapati in Odisha, Vizianagaram in Andhra Pradesh and Sangli in Maharashtra among India's most climate vulnerable districts. Overall, 27 Indian states and Union Territories are vulnerable to extreme climate events which often disrupt the local economy and displace weaker communities.
- The US Agency for International Development (USAID) announced the launch of a new, five-year, USD 49 million initiative called the South Asia Regional Energy Partnership (SAREP), which will facilitate collaboration among Bangladesh, Bhutan, India, the Maldives, Nepal, and Sri Lanka to improve access to affordable, reliable, and sustainable energy.
- Beijing-based multilateral development bank Asian Infrastructure Investment Bank (AIIB) and the Asian Development (ADB) will co-finance a USD 2 billion loan for India to procure COVID-19 vaccines under ADB's Asia Pacific Vaccine Access Facility (APVAX)
- PayU, a leading online payments solutions provider, announced the launch of its unique tokenisation solution 'PayU Token Hub', which will enable businesses to comply with Reserve Bank of India's (RBI's) latest guidelines on online card data storage, while allowing issuing banks to also generate their own



tokens.

National News

- Prime Minister Narendra Modi chaired the 38th PRAGATI meeting, the ICT (Information and Communication Technology) based multi-modal platform for pro-active governance and timely implementation, involving Centre and State governments.
- The Ministry of Defence has enhanced the income criteria for grant of family pension to deceased pensioners' children or siblings with a permanent mental or physical disability.
- Such dependents will be eligible for life-long family pension if "their overall income from sources other than family pension remains less than the entitled family pension at ordinary rate, i. e 30% of the last pay drawn by the deceased government servant or pensioner concerned plus the dearness relief admissible thereon.
- As of now, such dependents are eligible "if their overall monthly income from sources other than family pension is not more than ₹9,000/- along with dearness relief thereon."
- The government will borrow Rs 5. 03 lakh crore in the second half of the current fiscal in line with the estimate presented in the Budget for the fiscal year, a move that experts said move would cool yields. - Indian Council of Medical Research (ICMR) has released the Multilingual Dementia Research and Assessment (MUDRA) Toolbox in five Indian languages Hindi, Bengali, Telugu, Kannada and Malayalam
- The toolbox includes various cognitive tests to assess different domains of cognition such as attention and executive function, memory, language, and visuospatial functions.
- The Union Cabinet approved setting up of seven Mega Integrated Textile Region and Apparel (PM MITRA)
 Parks with a total outlay of four thousand 445 crore rupees over five years.
- Health Minister Mansukh Mandaviya launched ICMR's Drone Response and Outreach in North East (i-Drone). The delivery model is aimed at ensuring that life-saving vaccines reach everyone.

- The Ministry of Textiles has approved continuation of Comprehensive Handicrafts Cluster Development
- Scheme (CHCDS) with a total outlay of ₹160 crore. The scheme will now continue up to March 2026.
- Prime Minister of Denmark Mette Frederiksen arrived in New Delhi on a three-day visit to India.
- In a first of its kind move, Ayushman Bharat, the health insurance scheme, will now offer a healthcare cover to transgender people and support sex-change operations. The addition is part of the National Health Authority's (NHA) revised Health Benefits Package, or HBP 2. 2. The HBP 2. 2 is expected to be rolled out from November, 2021.
- Under the revised HBP 2. 2, rates of health packages have been increased by 20 per cent to 400 per cent. - Indian Naval Fast Attack Craft (IN FAC) T 80 was decommissioned at Naval Dockyard, Mumbai in an impressive yet poignant ceremony. Rear Admiral Krishna Swaminathan, AVSM, VSM, Chief of Staff, Western Naval Command, was the Chief Guest on the occasion.
- India is set to host its largest naval exercise, Ex Milan, in February 2022 for which 46 countries have been invited.
- INS Ranvijay (D55) and INS Satpura (F48) are participating in Multilateral Maritime Ex Malabar Phase II in Bay of Bengal. The Exercise has the participation of nine ships including US Aircraft carrier USS Carl Vinson (CVN 70), Japanese Helicopter Carrier JS Kaga (DDH 184), USS Lake Champlain (CG 57), USS Stockdale (DDG 106), HMAS Sirius (O266), HMAS Ballarat FFH 155) and JS Marasame (DD 101).
- The 17th edition of the Indo-US joint training exercise "Ex Yudh Abhyas 21" commenced at Joint Base Elmendorf Richardson in Alaska.
- The China and Russia joint naval exercises "Joint Sea 2021" kicked off at Russia's Peter the Great Gulf, in the Sea of Japan.
- South Korea has launched its first homegrown rocket, stepping up the country's ambitions in space. The Korean Satellite Launch Vehicle II, known as Nuri, took off from Goheung, about 500km south of Seoul.
- BHYAS the High-speed Expendable Aerial Target (HEAT) was successfully flight-tested by Defence Research and Development Organisation (DRDO) from the Integrated Test Range (ITR), Chandipur.
- The sea phase of the maiden bilateral tri-service exercise 'Konkan Shakti 2021' between the UK and Indian Armed Forces commenced off the Konkan coast in the Arabian Sea.
- The 7th Indian Navy Frigate of P1135. 6 class was launched at Yantar Shipyard, Kaliningrad, Russia, the navy said. The ship was formally named as Tushil by Datla Vidya Varmant. "Tushil" is a Sanskrit word meaning Protector Shield.

- Sports Minister Anurag Thakur launched a nationwide month-long Clean India Programme from Prayagraj in Uttar Pradesh to encourage people's participation in cleaning waste, mainly single use plastic.
- The cleanliness drive, to be organised by the sports ministry, is being taken up as part of Azadi ka Amrit Mahotsav and will run from October 1 to 31.
- Tokyo Olympic stars Rupinder Pal Singh, Birendra Lakra, and SV Sunil retire from international hockey.
- Boxing great Manny Pacquiao has announced his retirement from the sport as he shifts focus on becoming the next Philippines President.
- Australia fast bowler James Pattinson has announced his retirement from international cricket ahead of the upcoming Ashes series against Englang.
- Netherlands all-rounder Ryan ten Doeschate announced his retirement from international cricket after his side failed to qualify for the Super 12 stage of the T20 World Cup.
- England's Fran Wilson announced her retirement from international cricket.
- Nagaland will be hosting the 56th National Cross Country Championship in January 2022.
- In a historic moment in women's cricket, Smriti Mandhana became first Indian woman to score a Test hundred on Australian She scored 127 runs with 22 fours and a six.
- Union Law Minister Kiren Rijiju inaugurated the country's first "Sports Arbitration Centre of India" in Gujarat which will serve as an independent body to fast track disputes in the sports sector.
- The FIH announced that India made a clean-sweep of its annual awards. It's the first time that a country has won in all eight categories. Gurjit Kaur was named as the best woman player while Harmanpreet Singh was the best male.
- Savita Punia and PR Sreejesh were chosen as the best goalkeepers in the world while Sharmila Devi and Vivek Sagar Prasad were elected as the best rising stars.
- Sjoerd Marijne, captain of the Indian women's hockey team, and Indian men's hockey team skipper Graham Reid too grabbed the highest number of votes in their respective categories.
- India pulled out of the 2022 Birmingham Commonwealth Games' hockey competition stating the risk of contracting COVID-19 and the discriminatory quarantine rules by the United Kingdom (UK) for travellers coming from India.
- Germany has unveiled the logo for 2024 European Championship during a ceremony with a light show in the stadium that will hold the final. The logo features an outline of the Henri Delaunay Cup, the bulbous tournament trophy, set on a colored oval outline that resembles the Olympiastadion's roof.
- It features colors from the flags of UEFA's 55 member nations, set in 24 slices around the trophy to represent the 24 teams that will ultimately qualify for the tournament in Germany.
- Indian grappler Anshu Malik has scripted history as she became the first Indian woman to win a silver medal in the World Wrestling Championships. Anshu lost to Olympic medallist Helen Maroulis of the USA 4-1 in the summit clash of women's 57 kg category at Oslo in Norway.
- A group of 136 countries have signed a landmark global treaty to enforce a corporate tax rate of at least 15% for large multinationals.
- World football body, FIFA unveiled the official mascot of the U-17 Women's World Cup India 2022 "Ibha" an Asiatic lioness representing women power. Ibha aims to inspire women and girls across India and around the world to realise their potential.
- Ireland's Amy Hunter became the youngest player to score an ODI century, striking an unbeaten 121 to take her side to a win against Zimbabwe on her 16th birthday, bettering the record previously held by India's Mithali Raj.



- Child prodigy Divya Deshmukh has become India's latest Woman Grand Master (WGM) at the First Saturday Grandmaster chess tournament in Budapest, Hungary.
- The Asian Football Confederation (AFC) and the Local Organising Committee (LOC) unveiled 'Our Goal for All' as the official tagline of the 2022 Women's Asian Cup to be held in India from January 20 to February 6.
- The ICC has partnered with UNICEF to amplify awareness around mental health and well-being of children and adolescents throughout the men's T20 World Cup.
- India won a whopping 43 medals, including 17 gold, to finish on top of the pecking order in the just-concluded ISSF Junior World Championship at the Las Palmas Shooting range in Lima, Peru. India was followed by the US and Italy.
- Nagaland will host the South Asian Athletics Federation (SAAF) Cross Country Championship in the state capital Kohima on January 15 next year.
- Former Indian batter Rahul Dravid has been appointed head coach of Team India, who will replace Ravishastry, who will lead after the 2021 edition of the T20 World Cup in the United Arab Emirates.
- Fencer Bhavani Devi, who made history at the Tokyo Olympics by becoming the first Indian to compete in the sport at the Games, has won the Charlellville National Competition in France in the individual women's sabre event.
- Ridhima Veerendrakumar bags gold medal in 50m backstroke for group II girls in Bengaluru; breaks 7-year record of Maana Patel.
- India rise one spot to 106th, Belgium hold onto top position. India has also moved one spot ahead to the 106th position after the Sunil Chhetri-led side won the SAFF Championship. The Blue Tigers had defeated Nepal in the summit clash.
- Brazil remain second but are breathing down the neck of Belgium, just 12 points behind. England, meanwhile, dropped two places to fifth.
- Yamaha's Fabio Quartararo became the first Frenchman to win the MotoGP world championship following a fourth-placed finish in the Emilia Romagna Grand Prix as his closest title contender Francesco Bagnaia of Ducati crashed.
- The Board of Control for Cricket in India (BCCI) unveiled Ahmedabad and Lucknow as the two new teams for the Indian Premier League (IPL) 2022 after CVC Capitals Partners and Sanjiv Goenka's RPSG Group successfully bid for the franchises.
- In a first of its kind move, the Athletics Federation of India (AFI) has signed a 3-year exclusive partnership with sports management firm IOS Sports and Entertainment.
- Kalinga Institute of Social Sciences (KISS), Bhubaneswar, in an initiative never before, has launched the world's first-ever FIFA Football for School Programme at KISS. Naveen Patnaik, Chief Minister of Odisha virtually launched the Programme.

India is ranked at the top in emissions related to crop burning, accounting for 13 per cent of total global emissions for the 2015-2020 period, according to a new report released by climate tech startup Blue Sky Analytics, which is also part of global coalition "Climate TRACE". Blue Sky Analytics, the Indian climate tech startup founded by an IIT alumnus, also pointed towards a 12. 2-per cent contribution by India to cropland fire emissions in 2020.

According to a report published by London & Partners and Dealroom. co, India ranks at the ninth spot globally for climate tech investment, with the country's climate tech businesses receiving US\$ 1 billion inventure



capital funding between 2016 and 2021.

The top 10 countries for climate tech VC investment between 2016 and 2021 are – US (US\$ 48 billion), China (US\$ 18.6 billion), Sweden (US\$ 5.8 billion), UK (US\$ 4.3 billion), France (US\$ 3.7 billion), Germany (US\$ 2.7 billion), Canada (US\$ 1.4 billion), Netherlands (US\$ 1.3 billion), India (US\$ 1 billion) and Singapore (US\$ 700 million).

- Four Indian institutes have made it to the Times Higher Education's annual Reputation Rankings, that lists the world's top 200 universities based on votes from leading academics around the world.

 Indian Institute of Science Bangalore climbs into the top 100 (91-100 band), leading among the Indian institutes. Indian Institute of Technology Bombay climbs two ranking bands to 126-150th. IIT Madras retains its place in the 176-200 band while IIT Delhi (176-200) appears in the table for the first time.
- Kerala, Tamil Nadu and Telangana have taken the top three slots, emerging winners among the 18 largestates in governance performance, Public Affairs Centre (PAC), a Bengaluru-based nonprofit think tank, announced. - Government of India and Asian Development Bank, ADB signed a 100 million US dollar loan to promote



- agribusiness network to boost farm incomes and reduce food losses in the State of Maharashtra.
- The Government of India and the Asian Development Bank signed a 251 million dollar loan for climateresilient, integrated urban flood protection and management in the Chennai-Kosasthalaiyar basin to strengthen resilience of Chennai city to floods.

Nobel Prize Winners

- Scientists who discovered how our bodies feel the warmth of the sun or the hug of a loved one have wonthe Nobel Prize in Medicine or Physiology.
 - David Julius and Ardem Patapoutian, from the United States, share the 2021 prize in Medicine or Physiology for their work on sensing touch and temperature.
 - They unpicked how our bodies convert physical sensations into electrical messages in the nervous system. Their findings could lead to new ways of treating pain.
- ➤ German-born Benjamin List and Briton David MacMillan (Born in Bellshill, United Kingdom and Professorat Princeton University, USA): have been awarded the 2021 Nobel Prize in Chemistry for their work on building molecules that are mirror images of one another.
- Nobel Prize for Physics: Syukuro Manabe, 90, and Klaus Hasselmann, 89, were cited for their work in "the physical modeling of Earth's climate, quantifying variability and reliably predicting global warming". The second half of the prize was awarded to Giorgio Parisi, 73, for "the discovery of the interplay of disorder and fluctuations in physical systems from atomic to planetary scales."
- Tanzanian Novelist Abdulrazak Gurnah has won the 2021 Nobel Prize in literature for his uncompromising and compassionate penetration of the effects of colonialism and the fate of the refugees in the gulf between cultures and continents. The Nobel Prize in literature is awarded by the Swedish Academy of Stockholm, Sweden.
- ➤ The Nobel Peace Prize awarded to journalists Maria Ressa of Philippines and Dmitry Muratov of Russia for their fight for freedom of expression in their countries. The pair were honoured for their efforts to safeguard freedom of expression, which is a precondition for democracy and lasting peace, said the chairwoman of the Norwegian Nobel Committee, Berit Reiss-Andersen.
- A U. S. based Canadian David Card, Israeli-American Joshua Angrist and Dutch-American Guido Imbens won the Nobel Economics Prize for insights into the labour market and "natural experiments".
