IMI NEW DELHI SELECTION FOR ADMISSION PROCESS

- For shortlisting the first round, GMAT or CAT scores in addition with information provided in the application form, marks in 10th, 12th, graduation, and work experience are assessed.
- The final selection round include bachelor's degree, class XII & X, essay writing, psychometric test and personal Interview, and other qualitative parameters.
