- Composition: The ICJ consists of a panel of 15 judges elected by the UN General Assembly and Security Council for nine-year terms.
  - The Court may not include more than one national of the same State.

- Moreover, the Court as a whole must represent the main forms of civilization and the principal legal systems of the world.
- These organs vote simultaneously but separately.
- In order to ensure a measure of continuity, one third of the Court is elected every three years.
- Judges are eligible for re-election.
- The Court settles legal disputes submitted to it by States, in accordance with international law. It also gives advisory opinions on legal questions referred by authorized UN organs and specialized agencies. Judgments in disputes between States are binding.
  - The Court decides disputes between countries, based on the voluntary participation of the States concerned. If a State agrees to participate in a proceeding, it is obligated to comply with the Court's decision.

Statement 2 is not correct: Its official working languages are English and French.

# 3. [ANS] d

[SOL] In News: The Office of Economic Adviser, Department for Promotion of Industry and Internal Trade (DPIIT) has released the Index of Eight Core Industries (ICI).

Option d is correct: The eight core sector industries in decreasing order of their weightage: Refinery Products> Electricity> Steel> Coal> Crude Oil> Natural Gas> Cement> Fertilizers.

- It is a composite indicator that measures the growth rate of industry groups classified under:
  - o Broad sectors, namely, Mining, Manufacturing, and Electricity.
  - Use-based sectors, namely Basic Goods, Capital Goods, and Intermediate Goods.
- In India, the first official attempt to compute the Index of Industrial Production (IIP) was made much earlier than the first recommendation on the subject came at the international level.
- With the inception of the Central Statistical Organization (now known as the National Statistics Office (NSO)) in 1951, the responsibility for compilation and publication of IIP was vested with it.
- Ministry: Ministry of Statistics and Programme Implementation.
- Base year: 2011-2012
- Sources of data: NSO compiles the Index of Industrial Production (IIP) using secondary data received from 14 source agencies in various Ministries/Departments or their attached/subordinate offices.
- The Department of Industrial Policy and Promotion (DIPP) is the source for the major chunk of data for the calculation.

# 4. [ANS] d

[SOL] Statement 1 is not correct: Patent: It is an exclusive right granted for an invention.

- A patent provides the patent owner with the right to decide how or whether the invention can be used by others.
- In exchange for this right, the patent owner makes technical information about the invention publicly available in the published patent document.
- Statement 2 is not correct: Copyright: It is a legal term used to describe the rights that creators have over their literary and artistic works.
  - Works covered by copyright range from books, music, paintings, sculpture and films, to computer programs, databases, advertisements, maps and technical drawings.

[SOL] Statement 1 is not correct: The governor is neither directly elected by the people nor indirectly elected by a specially constituted electoral college as is the case with the president. He is appointed by the president by warrant under his hand and seal. In a way, he is a nominee of the Central government. But, as held by the Supreme Court in 1979, the office of governor of a state is not an employment under the Central government. It is an independent constitutional office and

is not under the control of or subordinate to the Central government.

Statement 2 is correct: The Governor shall not hold any other office of profit.

- The Governor shall be entitled without payment of rent to the use of his official residences and shall be also entitled to such emoluments, allowances and privileges as may be determined by Parliament by law and, until provision in that behalf is so made, such emoluments, allowances and privileges as are specified in the Second Schedule.
- Where the same person is appointed as Governor of two or more States, the emoluments and allowances payable to the Governor shall be allocated among the States in such proportion as the President may by order determine.
- The emoluments and allowances of the Governor shall not be diminished during his term of
  office.

# 6. [ANS] b

[SOL] In News: Odisha government has planned to run the Sun Temple completely on solar energy

Statement 1 is not correct: The temple is a World Heritage Site is situated in the eastern state of Odisha and is a massive temple dedicated to the Sun God temple. Konark is situated at a comfortable distance from the famous religious and tourist centre of Puri (35 K.M.) and the capital city of Bhubaneswar (65 K.M.)

• Meaning of Name: "Konarka", the place bears a name composed of two World elements: Kona meaning corner and ARKA meaning the Sun.

Statement 2 and 3 are correct: Built by King Narasimhadeva I of the Eastern Ganga dynasty. The Sun temple belongs to the Kalinga School of Indian Temples with characteristic curvilinear towers mounted by Cupolas. The Sun Temple, Konârak is protected under the National Framework of India by the Ancient Monuments and Archaeological Sites and Remains (AMASR) Act (1958) and its Rules (1959).

### 7. [ANS] d

[SOL] In News: Investments in the Indian capital market through Participatory notes (P-notes) dropped to ₹87,989 crore at the end of January and experts believe that foreign investors will continue with their negative stance amid the Ukraine crisis.

Statements 1,2 and 3 are correct: P-Notes are financial instruments required by investors or hedge funds to invest in Indian securities without having to register with the Securities and Exchange Board of India (SEBI).

- Investors save time, money and scrutiny associated with direct registration.
- P-Notes are among the group of investments considered to be Offshore Derivative Investments (ODIs).
- The P-Notes include investments in equity, derivatives, debt and other hybrid instruments.
  - Majority of the investments is in the equity space.
- P-notes are issued by registered Foreign Portfolio Investors (FPIs) to overseas investors who wish to be a part of the Indian stock market without registering themselves directly
  - They, however, need to go through a due diligence process.
- These investments are also beneficial to India as they provide access to quick money to the Indian capital market.

### 8. [ANS] c

[SOL] In News: The Union government has allowed manufacture and import of machine-made polyester national flags by amending the 2002 Flag Code of India.

Statement 1 is not correct: The first national flag, which consisted of three horizontal stripes of red, yellow and green, is said to have been hoisted on August 7, 1906, at the Parsee Bagan Square, near Lower Circular Road, in Calcutta.

Statement 2 is not correct: After undergoing several changes, the Tricolour was adopted as our national flag at a Congress Committee meeting in Karachi in 1931.

• Statement 3 is correct: The Indian flag was adopted in its present form during a meeting of the Constituent Assembly held on July 22, 1947.

[SOL] In news: Turkey is activating the Montreux Convention in response to Russia's invasion of Ukraine.

Option d is correct: Turkey is set to implement an international convention on naval passage through two of its strategic straits, which would allow them to limit the movement of Russian warships between the Mediterranean Sea and the Black Sea.

- Significance of the move
  - The declaration authorised Turkey to activate the Montreux Convention and ban Russian war vessels from entering the Black Sea through the Bosporus and Dardanelles straits.
  - In the event of a war, the pact gives Turkey the right to regulate the transit of naval warships and to block the straits to warships belonging to the countries involved in the conflict.
- The Bosporus and Dardanelles straits
  - Also known as the Turkish Straits or the Black Sea Straits, connect the Aegean Sea and the Black Sea via the Sea of Marmara.
  - It is the only passage through which the Black Sea ports can access the Mediterranean and beyond.
  - Over three million barrels of oil, about three per cent of the daily global supply, mostly produced in Russia, Azerbaijan, and Kazakhstan, pass through this waterway every day.
  - The route also ships large amounts of iron, steel, and agricultural products from the Black Sea coast to Europe and the rest of the world.
  - According to the 1936 Montreux Convention Turkey has control over both the Bosporus and Dardanelles straits.

### 10. [ANS] b

[SOL] Recently, a five-member delegation from India visited Namibia to hold discussions on translocating the Cheetahs to India.

Statement 1 is correct: Cheetahs will be reintroduced into Kuno Palpur National Park. This National Park has been tentatively earmarked for the translocation of 12-15 cheetahs.

Statement 2 is not correct: Kuno Palpur National Park is situated in Madhya Pradesh. The 344-sq km national park was recommended as one of the three potential sites for the cheetah project in 1992.

[SOL] Option D is correct: The Lingayat/Veerashaiva community, a politically dominant group in Karnataka, are devotees of Shiva. Statement 1 is correct: The government of India has approved the Revamped Distribution Sector Scheme (RDSS) to help DISCOMs improve their operational efficiencies and financial sustainability by providing result-linked financial assistance to DISCOMs to strengthen supply infrastructure based on meeting pre-qualifying criteria and achieving basic minimum benchmarks. Statement 2 is not correct: The scheme has an outlay of Rs 3,03,758 Crore over 5 years i.e. FY 2021-22 to FY 2025-26. The outlay includes an estimated Government Budgetary Support (GBS) of Rs 97,631 Crore. REC and Power Finance Corporation (PFC) have been nominated as nodal agencies for facilitating the implementation of the scheme.

[SOL] In News: Addressing the seventh post-budget webinar, India's Prime Minister said the Union Budget 2021-22 has clearly laid down a roadmap for the 5G spectrum auction in the country.)

- Statement 1 is correct: It is the latest upgrade in the Long-Term Evolution (LTE) mobile broadband networks with reduced latency than 4G.
- Statement 2 is not correct: It works in three bands of spectrum with their respective pros and cons.
  - Low Band Spectrum
    - It shows great promise in terms of coverage and speed of internet and data exchange with a maximum speed limited to 100 Mbps (Megabits per second).
    - Telcos can use and install it for commercial cellphone users who may not have specific demands for very high speed internet.
    - It may not be optimal for specialized needs of the industry.
  - Mid-Band Spectrum
    - It offers higher speeds compared to the low band, but has limitations in terms of coverage area and penetration of signals.
    - It may be used by industries and specialized factory units for building captive networks that can be molded into the needs of that particular industry.
  - o High-Band Spectrum
    - It offers the highest speed of all the three bands, but has extremely limited coverage and signal penetration strength.
    - Internet speeds have been tested to be as high as 20 Gbps (gigabits per second).
- Statement 3 is not correct: 5G technologies offer an extremely low latency rate, the delay between the sending and receiving information.

Statement 3 is not correct: China is the largest shareholder of the bank with 26.06 per cent voting rights. India is the second-largest shareholder with 7.5 per cent followed by Russia at 5.93 per cent and Germany at 4.5 per cent.

[SOL] In News: Recently, the National Disaster Response Force (NDRF) has sent relief material to Ukraine.

Statement 1 is correct: Established in 2006, NDRF is the world's single largest force dedicated to disaster response.

Statements 2 and 3 are not correct :NDRF is functioning under the Ministry of Home Affairs, within the overall command, control and leadership of the Director-General.

- At present, the NDRF consists of 15 battalions from the BSF, CISF, CRPF, ITBP, SSB and Assam Rifles.

- It is a multi-skilled and high-tech force that effectively responds to all types of natural and man-made disasters, including building collapses, landslides, devastating floods, and cyclones.

- November 2017: QUAD Coalition was finally given a present-day form with the active participation of India, the US, Australia and Japan.
  - The aim was to keep critical sea routes open and free for navigation in the Indo-Pacific.
- Foreign ministers of the four countries held their first meeting under the 'Quad' framework in New York in September 2019.

[SOL] In News - India's trade deficit, which shot back up to \$21.2 billion, is expected to stay elevated in coming months and the current account deficit could widen to 2.6% of GDP in 2022-23 from 1.7% of GDP this year.

Statement 1 and 2 are correct: Current Account Deficit (CAD): It is the shortfall between the money flowing in on exports, and the money flowing out on imports. It measures the gap between the money received into and sent out of the country on the trade of goods and services and also the transfer of money from domestically-owned factors of production abroad. It is slightly different from the Balance of Trade, which measures only the gap in earnings and expenditure on exports and imports of goods and services. Whereas, the current account also factors in the payments from domestic capital deployed overseas. For example, rental income from an Indian owning a house in the UK would be computed in the Current Account, but not in the Balance of Trade.

Reasons: The surge in oil prices, amid a pickup in domestic demand, will significantly enhance India's import bill.

- Aided by the broader rise in commodities and fertilizers.
- Anticipation that gold imports will remain high as investors look to hedge against market volatility and inflation.
- The situation is especially aggravated by the ongoing Russia-Ukraine conflict.

[SOL] Statement 1 is correct. The Animal Welfare Board of India (AWBI) is a statutory advisory body on Animal Welfare Laws which promotes animal welfare in the country.

[SOL] In News: Recently, India abstained on a vote at the UN Human Rights Council in Geneva as the Council decided to set up an international commission of enquiry into Russia's actions in Ukraine.

Statements 1 and 3 are correct: It is an inter-governmental body within the United Nations system responsible for strengthening the promotion and protection of human rights around the globe and for addressing situations of human rights violations and making recommendations on them.

- o It replaced the former United Nations Commission on Human Rights.
- It has the ability to discuss all thematic human rights issues and situations that require its attention throughout the year.
- It was created by the United Nations General Assembly in 2006.
- It meets at the UN Office in Geneva.
- The Council is made up of 47 United Nations Member States which are elected by the UN General Assembly.
  - The Council's Membership is based on equitable geographical distribution. Seats are distributed as follows:
    - African States: 13 seats
    - Asia-Pacific States: 13 seats
    - Latin American and Caribbean States: 8 seats
    - Western European and other States: 7 seats
    - Eastern European States: 6 seats
- Members of the Council serve for a period of three years and are not eligible for immediate re-election after serving two consecutive terms.

Statement 2 is not correct: Almost two-thirds of UN Human Rights income comes from voluntary contributions from the Member States and other donors.

- The remainder is covered by the UN regular budget.
- The UN regular budget, approved by the General Assembly, is funded by "assessed contributions" from each Member State.
- These are determined according to a formula that takes into account the size and strength of their respective national economies.

[SOL] A team of scientists from the Botanical Survey of India (BSI) has discovered a new gin berry species from the Kanyakumari Wildlife Sanctuary in Tamil Nadu.

- The findings have been published in the latest issue of Nordic Journal of Botany, published from Sweden .
- The species, named Glycosmis albicarpa with a distinct large white fruit.
- It is endemic to the southern Western Ghats. The species belongs to the Orange family, Rutaceae.
- Berries of the Glycosmis species have the unique characteristic of 'gin aroma' and have gained in popularity as an edible fruit.
- The species is also a larval host plant for butterflies like other species of Glycosmis

[SOL] The Eighth Schedule to the Constitution of India lists the official languages of the Republic of India.

Part XVII of the Indian Constitution deals with the official languages in Articles 343 to 351.

- The eighth schedule includes the recognition of the following 22 languages:
- Assamese, Bengali, Gujarati, Hindi, Kannada, Kashmiri, Konkani, Malayalam, Manipuri, Marathi, Nepali, Odia, Punjabi, Sanskrit, Sindhi, Tamil, Telugu, Urdu, Bodo, Santhali, Maithili and Dogri are the 22 languages presently in the eighth schedule to the Constitution.
   If these languages, 14 were initially included in the Constitution. Subsequently, Sindhi was added in 1967; Konkani, Manipuri and Nepali were added in 1992; and Bodo, Dogri, Maithili and Santali were added in 2003.
  - Currently, six languages enjoy the 'Classical' status: Tamil (declared in 2004), Sanskrit (2005), Kannada (2008), Telugu (2008), Malayalam (2013), and Odia (2014).

### 26. [ANS] c

[SOL] Statement 1 is not correct: Stagflation is an economic situation in which inflation and economic stagnation or recession occur simultaneously and remain unchecked for a period of time. Stagflation was witnessed by developed countries in the 1970s, when world oil prices rose dramatically.

- These sediments occur as terraces, plateaus and mounds and rest over the Paleozoic-Mesozoic sediments of the Kashmir 'basin'.

[SOL] In News: Recently, The global money laundering and terrorist financing watchdog FATF has retained Pakistan on its terrorism financing "grey list" and asked Islamabad to address at the earliest the remaining deficiencies in its financial system

Financial Action Task Force is an inter-governmental decision-making body.

- It was established in July 1989 by a Group of Seven (G-7) Summit in Paris, initially to examine and develop measures to combat money laundering.
- In October 2001, the FATF expanded its mandate to incorporate efforts to combat terrorist financing, in addition to money laundering. In April 2012, it added efforts to counter the financing of proliferation of weapons of mass destruction.
- The FATF has 39 members including two regional organisations the European Commission and the Gulf Cooperation Council. India is a member of the FATF consultations and its Asia Pacific Group.
- Its Secretariat is located in Paris.
- India became an Observer at FATF in 2006. Since then, it has been working towards full-fledged membership. On June 25, 2010, India was taken in as the 34th country member of FATF.

# 29. [ANS] d

[SOL] In News: Manipur celebrates four-day fest featuring dance, food, music, traditional games and much fanfare, at its heart, is the beautiful Shirui Lily, a unique species of ground lily that is found only in Manipur.

Option d is correct: It was English botanist Frank Kingdon-Ward who discovered the three-foot tall, bluish-pink bell-shaped lily in Manipur for research in 1946.

- The Lily won the merit prize from the 1948 Royal Horticultural Society (RHS) at a flower show in London because of how unique it was.
- The Manipur government declared Shirui Lily as the state flower in 1989, today it is considered endangered owing to intense tourist activities and invasion of an invasive bamboo species.
- The Shirui Lily Festival aims at increasing awareness about the plant.
- It is special because it is a species of ground lily found exclusively in the Shirui Hills, located about 18 km from the district headquarters of Ukhrul, which is home to the Tangkhul Naga tribe.
- In other words, it cannot be transplanted anywhere else in the world.

### 30. [ANS] d

[SOL] Option d is correct: The P5+1 refers to the UN Security Council's five permanent members (the P5); namely China, France, Russia, the United Kingdom, and the United States; plus Germany. The P5+1 is often referred to as the E3+3 by European countries. Hence, Japan is not a part of it.

• It is a group of six world powers which, in 2006, joined together in diplomatic efforts with Iran with regard to its nuclear program.

- The data is calculated separately for the manufacturing and services sectors and then a composite index is constructed.

- It aims to provide information about current and future business conditions to company decision-makers, analysts and investors.

The unorganised workers mostly engaged as home based workers, street vendors, midday meal workers, head loaders, brick kiln workers, cobblers, rag pickers, domestic workers, washer men, rickshaw pullers, landless labourers, own account workers, agricultural workers, construction workers, beedi workers, handloom workers, leather workers, audio- visual workers and similar other occupations whose monthly income is Rs 15,000/ per month or less and belong to the entry age group of 18-40 years.

Statement 4 is not correct: They should not be covered under New Pension Scheme (NPS), Employees' State Insurance Corporation (ESIC) scheme or Employees' Provident Fund Organisation (EPFO). Further, he/she should not be an income tax payer.

## 34. [ANS] d

[SOL] In News: The ministry of corporate affairs (MCA) is planning to bring out a set of new accounting and auditing standards tailor-made for limited liability partnerships (LLPs) that will seek more disclosures.

- Limited liability Partnership (LLP) is a partnership in which some or all partners have limited liability. It therefore exhibits elements of partnerships and corporations.
- It allows for a partnership structure where each partner's liabilities are limited to the amount they put into the business.
- An LLP is a corporate body and legal entity separate from its partners. It has perpetual succession.

## Benefits of Limited Liability Partnership

- Pooling Resources for Better Growth: Most LLPs are created and managed by a group of professionals who have a lot of experience and clients among them. By pooling resources, the partners lower the costs of doing business while increasing the LLP's capacity for growth.
- Increased Profits: Most important, reducing costs allows the partners to realize more profits from their activities than they could individually.
- Attracts Good Workers: The partners in an LLP may also have a number of junior partners in the firm who work for them in the hopes of someday making full partners. These junior partners are paid a salary and often have no stake or liability in the partnership.
- More Focus on Business: The LLPs help the partners scale their operations. Junior partners
  and employees take away the detail work and free up the partners to focus on bringing in
  new business.
- Liability Protection: The personal assets as a partner are protected from legal action. Basically, the liability is limited in the sense that one may lose assets in the partnership, but not those outside of it (i.e. personal assets). LLPs protect individual partners from the negligence of any other partner.
- Flexibility: It has the ability to bring partners in and let partners out. The LLP can always add partners who bring existing business with them. Overall, it is the flexibility of an LLP for a certain type of professional that makes it a superior option to an LLC or other corporate entity.

- The new UPI-based service is designed to bring the digital payments platform closer to a significant number of feature phone mobile subscribers in the country, which is estimated to be more than 40 crore.
  - It doesn't need an internet connection for transactions. Customers have to link their bank account with feature phones to use this facility.
  - Feature phone users will now be able to undertake a host of transactions based on four technology alternatives.
    - They include calling an IVR (interactive voice response) number, app functionality in feature phones, missed call-based approach and also proximity sound-based payments.
  - Users will be able to make payments to their friends and family, pay their utility bills, recharge FASTags, pay mobile bills and also check their account balances and customers will also be able to link bank accounts, set or change UPI PINs.

- DDU-GKY is already being implemented in 27 states and 3 UTs for rural poor youth with an emphasis on placements.
- Aims to skill rural youth who are poor and provide them with jobs having regular monthly wages or above the minimum wages.

#### 47. [ANS] c

[SOL] In News: According to Morgan Stanley, the current account deficit is likely to hit a 10-year high of 3 percent of GDP in FY23.

Statement 1 is correct: A current account deficit indicates that a country is importing more than it is exporting. Emerging economies often run surpluses, and developed countries tend to run deficits. A current account deficit is not always detrimental to a nation's economy—external debt may be used to finance lucrative investments. Current Account Deficit may be a positive or negative indicator for an economy depending upon why it is running a deficit. Foreign capital is seen to have been used to finance investments in many economies. Current Account Deficit may help a debtor nation in the short-term, but it may worry in the long-term as investors begin raising concerns over adequate return on their investments.

Statement 2 is correct: The Current Account Deficit could be reduced by boosting exports and curbing non-essential imports such as gold, mobiles, and electronics. Currency hedging and bringing easier rules for manufacturing entities to raise foreign funds could also help. The government and RBI could also look to review debt investment limits for FPIs, among other measures.

Option d is correct: The 1954 Hague Convention was drawn up after the widespread devastation of cultural property in World War II. Together with its two Protocols of 1954 and 1999, it is the most widely recognised international treaty exclusively dedicated to the protection of cultural heritage in armed conflict. The treaty stipulates a number of measures that States and the armed forces should conduct during peacetime to prepare for conflict, and provides a regime for its protection during fighting. Partnering with the United Nations Institute for Training and Research (UNITAR), the agency assesses damage by analyzing satellite imagery for priority sites which are endangered or already impacted. The Hague Convention specifies an emblem the Blue Shield repeated three times in a triangular formation. The emblem is a protective symbol used during armed conflicts and its use is restricted by law. When it was founded in 1996, the Blue Shield took up the emblem of the 1954 Hague Convention as its symbol, in line with Article 17 of the Convention.

## 50. [ANS] c

[SOL] In Context: An increasing number of women are joining Indian armed forces amidst long-standing calls to boost their presence in global missions.

Option c is correct: The Security Council adopted resolution (S/RES/1325) on women and peace and security on 31 October 2000.

- The resolution reaffirms the important role of women in the prevention and resolution of conflicts, peace negotiations, peace-building, peacekeeping, humanitarian response and in post-conflict reconstruction and stresses the importance of their equal participation and full involvement in all efforts for the maintenance and promotion of peace and security.
- Resolution 1325 urges all actors to increase the participation of women and incorporate gender perspectives in all United Nations peace and security efforts.

#### 51. [ANS] d

[SOL] All the statements are correct: Government announces minimum support prices (MSPs) for 22 mandated crops and fair and remunerative price (FRP) for sugarcane. The mandated crops are 14 crops of the kharif season, 6 rabi crops and two other commercial crops. In addition, the MSPs of toria and de-husked coconut are fixed on the basis of the MSPs of rapeseed/mustard and copra, respectively. The list of crops are as follows:

- O Cereals (7) paddy, wheat, barley, jowar, bajra, maize and ragi
- Pulses (5) gram, arhar/tur, moong, urad and lentil
- Oilseeds (8) groundnut, rapeseed/mustard, toria, soyabean, sunflower seed, sesamum, safflower seed and niger seed

- Sugarcane (Fair and remunerative price)
- Virginia flue cured (VFC) tobacco

The Commission for Agricultural Costs & Prices (CACP) makes recommendations for the MSPs. The Cabinet Committee on Economic Affairs (CCEA) takes these decisions.

## 52. [ANS] c

[SOL] In News: Chinar Corps of the Indian Army was accorded recognition by the National Monuments Authority (NMA) for preserving and rejuvenating the Pandrethan temple. Pandrethan temple is an 8th-century heritage site situated in Srinagar's Badamibagh, has been preserved and rejuvenated by the Chinar Corps of the Indian Army.

- The site hosts several excavated figurines tracing back to the 2nd century in the form of two large monolithic rock shiva lingams, seven Gandhara-style sculptures and a huge rock carving of the feet of a monolithic statue.
- Pandrethan site near Shiva temple was excavated by the British era ASI in 1913 yielding several Buddhist sculptures and rubbles of a Chaitya assignable to the 8th CE.

#### 53. [ANS] b

[SOL] Recently, retiring Delhi HC Chief Justice stressed the need for a balance between judicial activism and judicial restraint.

Statements 2 and 4 are correct: Article 121: Under Article 121 the Parliament is restricted to discuss the conduct of any judge of the Supreme Court or any High Court.

Article 212: The Courts are restricted to inquire into the legislative proceedings under Article 212. Article 21: Right to life and dignity

Article 124: There shall be a Supreme Court of India consisting of a Chief Justice of India and, until Parliament by law prescribes a larger number, of not more than seven other Judges.

Statements 1 and 2 are not correct: Political Parties registrations are governed by the provisions of the Representation of the People Act, 1951. According to the EC, any party seeking registration has to submit an application to the Commission within a period of 30 days. Powers conferred by EC under Article 324 of the Constitution of India and Section 29A of the Representation of the People Act, 1951. Section 29A of RPA, 1951: Indian Citizen, Purpose of contesting elections, & 100 registered electors as its members. There is no procedure available for the de-registration of dormant political parties.

Statement 3 is correct: Conditions for recognising as a national party are:

- o If Party is treated as a recognised political party in four or more states.
- Get at least six per cent votes in four states in addition to four Lok Sabha seats.
- It won at least two per cent seats in the LS (i.e., 11 seats in the existing House having 543 members).

[SOL] In News: The Union government plans to open the villages along the Chinese border for tourists under the Vibrant Village programme announced in the Union Budget 2022-23. The Union Budget 2022-23 has announced that villages on the northern border will be covered under the new Vibrant Villages Programme.

- The activities will include construction of village infrastructure, housing, tourist centres, road connectivity, provisioning of decentralised renewable energy, direct to home access for Doordarshan and educational channels, and support for livelihood generation.
  - Additional funding for these activities will be provided.
- Existing schemes will be converged and their outcomes will be defined and monitored on a constant basis.
- The programme aims to enhance infrastructure in villages along India's border with China, in states like Himachal Pradesh, Uttarakhand, and Arunachal Pradesh.

#### 58. [ANS] a

[SOL] India took a strong stance and said that it is important to ensure full and effective implementation of the Biological and Toxin Weapons Convention (BTWC) after emerging reports of biological activities relating to Ukraine.

Statements 1 and 2 are correct: "The Convention on the Prohibition of the Development, Production and Stockpiling of Bacteriological (Biological) and Toxin Weapons and on their Destruction", the Convention was negotiated by the Conference of the Committee on Disarmament in Geneva, Switzerland. Biological and Toxin Weapons Convention (BTWC) is a treaty that prohibits the development, production, acquisition, transfer, stockpiling, and use of biological weapons and the treaty came into force in 1975. It was the first multilateral disarmament treaty banning an entire category of weapons of mass destruction (WMD). The treaty prohibiting bioweapons has 183 signatories, including the United States, Russia, and Ukraine. Statement 3 is not correct: India has signed and ratified this convention.

## 59. [ANS] d

[SOL] In News: Ukraine's two leading suppliers of neon, which produce about half the world's supply of the key ingredient (Neon) for making chips, have halted their operations due to Russian attack.

All the statements are correct: Neon was discovered in 1898 by the British chemists Sir William Ramsay (1852–1916) and Morris Travers (1872–1961) in London.

- Neon is a chemical element with the symbol Ne and atomic number 10.
- It is a noble gas.

- Neon is a colorless, odorless, inert monatomic gas under standard conditions, with about twothirds the density of air.
- Neon gas occurs in minute quantities in Earth's atmosphere and is trapped within the rocks of Earth's crust.
- Neon was the second of these three rare gases to be discovered and was immediately recognized as a new element from its bright red emission spectrum.
- Neon gives a distinct reddish-orange glow when used in low-voltage neon glow lamps, high-voltage discharge tubes and neon advertising signs.

[SOL] In News: Recently, The United States, the European Union, Britain, Canada and Japan were due to move jointly to revoke Russia's "most favoured nation" (MFN) status over its invasion of Ukraine.

Statements 1,2 and 3 are correct: Most-favoured-nation (MFN): treating other people equally Under the WTO agreements, countries cannot normally discriminate between their trading partners. Grant someone a special favour (such as a lower customs duty rate for one of their products) and you have to do the same for all other WTO members.

- This principle is known as most-favoured-nation (MFN) treatment. It is so important that it is the first article of the General Agreement on Tariffs and Trade (GATT), which governs trade in goods. MFN is also a priority in the General Agreement on Trade in Services (GATS) (Article 2) and the Agreement on Trade-Related Aspects of Intellectual Property Rights (TRIPS) (Article 4), although in each agreement the principle is handled slightly differently. Together, those three agreements cover all three main areas of trade handled by the WTO.
- Some exceptions are allowed. For example, countries can set up a free trade agreement that applies only to goods traded within the group discriminating against goods from outside. Or they can give developing countries special access to their markets. Or a country can raise barriers against products that are considered to be traded unfairly from specific countries. And in services, countries are allowed, in limited circumstances, to discriminate. But the agreements only permit these exceptions under strict conditions. In general, MFN means that every time a country lowers a trade barrier or opens up a market, it has to do so for the same goods or services from all its trading partners whether rich or poor, weak or strong.

## 61. [ANS] c

[SOL] In News: M.N. Srinivas, an eminent social anthropologist, produced a detailed explanation of the phenomenon of Sanskritization in 'A Note on Sanskritization and Westernisation (Far Eastern Quarterly, 1956)'. Sanskritisation referred to the lower castes' adoption of the practices and rites of the locally dominant caste in a particular region, which included Brahmin and non-Brahmin castes, who were politically powerful, socio-economically influential and ritually higher in the local caste hierarchy.

- Sanskritisation became a process through which mobility in caste positions/roles became possible for certain castes.
  - O But for Dalits, this process did not guarantee higher social stature nor lead to any improvement in their everyday life.
    - Other factors such as economic well-being, political power, education, and establishment of literary/historical evidence for their affiliation to/descent from a particular caste/caste lineage were also important for their aspirations for higher social positions

## 62. [ANS] b

[SOL] In News: Recently, the United States approved a \$200-million arms package for Ukraine, which would include US-made Stinger Missiles, which are a type of shoulder-fired Man-Portable Air-Defence Systems (MANPADS).

Statement 1 is not correct :Man-Portable Air-Defence Systems are short-range, lightweight and portable surface-to-air missiles that can be fired by individuals or small groups to destroy aircraft or helicopters.

Statements 2 ,3 and 4 are correct: They help shield troops from aerial attacks and are most effective in targeting low-flying aircrafts.

- MANPATs or Man-Portable Anti-Tank Systems work in a similar manner but are used to destroy or incapacitate military tanks.
- MANPADS can be shoulder-fired, launched from atop a ground-vehicle, fired from a tripod or stand, and from a helicopter or boat.
- Weighing anywhere between 10 to 20 kilograms and not being longer than 1.8 metres.
  - They are fairly lightweight as compared to other elaborate weapon systems, making them easy to operate by individual soldiers.
  - Operating MANPADS requires substantially less training.
  - MANPADS have a maximum range of 8 kilometres and can engage targets at altitudes of 4.5 km.
  - Most MANPADS have passive or 'fire and forget' guidance systems, meaning the
    operator is not required to guide the missile to its target, enabling them to run and relocate
    immediately after firing.
- The first MANPADS were introduced by the United States and Soviet Union in the 1960s.
  - Russian and U.S. MANPADS were also used during the Vietnam war.
- Countries such as India, Pakistan, Germany, U.K, Turkey and Israel have also used MANPADS in their defence efforts.
  - As of 2019, 20 countries had developed the wherewithal to manufacture MANPADS and together made 1 million such systems for defence and export purposes.

## 63. [ANS] b

[SOL] Statement 1 is not correct: The Sikkim government is planning to launch Bahini Scheme to provide free sanitary pads in all its 210 secondary and senior secondary government schools across the state. It aims at:

- Providing 100 percent access to free and safe sanitary pads to secondary and senior secondary Government school going girls.
- To curb dropout of girls from schools and
- To raise awareness about menstrual hygiene.

Statement 2 is correct: Union Minister for Chemicals & Fertilizers and Parliamentary Affairs, Shri Ananthkumar announced the launch of 'Suvidha', the 100% Oxo-biodegradable Sanitary Napkin, under the Pradhan Mantri Bhartiya Janaushadhi Pariyojana (PMBJP), here today. The affordable sanitary napkin will be available for Rs. 2.50 per padat over 3200 Janaushadhi Kendrasacross India and would ensure 'Swachhta, Swasthya and Suvidha' for the underprivileged Women of India. This step taken by the Department of Pharmaceuticals will ensure the achievement of Prime Minister Shri Narendra Modi's vision of Affordable and Quality Healthcare for All, the Minister said while addressing the media.

# 64. [ANS] c

[SOL]

Statement 1 is correct. Hydrogen produced from fossil fuels is called grey hydrogen, this constitutes the bulk of the hydrogen produced currently.

Statement 2 is correct. Hydrogen generated entirely from renewable power sources is called green hydrogen.

[SOL] Statement 1 is correct: Sarkaria Commission was set up in June 1983 to examine the relationship and balance of power between state and central governments and suggest changes within the framework of the Constitution. It recommended that the state assembly should not be dissolved unless the proclamation is approved by the parliament and sparing use of article 356 of the constitution should be made.

Statement 2 is not correct. Punchhi Commission (2007) recommended that the governor should follow "constitutional conventions" in the case of a hung Assembly.

Statement 3 is not correct. Punchhi Commission also sought to protect the interests of the States by trying to curb their misuse by the Centre by localizing the emergency provisions under Articles 355 and 356. Simply, the centre should try to bring only the specific troubled area under its jurisdiction and that too for a brief period, not more than three months.

#### 66. [ANS] d

[SOL] In News: The PM paid tributes to Mahatma Gandhi on the 92nd anniversary of Dandi March.

## Explanation

- It is also known as Salt Satyagraha and marked the first step of the Civil Disobedience movement.
- Reasons behind the launch of Dandi March:
  - Simon Commission: No Indian was included in it despite protests by Congress and all major parties.
    - Britishers even mocked Indians by terming them incapable of framing their own constitution.
  - Lahore Declaration of Congress, 1929: It declared Complete Independence as the goal of Indian Freedom Struggle.
  - Non Acceptance of Gandhi's 11 Points Demand: Gandhi ji put forth 11 demands including release of all Political Prisoners, Issual of Arms license to Indians for self defence, etc.
- Gandhi ji after his 11 points demand was not met launched a non violent march from Sabarmati Ashram on 12 March 1930, travelled to 21 places and over 390 kms and reached Dandi on 5 April 1930.
- Gandhi also published an article titled "Duty of Disloyalty". In the issue of Young India.
- Gandhi, Nehru, etc were arrested on breaking salt law which again instigated masses to take part in Civil Disobedience.

## Why was Salt Chosen?

• Salt appealed to masses as Repressive Salt Law prohibited Indians from processing and manufacturing salt.

## 67. [ANS] a

[SOL] In News : Inflation based on the Consumer Price Index (CPI) quickened to 6.07% in February from 6.01% in the previous month .

Statement 1 is correct: Consumer Price Index or CPI as it is commonly called is an index measuring retail inflation in the economy by collecting the change in prices of most common goods and services used by consumers. CPI is calculated for a fixed list of items including food, housing, apparel, transportation, electronics, medical care, education, etc. Note that the price data is collected periodically, and thus, the CPI is used to calculate the inflation levels in an economy. This can be further used to compute the cost of living. This also provides insights as to how much a consumer can spend to be on par with the price change.

Statement 2 is not correct :In India, there are four consumer price index numbers, which are calculated, and these are as follows:

- CPI for Industrial Workers (IW)
- CPI for Agricultural Labourers (AL)
- CPI for Rural Labourers (RL) and
- CPI (Rural/Urban/Combined).
- Of these, the first three are compiled by the Labour Bureau in the Ministry of Labour and Employment. Fourth is compiled by the National Statistical Office (NSO) in the Ministry of Statistics and Programme Implementation.

[SOL] In News: Important steps taken by the Government for protection of Great Indian Bustards in the country including details of captive breeding facilities are highlighted recently.

Statement 1 is not correct: Great Indian Bustard is a State Bird of Rajasthan

Statements 2 and 3 are correct: The Great Indian Bustard has been included in the Appendix I of Convention on Migratory Species (CMS) on the basis of a proposal submitted by India.

• It was also the mascot of the prestigious 13th CMS Conference of Parties held in Gandhinagar giving wider publicity for the conservation of the species.

IUCN Status: Critically Endangered.

## 69. [ANS] d

[SOL] A recent study warned that permafrost peatlands in Europe and western Siberia might be approaching their tipping point faster than expected.

Statement 1 is correct: It is defined solely based on temperature and duration. It is composed of rock, sediments, sand, dead plant and animal matter, soil, and varying degrees of ice and is believed to have formed during glacial periods dating several millennia. It is mainly found near the polar zones and regions with high mountains covering parts of Greenland, Alaska, Russia, Northern Canada, Siberia and Scandinavia.

Statement 2 is correct: Permafrost is ground that remains completely frozen at 0 degrees Celsius or below for at least two years and

Statement 3 is correct: Its thickness reduces progressively towards the south and is affected by a number of other factors, including the Earth's interior heat, snow and vegetation cover, presence of water bodies, and topography.

## 70. [ANS] d

[SOL] Recently, the Supreme Court upheld the government's decision on One Rank, One Pension (OROP) for defence forces and said that it does not find any constitutional infirmity on the OROP principle.

Option d is correct: The 'one rank, one pension' rule means that retired soldiers of the same rank and length of service will receive the same pension, regardless of when they retire.

- Under this definition, it has been decided that the gap between the rate of pension of current pensioners and past pensioners will be bridged every five years.
- The SC disposed of a plea filed by Ex-servicemen Association seeking implementation of the One Rank-One Pension as recommended by the Bhagat Singh Koshyari Committee with an automatic annual revision, instead of the current policy of periodic review once in five years.

# 71. [ANS] b

[SOL] Statement 1 is correct: Shanghai Cooperation Organisation is a permanent intergovernmental international organisation. Its creation was announced on 15th June 2001 in Shanghai (China) by Kazakhstan, China, Kyrgyzstan, Russia, Tajikistan and Uzbekistan and was preceded by the Shanghai Five mechanism.

Statement 2 is not correct: Its chairmanship rotates on an annual basis and Tajikistan is the chair for 2021.

Statement 3 is not correct: India and Pakistan became members in 2017 and Afghanistan, Belarus, Iran and Mongolia are observer states.

## 72. [ANS] c

[SOL] India recently criticised the Organisation of Islamic Cooperation's (OIC) decision to invite Hurriyat leader Mirwaiz Omar Farooq to a meeting being held in Pakistan.

Statement 1 is not correct: The Organisation of the Islamic Conference was established by the First Islamic Summit Conference held in Morocco in September 1969. It was known as the Organisation of Islamic Conference until 2011. It's objective is to safeguard and protect the interests of the Muslim world in the spirit of promoting international peace and harmony among various people of the world.

Statement 2 is correct: It is the world's second-largest inter-governmental organization after the UN, with a membership of 57 states, all of which are Islamic countries or Muslim majority members.

Statement 3 is not correct: OIC has reserved membership for Muslim-majority countries. Russia, Thailand, and a couple of other small countries have Observer status. In 2006, as India turned the economic corner and improved ties with the US, Saudi Arabia invited Delhi to join as an observer. However, India stayed away because of a multiplicity of reasons, as a secular country, it did not want to join an organisation founded on religion. And, India can come under pressure in a grouping, especially on issues such as Kashmir.

## 73. [ANS] a

[SOL] In News: About 100 Himalayan griffon vultures have died of suspected poisoning in Assam.

Statement 1 is correct: Himalayan griffon vulture is a rare and largest bird native to the Himalayas.

• It lives mainly in the higher regions of the Himalayas and the Tibetan Plateau at the elevation of above 1500 metres.

Statement 2 is not correct: The vulture is listed as "Near Threatened" by the International Union for Conservation of Nature (IUCN) Red List of Threatened Species.

## 74. [ANS] d

[SOL] Recently, the Ministry of Earth Science has unveiled India's Arctic Policy, titled 'India and the Arctic: building a partnership for sustainable development'.

Option d is correct: It is commonly understood to refer to the region above the Arctic Circle, north of latitude 66° 34' N, which includes the Arctic Ocean with the North Pole at its centre.

Eight Arctic States: Canada, Kingdom of Denmark, Finland, Iceland, Norway, Russia, Sweden, and USA form the Arctic Council. The Arctic is home to almost four million inhabitants, of which approximately one tenth are considered as indigenous people. The Arctic Ocean and its surrounding landmass has been a topic of immense interest and a high-priority area of research among the global scientific fraternity as well as of importance to policy makers.

## 75. [ANS] d

[SOL] In News: Parliament's Standing Committee on Rural Development and Panchayati Raj has asked the government to roll back the system of caste-based wages, under which NREGS workers are paid based on whether they belong to a Scheduled Caste, Scheduled Tribe, or Others.

- Mandate: The mandate of the MGNREGA is to provide at least 100 days of guaranteed wage employment in a financial year to every rural household whose adult members volunteer to do unskilled manual work.
- Objectives: Providing not less than one hundred days of unskilled manual work as guaranteed employment in a financial year to every household in rural areas as per demand, resulting in the creation of productive assets of prescribed quality and durability
  - Strengthening the livelihood resource base of the poor
  - o Proactively ensuring social inclusion and

- Strengthening Panchayati Raj Institutions
- Coverage: It is implemented in all rural districts of the country.
- Role of Gram Sabha in MGNREGS: It determines the order of priority of works in the meetings of the Gram Sabha keeping in view the potential of the local area, its needs, and local resources.
  - Monitor the execution of works within the GP.
  - It is the primary forum for the conduct of social audits. It provides a platform to all residents to seek and obtain all relevant information from all the Implementing Agencies including GP in relation to MGNREGA works implemented in the GP area.
- Legal Right to Work: The Act provides a legal right to employment for adult members of rural households.

[SOL] In News: The National Commission for Scheduled Tribes has been dysfunctional for the last four years and has not delivered a single report to Parliament, a parliamentary committee has said in a recent report.

- Article 366 of the Constitution: Such tribes or tribal communities or parts of or groups within such tribes or tribal communities as are deemed under article 342 to be Scheduled Tribes for the purposes of this Constitution.
- Article 342: The President may with respect to any State or Union territory, and where it is a State, after consultation with the Governor thereof, by public notification, specify the tribes or tribal communities or parts of or groups within tribes or tribal communities which shall for the purposes of this Constitution be deemed to be Scheduled Tribes in relation to that State or Union territory, as the case may be.
- Criteria: The Constitution is silent about the criteria for the specification of a community as
  a Scheduled Tribe. Primitiveness, geographical isolation, shyness and social, educational &
  economic backwardness are the traits that distinguish Scheduled Tribe communities from
  other communities.
- There are certain Scheduled Tribes, 75 in number known as Particularly Vulnerable Tribal Groups (PVTGs), who are characterized by:- a) pre-agriculture level of technology; b) stagnant or declining population; c) extremely low literacy, and d) subsistence level of the economy.

## 77. [ANS] b

[SOL] In News: An uncommon experiment with Africa's Boma technique undertaken at Keoladeo National Park in Rajasthan's Bharatpur district for capturing and translocating spotted deer is set to improve the prey base in Mukundara Hills Tiger Reserve.

- The Boma capturing technique, which is popular in Africa, involves luring animals into an enclosure by chasing them through a funnel-like fencing.
- The funnel tapers into an animal selection-cum-loading chute, supported with grass mats and green net to make it opaque for animals, which are herded into a large vehicle for their transport to another location.
- The technique is preferred since it does not require chemical immobilization of the animal involved.
  - If mass capture is the task at hand, Boma method is adopted as it is not feasible to dart and sedate numerous animals at once within a limited time frame."
- This old technique was earlier utilised to capture wild elephants for training and service.

## 78. [ANS] c

[SOL] In News: Recently, The United States Senate unanimously passed a lawmaking daylight saving time (DST) permanent, scrapping the biannual practice of putting clocks forward and back coinciding with the arrival and departure of winter.

Statements 1 and 2 are correct: DST is the practice of resetting clocks ahead by an hour in spring, and behind by an hour in autumn (or fall).

- Ouring these months, countries that follow this system get an extra hour of daylight in the evening.
- Because the spring to fall cycle is opposite in the Northern and Southern Hemispheres, DST lasts from March to October/November in Europe and the US, and from September/October to April in New Zealand and Australia.
- In April 1916, during World War I, Germany and Austria introduced DST to minimise the use of artificial lighting.
  - It gradually caught on in many countries. In the EU, clocks in the 28 member states move forward on the last Sunday in March and fall back on the last Sunday in October. India does not follow daylight saving time.
    - DST is currently followed by some 70 countries twice a year.

## 79. [ANS] c

[SOL]In News: Recently, the Ministry of Panchayati Raj released a Disaster Management Plan. Statement 1 is correct: As per  $\sec - 37$  (1) (a) of DM Act, 2005, every Ministry or Department of the Government of India shall prepare a Disaster Management Plan.

Statement 2 is correct: Crisis management plan is different from Disaster Management Plan. Crisis management plan is a plan for responding to an identified crisis and its plans on how to manage a crisis when it occurs, whereas a Disaster Management Plan includes a gamut of activities as per the DM Act, the NDMP and various national guidelines issued by NDMA. Crisis Management Plan basically deals with response, whereas Disaster Management Plan is a holistic one including preventive strategies.

## 80. [ANS] a

[SOL] Statement 1 is correct: Under Section 498A, 'Cruelty' is defined as wilfully driving a woman to commit suicide or inflicting grave injury (including physical or mental injury) upon her.

Statement 2 is not correct: Both the Law Commission as well as Malimath Committee have recommended making dowry law compoundable. This will leave a scope for compromise in cases where it is felt that the case is not genuine and is motivated in nature.

### 81. [ANS] a

[SOL] Option A is correct: It is a parasitic disease caused by microscopic, thread-like worms. Wuchereria bancrofti, is responsible for 90% of the cases. The adult worms only live in the human lymph system. The lymph system maintains the body's fluid balance and fights infections. Transmission: It is spread from person to person by mosquitoes. It is a leading cause of permanent disability worldwide.

## 82. [ANS] a

[SOL] Statement 1 is not correct: The Collegium System is not prescribed in the constitution nor in any statute. It came into existence through the 2nd Judges case..

Statement 2 is not correct: The 2nd Judges Case recommended the CJI+ 2 senior most judges but 3rd Judges cases upgraded it to CJI+4 senior most judges.

Statement 3 is correct: National Judicial Appointment Commission Act, 2014 was brought to replace commission. But it was declared unconstitutional by SC.

# 83. [ANS] d

[SOL] In News: Recently, The Union of India has approved a "New India Literacy Programme (NILP)".

Statements 1 and 2 are not correct: NILP is a Centrally Sponsored Scheme with the aim to support the States and Union Territories in promoting literacy among non-literates in the age group of 15 and above, across the country covering 5 crore non-literates during the implementation period

from 2022-23 to 2026-27.

- The scheme has been approved with a financial outlay of Rs.1037.90 crore including Central share of Rs.700.00 crore and State share of Rs.337.90 crore.
- The scheme has five components namely, Foundational Literacy and Numeracy, Critical Life Skills, Vocational Skills Development, Basic Education and Continuing Education.

### 84. [ANS] b

[SOL] In News: The Minister of Commerce and Industry said that Open Network for Digital Commerce (ONDC) would democratise e-commerce and will protect small businesses by granting them equal opportunity.

Statement 1 is not correct :ONDC is a network based on open protocol and will enable local commerce across segments, such as mobility, grocery, food order and delivery, hotel booking and travel, among others, to be discovered and engaged by any network-enabled application.

- The platform aims to create new opportunities, curb digital monopolies and by supporting micro, small and medium enterprises and small traders and help them get on online platforms.
- It is an initiative of the Department for Promotion of Industry and Internal Trade (DPIIT) under the Ministry of Commerce and Industry.

Statements 2 and 3 are correct: It is a globally first-of-its-kind initiative that aims to democratise Digital Commerce, moving it from a platform-centric model to an open-network.

- It will enable buyers and sellers to be digitally visible and transact through an open network, no matter what platform/application they use.
- It will empower merchants and consumers by breaking silos to form a single network to drive innovation and scale, transforming all businesses from retail goods, food to mobility
- It will also be compliant with the Information Technology Act, 2000 and designed for compliance with the emerging Personal Data Protection Bill.
- It is modelled around the Unified Payments Interface (UPI) project that is seen as a success by many.
  - The UPI project allows people to send or receive money irrespective of the payment platforms on which they are registered.
- Similarly, ONDC will ensure that buyers and sellers in the e-commerce market transact regardless of the platforms on which they are registered.
- Thus, a buyer registered on Amazon, may directly purchase goods from a seller who sells on Flipkart.

## 85. [ANS] a

[SOL] In Context: Recently, Rajya Sabha Chairman granted a three-month extension to the Standing Committee examining the Prohibition of Child Marriage (Amendment), Bill, 2021.

Statement 1 is correct: Members of the All India Women's Conference, Women's Indian Association and National Council of Women in India presented their argument to raise the minimum age of marriage for women before the Joshi committee. The Committee presented its report to the Imperial Legislative Council on 20 June 1929. Finally, on 28 September 1929, the Imperial Legislative Council passed the Child Marriage Restraint Act and it became a law on 1st April 1930 after it was approved by Lord Irwin. It set a minimum age of marriage as 14 years for women and 18 years for men. This Act is popularly known as Sarda Act as it was sponsored by Rao Sahib Harbilas Sarda who was a retired judge and a member of Arya Samaj.

Statement 2 is not correct: In 2006, Prohibition of Child Marriage Act, 2006 was enacted which made child marriage, i.e. marriage below the prescribed minimum age of marriage for men and women, a cognizable and non-bailable offence. As per this Act also, the minimum age of marriage was 18 years for women and 21 years for men. This Act punished the parents of the children as well as priests who solemnised such marriage.

[SOL] In News: Recently, a saltwater or estuarine crocodile has been found dead in the Patasala river near Silapokhari village within the Bhitarkanika National Park (BNP) in Odisha.

Statement 1 is correct: Saltwater Crocodiles are the Earth's largest living crocodiles, with average-size males reaching 17 feet and 1,000 pounds.

Statement 2 is correct: Their primary habitats are brackish and freshwater regions of eastern India, Southeast Asia and northern Australia. In India, they are found in and around BNP, Odisha, the Sundarbans, Bengal and the Andaman and Nicobar Islands.

Statement 3 is correct: Odisha is the only State in India with all crocodile species namely, Gharial, Mugger and Saltwater crocodiles.

#### 87. [ANS] c

[SOL] Statement 1 is correct: The Kasturirangan report seeks to bring just 37% of the Western Ghats under the Ecologically Sensitive Area (ESA) zones — down from the 64% suggested by the Gadgil report.

Statement 2 is not correct: The Gadgil Committee came before the Kasturirangan Committee. The report recommended a blanket ban on mining, quarrying, setting up of red category industries and thermal power projects. Although hydro power projects are allowed with few restrictions,

Statement 3 is correct: The report recommended a blanket ban on mining, quarrying, setting up of red category industries and thermal power projects.

Although hydro power projects are allowed with few restrictions.

## 88. [ANS] c

[SOL] Statement 1 is correct: It is a UN global treaty to protect human health and the environment from the adverse effects of mercury and its compounds. The Minamata Convention is named after the Japanese city of Minamata, which experienced a severe, decades-long incidence of mercury poisoning after industrial wastewater from a chemical factory was discharged into Minamata Bay. Statement 2 is not correct: It is caused due to nitrate poisoning.

Statement 3 is correct: The major highlights of the Minamata Convention on Mercury include a ban on new mercury mines, the phase-out of existing mines and mercury-added products, as well as control measures on air emissions. The Convention also addresses interim storage of mercury and its disposal once it becomes waste, sites contaminated by mercury as well as health issues.

## 89. [ANS] d

[SOL] Option d is correct: The third edition of the exercise, titled EX-DUSTLIK would be conducted at Yangiarik, Uzbekistan from March 22 to March 31. EX- DUSTLIK's is a joint training exercise that is conducted between the armies of India and Uzbekistan.

The Grenadiers battalion that will represent India at this exercise is one of the Indian Army's highly decorated battalions. The first edition of the exercise was held in Uzbekistan in Nov 2019, second edition in March 2021 in Ranikhet, Uttarakhand.

It aims to provide impetus to the ever-growing military and diplomatic ties between the two nations and reflect the strong resolve of both nations to counter-terrorism.



[SOL] Statement 1 is not correct: Operation Greens scheme was launched by the Ministry of Food Processing Industries (MoFPI) in November 2018. It aims to enhance value realization of TOP farmers; reduce post-harvest losses; price stabilization for producers and consumers and increase food processing capacities and value addition.

Statement 2 is not correct: The scope of short term measures originally applicable to Tomato, Onion and Potato crops were expanded to 41 notified fruits & vegetables w.e.f. June 2020 as a part of Aatmanirbhar Bharat Abhiyan Package. In Budget Announcement 2021-22, the scope of long term strategy i.e. Value Chain Development Projects was expanded from TOP crops to 22 perishables which include 10 fruits, 11 vegetables (including TOP crops) and 1 marine product i.e. Shrimp.

## 91. [ANS] c

[SOL] Recently, the Centre for Science and Environment (CSE) stated that Global warming and climate change has the potential to put water security in India at risk.

Statement 1 is correct: It is envisioned to provide safe and adequate drinking water through individual household tap connections by 2024 to all households in rural India.

Statement 2 is correct: The Jal Jeevan Mission will be based on a community approach to water and will include extensive Information, Education and communication as a key component of the mission. The programme will also implement source sustainability measures as mandatory elements, such as recharge and reuse through greywater management, water conservation, rainwater harvesting.

## 92. [ANS] b

[SOL] India is observing Shaheed Diwas on 23rd March to pay homage to legendary freedom fighters Bhagat Singh, Rajguru and Sukhdev.

Option b is correct: Bhagat Singh was first arrested on charges of association with the Kakori Case, accused of an article written under the pseudonym Vidrohi (Rebel).

- He was also accused of being responsible for a bomb explosion in Lahore.
- Bhagat Singh, Rajguru and Sukhdev were sentenced to death in the Lahore conspiracy case and ordered to be hanged on 24 March 1931. The schedule was moved forward by 11 hours and the three were hanged on 23 March 1931 at 7:30 pm in the Lahore jail.

- What happened in the Lahore conspiracy case?
  - The trial was held by a Special tribunal constituted under the Defence of India Act 1915.
     Out of a total of 291 convicted conspirators, 42 were executed, 114 got life sentences and 93 got varying terms of imprisonment. 42 defendants in the trial were acquitted.
- Saunders' Murder Case:
  - On December 17, 1927, the revolutionaries Bhagat Singh and Shivaram Rajguru shot and killed assistant superintendent of police John Saunders. They were supported in this act by their compatriots Sukhdev Thapar and Chandrashekhar Azad.
- Emperor vs Aurobindo Ghosh and others, colloquially referred to as the Alipore Bomb Case, the Muraripukur conspiracy, or the Manicktolla bomb conspirac
  - It was a criminal case held in India in 1908.
  - The case saw the trial of a number of Indian nationalists of the Anushilan Samiti in Calcutta, under charges of "Waging war against the Government" of the British Raj. The trial was held at Alipore Sessions Court, Calcutta, between May 1908 and May 1909.
  - The trial followed in the wake of the attempt on the life of Presidency Magistrate Douglas Kingsford in Muzaffarpur by Bengali nationalists Khudiram Bose and Prafulla Chaki in April 1908, which was recognised by the Bengal police as linked to attacks against the Raj in the preceding years, including attempts to derail the train carrying Lieutenant-Governor Sir Andrew Fraser in December 1907.

## 93. [ANS] c

[SOL] Statements 1 and 3 are correct: A black box is a combination of flight data recorder that records the altitude, speed among other pertinent details and a cockpit voice recorder that records the conversation among pilots. Data from these black boxes reveal the reason behind a crash.

- Black box is a recording device used by aviation investigators to analyse the events leading to the air mishap
- Black boxes are not actually black, but high-visibility orange
- Australia was the first country to make black boxes mandatory in its aeroplanes

Statement 2 is not correct: They are mandatory. The aim is not to establish legal liability, but to identify causes and help prevent accidents.

## 94. [ANS] d

[SOL] In News: West Bengal Congress president renewed his calls to invoke Article 355 in the state given the violence that broke out in the Birbhum district.

- Article 355 deals with Duty of the Union to protect States against external aggression and internal disturbance.
  - It shall be the duty of the Union to protect every State against external aggression and internal disturbance and to ensure that the Government of every State is carried on in accordance with the provisions of this Constitution.

### 95. [ANS] d

[SOL] Karnataka and Tamil Nadu are heading for a political confrontation over the Mekedatu drinking water project across river Cauvery.

- Originally mooted in 1948: Mekedatu is a drinking water cum power generation project across river Cauvery.
- Location: Proposed by Karnataka, the project envisages a reservoir near Ontigondlu, about 1.5 km from Mekedatu in Ramanagara district of south Karnataka at the confluence of the Cauvery and Arkavathi rivers.
  - It is 4 km from the Tamil Nadu border and 100 km from Bengaluru.
- Cauvery Water Disputes Tribunal: Karnataka gave the project shape after the final award of the Cauvery Water Disputes Tribunal was notified in 2013 allocating the riparian states their shares.

• Cost: The project cost is estimated at Rs 9,000 crore.

#### 96. [ANS] c

[SOL] Statement 1 is correct: The aim of the Artemis Programme is to land humans on the moon by 2024, and it also plans to land the first woman and first person of colour on the moon. Statement 2 is correct: Space agencies involved:

- Lead is a highly toxic metal and a very strong poison: Lead poisoning is a serious and sometimes fatal condition. It occurs when lead builds up in the body.
- Source: Lead is a metal that occurs naturally in the earth's crust, but human activity such as mining, burning fossil fuels and manufacturing has caused it to become more widespread.
  - Lead was also once used in paint and gasoline and is still used in batteries, solder, pipes, pottery, roofing materials and some cosmetics.
- Vulnerability: Lead poisoning usually occurs over a period of months or years. It can cause severe mental and physical impairment. Young children are most vulnerable.
  - Lead is more harmful to children because their brains and nervous systems are still developing.
- Treatment: Lead poisoning can be treated, but any damage caused cannot be reversed.

# 99. [ANS] d

[SOL] In News: The Polar Science and Cryosphere (PACER) scheme has been approved for continuation during 2021-2026.

- Statement 1 is not correct: Clear-air atmospheric observatories containing automatic weather stations, a suite of sensors to measure aerosol and greenhouse gas concentrations have been established at Maitri and Bharati stations in the Antarctic region.
- Statement 2 is not correct: Chandra Basin is situated in Lahaul-Spiti region of Western Himalaya.

## 100. [ANS] d

[SOL] In News: In 2021, Mumbai had recorded Particulate Matter (PM) 2.5 annual average of 46.4 microgram/cubic metre – nearly nine times above the World Health Organisation (WHO) limit – according to a report by IQAir.

Option d is correct: Particulate matter (PM) are inhalable and respirable particles composed of sulphate, nitrates, ammonia, sodium chloride, black carbon, mineral dust and water.

#### • PM2.5

- $\circ$  PM2.5 concentrations, in micrograms per cubic metre ( $\mu g/m^3$ ) were selected as the standard metric for this report.
- PM2.5, particulate matter consisting of fine aerosol particles measuring 2.5 microns or smaller in diameter, is one of six routinely measured criteria air pollutants.

- It is commonly accepted as the most harmful to human health due to its prevalence in the environment and broad range of health effects.
- It is generated from many sources and can vary in chemical composition and physical characteristics.
- Common chemical constituents of PM2.5 include sulphates, nitrates, black carbon, and ammonium.
- The most common human-made sources include internal combustion engines, power generation, industrial processes, agricultural processes, construction, and residential wood and coal burning. The most common natural sources for PM2.5 are dust storms, sandstorms, and wildfires.

[SOL] Recently, the Centre cleared nine names, including two from Jammu and Kashmir which were earlier reiterated by the Supreme Court collegium.

Option b is correct: Collegium System is a system under which appointments and transfers of judges are decided by a forum of the Chief Justice of India and the four senior-most judges of the Supreme Court. It has no place in the Indian Constitution.

- History:
  - The Collegium of judges is the Supreme Court's invention.
  - No mention in the constitution: It does not figure in the Constitution, which says judges
    of the Supreme Court and High Courts are appointed by the President and speaks of a
    process of consultation.
  - Article 124 deals with the appointment of Supreme Court judges. It says the appointment should be made by the President after consultation with such judges of the High Courts and the Supreme Court as the President may deem necessary. The CJI is to be consulted in all appointments, except his or her own.
- National Judicial Appointment Commission (NJAC) as rescue but no result:
  - An attempt to replace collegium by a 'National Judicial Appointments Commission' was struck down by the court in 2015.
  - The reason stated was that NJAC posed a threat to the independence of the judiciary.
  - o Dissenting judge, Justice J. Chelameswar termed it "inherently illegal".
  - Even the majority opinions admitted the need for transparency.
- Procedure:
  - The President of India appoints the CJI and the other SC judges.
  - As far as the CJI is concerned, the outgoing CJI recommends his successor.
    - In practice, it has been strictly by seniority ever since the supersession controversy of the 1970s.
    - The Union Law Minister forwards the recommendation to the Prime Minister who, in turn, advises the President.

#### 102. [ANS] b

[SOL] Statement 1 is correct: The Antarctic treaty remains the only example of a single treaty that governs a whole continent.

Statement 2 is correct: India has been a member since 1983.

Statement 3 is not correct: It is headquartered in Buenos Aires, Argentina.

#### 103. [ANS] d

[SOL] In News: Recently, Calcutta High Court ordered the Central Bureau of Investigation (CBI) to investigate the killings in Bogtui village of West Bengal's Birbhum district, where eight persons were burnt alive, hours after the murder of a Trinamool Congress panchayat leader.

Central Bureau of Investigation (CBI) is the premier investigating police agency in India.

- It has its origin in the Special Police Establishment set up in 1941 to probe bribery and corruption during World War II.
- It was set up by a resolution of the Ministry of Home Affairs in 1963 after Santhanam committee recommendation.
- CBI investigations have a major impact on the political and economic life of the nation. The following broad categories of criminal cases are handled by the CBI:
  - Cases of corruption and fraud committed by public servants of all Central Govt.
     Departments, Central Public Sector Undertakings and Central Financial Institutions.
    - The Anti-Corruption Division of the CBI has handled cases against Chief Ministers, Ministers, Secretaries to Government, Officers of the All India Services, CMDs of Banks, Financial Institutions, Public Sector Undertakings, etc.
  - Economic crimes, including bank frauds, financial frauds, Import Export & Foreign Exchange violations, large-scale smuggling of narcotics, antiques, cultural property and smuggling of other contraband items etc.
  - Special Crimes, such as cases of terrorism, bomb blasts, sensational homicides, kidnapping for ransom and crimes committed by the mafia/the underworld.

[SOL] In News: Union Minister of Rural Development & Panchayati Raj felicitated 75 trained candidates of Project UNNATI under Mahatma Gandhi NREGA .

- It is a skilling project intended to upgrade the skill base of the Mahatma Gandhi NREGA beneficiaries, and thereby improving their livelihoods, so that they can move from the current partial employment to full-time employment and hence reduce their dependence on Mahatma Gandhi NREGS.
- This project is meant for providing training for one adult member (of age 18-45 years old) of a household who has completed 100 days of work under Mahatma Gandhi NREGA in the previous financial year from the year of commencement of the project.

## 105. [ANS] b

[SOL] The Lok Sabha approved the Finance Bill, 2022. The approval completes the budgetary process for the next financial year.

- Statement 1 is not correct: Crypto currencies are not a legal tender in India and hence are not under the regulatory control of any body.
- Statement 2 is correct: India at present has no Dispute Settlement Mechanisms with reference to Crypto currencies.
- Statement 3 is correct: El Salvador is the first country to use bitcoin as legal tender, alongside the US dollar.

[SOL] Department of Agriculture & Farmers Welfare (DA&FW) has provisionally notified Nano Urea as Nano Nitrogen Fertilizers in Fertilizer Control Order, 1985.

Benefits/ Significance of Nano-Fertilizers:

- Application of Nano Urea results in better crop productivity.
- This is regarded as an excellent alternative to chemical fertilizers because it promotes growth and reduces environmental pollution.
- Nano-fertilizers also reduce the crop cycle period and increase crop yield.
- The unique properties of nanoparticles, such as high absorption capacity, the increased surface to volume ratio, and controlled-release kinetics to targeted sites, make them a potential plant growth enhancer.

Limitations of Nano-Fertilizers:

• Lack of a nano-fertilizer risk management system

- Lack of production and availability of nano fertilizers in required quantities. This limits the wider scale adoption of nano-fertilizers as a source of plant nutrients.
- The high cost of nano fertilizers
- Lack of standardization in the formulation process. This brings about different results of the same nanomaterial under various pedoclimatic conditions.

#### 107. [ANS] a

[SOL] Statement 1 is correct. Shaivite Bhakti Saints are called Nayanars. Basavana was a Nayanar saint and poet and compiled Vachanas.

Statement 2 is not correct. He founded Lingayats also known as Veershaivs. Nathpanthis were founded by Gorakhnath.

Statement 3 is not correct. He was a contemporary of Chalukyan Kings, not VijayaNagar Empire. Vijaynagar empire came into existence in the 14th century whereas Basvanna was a saint of the 11th century.

## 108. [ANS] d

[SOL] In News: The study reveals the durability and robustness of the T cell responses against variants, including Delta, even after one year of infection.

Statements 1,2 and 3 are correct: T cells are a diverse and important group of lymphocytes that mature and undergo positive and negative selection processes in the thymus.

- There are several types of T cells; the most common and well-known are the CD4+ T cells (helper T cells) and CD8+ T Cells (cytotoxic T cells, or killer T cells).
  - T cells play a vital role in both components of active immunity, including cell-mediated and to some extent humoral immunity.
  - T cells cannot recognize soluble, free antigens. T cells can only recognize protein-based, receptor-bound antigens.

## 109. [ANS] b

[SOL] In News: India's space economy has evolved considerably and now accounts for about 0.23% of the GDP according to the CDS-IIST research project.

- Statement 1 is not correct: The estimated size of India's space economy as a percentage of the GDP: has slipped from 0.26% in 2011-12 to 0.19% in 2020-21.
- Statement 2 is correct: In relation to GDP, India's spending is more than that of China, Germany, Italy and Japan, but less than the U.S. and Russia.

[SOL] Recently, the second edition of Export Preparedness Index 2021 was released by NITI Aavog.

Option a is correct: Export Preparedness Index 2021 was released by NITI Aayog, in partnership with the Institute of Competitiveness, released the Export Preparedness Index (EPI) 2021. The report is a comprehensive analysis of India's export achievements.

#### Goal:

- To instil competition among all Indian states ('Coastal', 'Landlocked', 'Himalayan', and 'UTs/City-States')

- It is measured in hertz (Hz).
  - o So, a 30 Hz or a 60 Hz display can refresh 30 or 60 times per second, respectively.
- The higher the refresh rate, the better the quality of viewing experience.
- Displays with over 120 Hz can deliver a smoother and more comfortable viewing experience.
  - This is necessary while playing video games or watching videos.
- VRR supports a wide range of refresh rates, allowing its refresh rate to change in real-time based on the frames-per-second (FPS) rate coming from a source device such as a gaming console.

## 112. [ANS] c

[SOL] In News: Defence Research and Development Organisation (DRDO) conducted two successful flight tests of the Indian Army version of Medium Range Surface to Air Missile (MRSAM) at Integrated Test Range, Chandipur off the coast of Odisha.

Statements 1 and 3 are correct: MRSAM is a Surface-to-Air Missile

- The MRSAM Army weapon system comprises multi-function radar, mobile launcher system and other vehicles.
- The flight tests were carried out with the weapon system in deliverable configuration.
- The performance of the weapon system was validated through the flight data captured by range instruments like radars, electro-optical tracking systems and telemetry deployed by ITR, Chandipur.

Statement 2 is not correct: This MRSAM version developed jointly by DRDO and Israel Aerospace Industries (IAI), Israel for use by the Indian Army.

[SOL] In News: The Lok Sabha has passed the Constitution (Scheduled Tribes) Order (Amendment) Bill, 2022. The Bill proposes the "Darlong" community as a sub-tribe of "Kuki" in the list of Scheduled Tribes.

Statements 1 and 2 are correct: Kuki is a word pronounced by outside people to refer to a group of tribes like Darlong and Lusai.

- The Lusai of Tripura used to live in Jampui and Shakan Hills of North Tripura.
  - They call them as Mizos. They never call them Lusai as the word 'LU' means Head and 'SAI' means cutting (Head Hunter). Though once they were treated as headhunters.
- Darlong is another tribe known as Kukis.
- They live in hill tops and maintain their livelihood through Jhum Cultivation and producing fruits. nowadays they are also accustomed with plain land cultivation and rearing of animals.
- Kukis are very much experts in hunting wild animals.
- Linguistically they speak a language that originated from the Kuki-Chin linguistic family and they have so many clans.
- Kukis are fond of music and dance.

Statements 3 and 4 are not correct: They do not arrange any marriage alliances outside their community.

- Tradition-ally they were not Christian. They had faith in lord Shiva beside different deities and spirits. But for the last fifty years the majority of them have embraced Christianity.
- They have their own customary laws and village council. LAL is a term to denote village chief. This is the reason for which Darlong uses Lal before their name.
- Kukis are presently a small tribe in the state and socio-economically more advanced.

## 114. [ANS] c

[SOL] In News: 21 years after destroying Bamiyan Buddhas, Taliban now seek to preserve Buddhas.In their Roman draperies and with two different mudras, the Bamiyan Buddhas were great examples of a confluence of Gupta, Sassanian and Hellenistic artistic styles. Bamiyan is

situated in the high mountains of the Hindu Kush in the central highlands of Afghanistan.

- The valley, which is set along the line of the Bamiyan River, was once integral to the early
  days of the Silk Roads, providing passage for not just merchants, but also culture, religion
  and language.
- They are said to date back to the 5th century AD and were once the tallest standing Buddhas in the world.
- Salsal and Shamama, as they were called by the locals, rose to heights of 55 and 38 metres respectively, and were said to be male and female.
  - Salsal means "light shines through the universe"
  - Shamama is "Queen Mother".
- The statues were set in niches on either ends of a cliff side and hewn directly from the sandstone cliffs.

#### 115. [ANS] c

[SOL] Union Minister for Law and Justice in response to a question in the Lok Sabha stated that the government was exploring the possibility of allowing online voting for non-resident Indians (NRI).

Statement 1 is not correct: The Conduct of Election Rules, 1961 was amended in 2016 to allow only service voters to use the ETPBS.

Statement 2 is not correct: Under this system, postal ballots are sent electronically to registered service voters. The service voter can then register their mandate on the ballot and send it back via ordinary mail.

Statement 3 is correct: As per the Indian Constitution, all Indian citizens above the age of 18 years who have registered themselves as voters are eligible to vote.

- It is a concurrent program to Deen Dayal Upadhyaya Gram Jyoti Yojana" (DDUGJY)
- Rural Electrification Corporation Limited (REC) is the nodal agency for the operationalization of the scheme throughout the country. The prospective beneficiary households for free connection would be identified using Socio-Economic Caste Census (SECC) 2011 data.
  - Households not found eligible as per SECC data, would also be provided electricity connections on payment of Rs 500 recoverable in 10 instalments through electricity bills.

Statement 3 is not correct: All DISCOMs including Private Sector DISCOMs, State Power Departments and RE Cooperative Societies are eligible for financial assistance.

 Dedicated web portal for SAUBHAGYA has been developed to capture the information and progress of household electrification

- Atal Innovation Mission (AIM): Launched by NITI Aayog as a flagship programme, it aims to promote a culture of innovation and entrepreneurship in India.
  - o Some initiatives of AIM are AIM iCREST and Mentors of Change.
- Project Chunauti: It is a start-up challenge under the Next Generation Incubation Scheme (NGIS) initiative. Selected startups are provided human resources, legal, intellectual property rights (IPR) and Patent matters guidance as well as other incubation and mentorship facilities.

National Initiative for Developing and Harnessing Innovations (NIDHI): It is an umbrella
programme for nurturing ideas and innovations (knowledge-based and technology-driven)
into successful startups.

#### 122. [ANS] a

[SOL] Statement 1 is not correct. The Lithium-ion batteries are rechargeable batteries which use an intercalated lithium compound as one electrode material, compared to the metallic lithium used in a non-rechargeable lithium battery.

Statement 2 is correct. Lithium ions move from the negative electrode to the positive electrode during discharge and back when charging.

## 123. [ANS] c

[SOL] Statement 1 is correct. The Organization of the Petroleum Exporting Countries (OPEC) was created at the Baghdad Conference in September 1960, by Iran, Iraq, Kuwait, Saudi Arabia and Venezuela.

They also signed the BRICS Contingent Reserve Arrangement to provide short-term liquidity support to the members.

Option d is correct: The Information Technology (Intermediary Guidelines and Digital Media Ethics Code) Rules, 2021 define a significant social media intermediary ("SSMI") as a social media intermediary whose number of registered users in India is more than 50 lakh registered users.

- As of today's date, some of the sizable SSMIs in India are WhatsApp, YouTube, Facebook, Instagram and Twitter.
- 126. [SOL] With space junk posing an increasing threat to Indian assets in space, ISRO is building up its orbital debris tracking capability by deploying new radars and optical telescopes under the NETRA project.

Option d is correct: The Fengyun-1C satellite is a part of the anti-satellite test (ASAT) by China.

- Most Space debris comprises human-generated objects, such as pieces of spacecraft, tiny
  flecks of paint from a spacecraft, parts of rockets, satellites that are no longer working, or
  explosions of objects in orbit flying around in space at high speeds.
- Hurtling at an average speed of 27,000 kmph in LEO, these objects pose a very real threat as collisions involving even centimetre-sized fragments can be lethal to satellites.

[SOL] In News: A draft recommendation on 'biodiversity and health' was released during the Convention on Biological Diversity concluded recently.

Option a is correct: The Convention on Biological Diversity (CBD) is known informally as the Biodiversity Convention.

- It is a multilateral treaty.
- The convention was opened for signature at the Earth Summit in Rio de Janeiro in 1992 and entered into force in 1993.
- The United States is the only UN member state which has not ratified the convention.
- It has two supplementary agreements, the Cartagena Protocol and Nagoya Protocol.
  - The Cartagena Protocol on Biosafety to the Convention on Biological Diversity is an
    international treaty governing the movements of living modified organisms (LMOs)
    resulting from modern biotechnology from one country to another.
  - The Nagoya Protocol on Access to Genetic Resources and the Fair and Equitable Sharing
    of Benefits Arising from their Utilization (ABS) to the Convention on Biological
    Diversity is another supplementary agreement to the CBD.
- It has been ratified by 196 nations.
- The CBD's governing body is the Conference of the Parties (COP). This ultimate authority of all governments (or Parties) that have ratified the treaty meets every two years to review progress, set priorities and commit to work plans.
- The Secretariat of the Convention on Biological Diversity (SCBD) is based in Montreal, Canada.

[SOL] Cabinet Committee on Economic Affairs (CCEA) is chaired by the Prime Minister. One of the standing committees of the cabinet. It comprises 11 ministers and 3 special invitees. Major functions:

- Take major economic decisions like disinvestments, MSP, etc.
- CCEA handles the functions of the cabinet committee on prices, cabinet committee on UIDAI, Cabinet committee on WTO, after they were scrapped.
