## History of December 25

- ◆ 1771: The Mughal ruler Shah Alam II ascended the throne of Delhi under the protection of the Marathas.
- 1924: The first All India Communist Conference was held in Kanpur.
- 1763: Maharaja Surajmal of Bharatpur was assassinated.
- ♦ 1892 : Swami Vivekananda meditated for three days on a rock situated in the middle of the sea in Kanyakumari.
- ♦ 2002 : A defense agreement was signed between China and Bangladesh.

## **Current Affairs Related to 25 December**

- ♦ The government allowed 22 states to borrow additional Rs 60,000 crore for the National Pension Scheme. 3 percent of Gross State Domestic Product or exactly Rs 8,59,988 crore has been fixed as the general net borrowing limit for states in FY 2024.
- ★ King Jigme Khesar Namgyel Wangchuck of Bhutan unveiled the Gelephu SmartCity project, outlining a massive international city of over 1000 sq km along the Assam border. The picturesque Himalayan kingdom of Bhutan is set to embark on a transformational journey with the announcement of its ambitious Gelephu Smartcity project.
- The Jammu and Kashmir administration has introduced detailed rules for registration of Sikh marriages under the Anand Marriage Act. Jammu and Kashmir administration has taken an important step towards fulfilling the long standing demand of the Sikh community by implementing the Anand Marriage Act. The Act provides statutory recognition to Sikh marriage rituals, allowing Sikh couples to register their marriage under specific rules rather than the Hindu Marriage Act.
- ♦ The Israeli government gave its approval to the appointment of Reuven Azar as the new Ambassador to India. Azar, who currently serves as Israel's Ambassador to Romania, will also take up the role of non-resident ambassador to Sri Lanka and Bhutan.
- India remains the largest recipient of remittances in the world in 2023 with \$125 billion in remittances, according to the World Bank's latest Migration and Development report. Mexico, China, the Philippines and Egypt are among the top five remittance receiving countries in the world. The South Asia region recorded an increase in remittance inflows to India.
- Zinc Football Academy, a CSR initiative of Hindustan Zinc has earned the elite 3.Star rating awarded by AIFF, cementing its position among India's top youth development academies.

- Domestic rating agency ICRA increased India's economic growth rate forecast for the current financial year from 6.2 percent to 6.5 percent. However, this is lower than the RBI's revised growth rate estimate of seven percent. The agency said that due to the continuation of decline in commodity prices, the growth rate in the October-December quarter is expected to be better than the previous estimate.
- India leads the way in remittances and will reach \$125 billion in 2023, outperforming estimates. Global flows to low- and middle-income countries increased by 3.8%, totaling \$669 billion. The report underlines the important role of inclusive labor markets and social protection policies.
- ♦ Hyderabad ranks first in India in terms of food adulteration. In cases of food adulteration, Andhra Pradesh stood next to Telangana. In 2021, a total of 291 cases of food adulteration were reported in 19 major cities of India.
- ◆ Indian Armed Forces officers have been awarded the Golden Owl for their outstanding performance. DSCSC courses are designed to prepare senior officers for leadership roles in joint operations and high command. Wing Commander Sumeet Mahajan, Major Rohit and Lieutenant Commander Sunny Sharma were given this award by Sri Lankan President Ranil Wickremesinghe.
  - Rice industry associations have been instructed by the Center to ensure reduction in the retail price of rice with immediate effect. Shri Sanjeev Chopra, Secretary, Department of Food and Public Distribution, convened a meeting with key representatives of the rice processing industry to review the domestic price scenario of non-Basmati rice in New Delhi.It was discussed in the meeting that despite good Kharif crop this year, adequate stock with FCI and various rules regarding export of rice, domestic prices of rice are increasing.
