History of 2nd July

- ♦ 1306: When Alauddin Khilji attacked Siwana, this fort was under the control of Chauhan Sardar Shitaldev, the protector of Kanhaddev.
- ◆ 1916: The Scientific Survey of India was established.
- ♦ 1940 : Subhash Chandra Bose was arrested by the British government on charges of inciting rebellion.
- ♦ 1972: Prime Minister Indira Gandhi and Pakistan President Zulfikar Ali Bhutto signed an agreement.

Current Affairs Related to 2nd July 2024

- Council of Scientific and Industrial Research and AIIMS will run One Week One Theme campaign from June to December 2024. The campaign will showcase India's recent success stories in various fields of science and technology. The campaign will showcase projects that promote innovation, create employment opportunities and showcase the research and development work of CSIR. The main objective of this initiative is to promote the achievements of CSIR laboratories and promote collaboration with industry.
- Under the ULAS-Nav Bharat Literacy Programme, Ladakh has become the first administrative body to achieve full functional literacy. More than 97% of the people in the union territory are literate. ULAS is a centrally sponsored programme, also known as the New India Literacy Program or Nav Bharat Saksharta Karyakram, being implemented from 2022 to 2027. This is in line with the recommendations of the National Education Policy 2020. Additionally it tries to integrate them into the society so that they can further contribute to the progress of the nation.
- Kotak Mahindra Bank in India plans to increase its branch network by 175 to 200 percent in FY 2025. The decision comes despite the Reserve Bank of India's new regulatory norms on digital customer acquisition and credit card issuance due to IT-related issues. Mr. Virat Diwanji, Group President and Head of Consumer Bank, highlighted the bank's drive for this expansion strategy, noting its historical growth rate of nearly 150 per cent.
- Garden Reach Shipbuilders & Engineers Limited has been awarded the Outlook Planet Sustainable Governance Champion Award 2024. This recognition highlights GRSE's continuous efforts towards a sustainable structure and governance system. Garden Reach Shipbuilders and Engineers Limited is a major shipyard in India, located in Kolkata.

- Pradhan Mantri Awas Yojana is making a scheme of affordable housing for the urban poor. It was launched in 2015 and has been extended till December 2024. Its main objective is to overcome the shortage of urban housing among poor and middle income group people living in slums. The Ministry of Urban Affairs had also announced the Scheme of Special Assistance to States for Capital Investment 2023.2024 and 2022.2023. Its main objective is to encourage states to improve and accelerate the basic urban planning ecosystem in cities.
- The market capitalization of ICICI Bank has crossed the \$100 billion mark for the first time, and it has also become the sixth company in the country whose market value is more than \$100 billion. Earlier, Infosys had also achieved this feat. After touching the record high of Rs 1207, ICICI Bank shares last closed at Rs 1199 with a rise of 2.5 percent.
- Defense Research and Development Organization organized an event in New Delhi to develop medium range Web Obscurant Chaff Rocket for the Indian Navy. This rocket creates a microwave bright cloud in space, which forms an effective shield against attacks with radio free bassists. Developed by DRDO's Defense Laboratory in Jodhpur, this technology exposes radar, creates a microwave shield all around the surface and thickness to reduce radar detection.
- ♦ The Comptroller and Auditor General of India inaugurates Chadwick House: Navigation Audit Heritage Museum. This museum is an important milestone in preserving and celebrating the rich heritage of the institution and its contribution to the governance of the country. Chadwick House is an important site with a rich and extensive history.
