MOU/Agreement Countries:

- India and the US have signed an agreement for cooperation in the development of Air-Launched Unmanned Aerial Vehicle (ALUAV).
- ➤ Union Cabinet has approved the signing of Memorandum of Understanding between the Institute of Chartered Accountants of India and the Chamber of Auditors of the Republic of Azerbaijan.
- India, Denmark jointly launched 'Centre of Excellence on Offshore Wind' as part of Green Strategic Partnership.
- ➤ Union Cabinet approved the signing of an agreement between India and Portugal on the recruitment of Indian citizens to work in that European country.
- The Pharmacopoeia Commission for Indian Medicine has signed MoU with Homoeopathy and the American Herbal Pharmacopoeia, USA.
- ➤ India and the United Arab Emirates (UAE) have formally launched negotiations on a Comprehensive Economic Partnership Agreement (CEPA) that aims at expanding bilateral trade and investment between the two nations.
- India and Oman inked an agreement for exchange of white shipping information and to boost maritime security cooperation in reflection of growing cooperation between the two sides.

For setting up the country's first Air Force Heritage Centre, the Chandigarh administration and IndianAir Force signed an in-principle agreement.



- ➤ Nasscom Centre of Excellence for Internet of Things (CoE-IoT) has signed an intent of cooperation with Taiwan-India Artificial Intelligence Technology Innovation Research Centre, Taiwan's largest university and incubator of startups under the National Chung Cheng University.
- ➤ National Mission for Clean Ganga (NMCG) and South Asian Institute for Advanced Research and Development (SAIARD) have signed an MoU to create and enhance capacity building on integrated river basin management.
- ➤ Punjab government and the American Chamber of Commerce in India (Amcham India) signed a memorandum of understanding (MoU) to promote investment in the state as well as further increase the ease of doing business for US member companies.
- ➤ Gujarat Government has signed a Memorandum of Understanding (MoU) with Amazon India to boost the export of MSME sector.
- Coal India Limited has signed an MoU with Department of Sports in New Delhi for betterment of sports infrastructure in the country.
- All India Institute of Ayurveda under Ministry of Ayush has signed a Memorandum of Understanding, MoU in coordination with Western Sydney University Australia, in virtual mode to appoint an Academic Chair in Ayurveda.
- ➤ The Indian Institute of Technology Bombay signed an MoU with the Indian Institute of Astrophysics (IIA) for extending the ongoing collaboration for operations and scientific utilisation of the GROWTH-India Telescope in Ladakh.
- ➤ Coal India Ltd or the CIL (under the Ministry of Coal) signed an MoU with Department of Health & Family Welfare, Govt. of Assam to strengthen the health infrastructure at Silchar Medical College & Hospital, Silchar, the only Medical College / Hospital in Barak Valley Region, Assam.
- Indian Institute of Technology Kanpur and the Indian Air Force have joined forces in their efforts to develop strong technologies in the field of Aerospace Technology, both academically and via research.
- Niti Aayog's Atal Innovation Mission in collaboration with ISRO and CBSE has launched 'Space Challenge' for school students across India.
- ➤ BLS International has been empanelled for processing Ayushman Bharat cards under Pradhan MantriJan Arogya Yojana (AB-PMJAY) by the National Health Authority.
- ➤ Vodafone Idea (Vi) has joined hands with Celltick, a provider of cell broadcast-based products and public warning systems, to deploy an Integrated Public Alert and Warning System (IPAWS) for the Andhra Pradesh State Disaster Management Authority (APSDMA).
- ➤ United Nations Development Programme (UNDP), HDFC Bank and the Greater Noida Industrial Development Authority (GNIDA) inked a pact to set up a facility for to manage up to 300 metric tonnes ofdry waste in the city every month.
- Atal Innovation Mission (AIM), Niti Aayog in collaboration with the Indian Space Research Organisation (ISRO) and Central Board of Secondary Education (CBSE) successfully launched the ATLSpace Challenge 2021 for all school students across the country.

Recognitions

Dorje Angchuk, a Ladakh-based engineer has become the only Indian Honorary Member of the International Astronomical Union.

Odisha's Manda buffalo, mostly found in Koraput district and adjoining areas of Malkangiri and Nabarangpur, has been recognised as an indigenous breed by the National Bureau of Animal Genetic Resources (NBAGR).

Ramesh Narayan will be inducted into the Asian Federation of Advertising Associations (AFAA) Hall ofFame at AdAsia 2021 slated to be held on December 3,4.

Jeev Milkha Singh has become the first professional golfer in the world to receive the prestigious 10-year Dubai Golden Visa in recognition of his outstanding achievements in the sport.

Union Minister of Home Affairs and Minister of Cooperation, Shri Amit Shah awarded Rajbhasha Gaurav & Rajbhasha Kirti Awards to Ministries, Departments, Undertakings who have done excellent work in the Official Language during the years 2018-19, 2019-20 and 2020-21. Union Minister of Home Affairs and Minister of Cooperation also released the 160th issue of the "Rajbhasha Bharati" booklet. Shri Shah also launched the E-Saral Hindi Vakya Kosh and E-Maha Shabda Kosh Mobile App, both initiatives of the Department of Official Language that aim to harness information technology for the growth of Hindi.
