[SOL] In News : IRENA launched the World Energy Transitions Outlook 2022 at the Berlin Energy Transition Dialogue.

- World Energy Transitions Outlook outlines priority actions till 2030 to keep 1.5°C alive.
- Aim: It calls on governments to fast-track energy transition for more energy security, resilience and affordable energy for all.
- Goals: The Outlook sets out priority areas and actions based on available technologies that must be realised by 2030 to achieve net zero emissions by mid-century.
 - Renewables will have to scale-up massively across all sectors from 14 percent of total energy today to around 40 per cent in 2030.
 - Global annual additions of renewable power will triple by 2030 as recommended by the Intergovernmental Panel on Climate Change.

[SOL] In News : Recently ,The Union Home Ministry has considerably reduced the "disturbed areas" under the Armed Forces (Special) Powers Act (AFSPA) in Assam, Manipur and Nagaland.AFSPA remains in force in parts of these three states as well as in parts of Arunachal Pradesh and Jammu & Kashmir.

- The order, effective from April 1, would be applicable for six months.
 - AFSPA was enacted by the Parliament and approved by the President in 1958.
 - It confers certain special powers on members of the Armed Forces (military forces, air forces operating on the ground as land forces and any other armed forces of the Union (CRPF, BSF, ITBP etc)for carrying out proactive operations against the insurgents in a

highly hostile environment.

- They have the authority to prohibit a gathering of five or more persons in an area.

[SOL] In News : The Supreme Court found in the Dam Safety Act of 2021 a panacea to end the "perennial" legal battle between Tamil Nadu and Kerala over the Mullaperiyar dam.]

Statements 1 and 2 are not correct : Mullaperiyar dam was built in 1895 on the Periyar River in the Idukki district of Kerala.

- It is situated high up in the Western Ghats, adjacent to Kerala's famed Periyar wildlife sanctuary.
- Mullaperiyar is listed among the world's big dams that need to be decommissioned in a report by the UN University Institute for Water, Environment and Health.
 - It has been stated that the Mullaperiyar dam, situated in a seismically active area, faces the risk of failure.
 - The ageing of large dams is an emerging global development issue as they pose threats to human safety and the environment.
- Decommissioning Mullaperiyar is strongly opposed by Tamil Nadu state, which inherited a lease agreement between the former princely state of Travancore (now Kerala) and the British government.
 - The matter is still subjudice in the Supreme Court.

[SOL] In News : Pluto has a giant ice volcano like Wright Mons that could hint at the possibility of life.

- It was spotted on the surface of Pluto by the New Horizons spacecraft in July 2015.
- It was informally named by the New Horizons team in honour of the Wright brothers.
- It is about 150km across its base and has a central depression (a hole) 40-50km wide, with a floor at least as low as the surrounding terrain.
- It rises 4-5km above its surroundings.
- Its volume exceeds 20 thousand cubic kilometres.

[SOL] Statement 1 is not correct: The Current Account records exports and imports in goods, trade in services and transfer payments and the Capital account records all international

purchases and sales of assets such as money, stocks, bonds, etc. It includes foreign investments and loans. Capital receipts and payments are part of the Capital account not of the current account.

Statement 2 is not correct: Rupee convertibility is the ease with which the rupee can be converted into another currency at the market exchange rate. It is of two types, one is Capital Account Convertibility and the other is Current Account Convertibility. Capital Account Convertibility means the freedom to convert rupee into any foreign currency (Euro, Dollar, Yen, Renminbi etc.) and foreign currency back into rupee for capital account transactions. Current Account Convertibility allows free inflows and outflows of foreign currency for all-purpose including resident Indians buying foreign goods and services (imports), Indians selling foreign currency for travel, study abroad, medical tourism purpose etc. The Indian rupee is fully convertible only in the current account and partial in the capital account.

[SOL] In News : The Union Cabinet chaired by the Prime Minister approved a USD 808 million or Rs 6,062.45 crore, World Bank assisted programme on "Raising and Accelerating MSME Performance" (RAMP).

Statements 1,2 and 3 are not correct : RAMP was formulated and proposed by the Government of India, for strengthening MSMEs in line with the recommendations made by U K Sinha Committee, KV Kamath Committee and Economic Advisory Council to the Prime Minister (PMEAC).

- RAMP is a World Bank assisted Central Sector Scheme, supporting various COVID Resilience and Recovery Interventions of the Ministry of Micro, Small and Medium Enterprises.

[SOL] In News :As a record number of 4.92 lakh Olive Ridley turtles have crawled to the Rushikulya coast in Odisha, scientists have tagged more than 6,000 turtles to gather more information about their breeding behaviour and migration.

Statements 1 and 3 are correct : The Olive ridley turtles are the smallest and most abundant of all sea turtles found in the world. The species is recognized as Vulnerable by the IUCN Red list.

- International trade in these turtles and their products is banned under CITES Appendix
- They are carnivores, and feed mainly on jellyfish, shrimp, snails, crabs, molluscs and a variety of fish and their eggs.

Statement 2 is not correct : They are inhabiting warm waters of the Pacific, Atlantic and Indian oceans. These turtles spend their entire lives in the ocean, and migrate thousands of kilometres between feeding and mating grounds in the course of a year.

All of this will now be part of NFDC's mandate under

its Promotion Vertical, with which DFF employees will be attached on a temporary basis.

Statement 2 is correct: The National Film Heritage Mission aiming at digitisation and restoration of films and documentaries will now be implemented by NFDC.

[SOL] In News : The government introduced the 'Antarctica Bill' in the Lok Sabha .

Statements 1 and 2 are correct : Antarctica is a continent. It is Earth's fifth largest continent. Antarctica is covered in ice. Antarctica covers Earth's South Pole.

Antarctica is the coldest place on Earth. The temperature in the winter is cold enough to freeze water all the time. The temperature in the middle of Antarctica is much colder than the temperature on the coasts.

- Antarctica has two seasons: summer and winter. Earth is tilted in space and the direction of tilt never changes. During summer, Antarctica is on the side of Earth tilted toward the sun. It is always sunny. In winter, Antarctica is on the side of Earth tilted away from the sun. Then, the continent is always dark.
- Antarctica has no trees or bushes. The only plants that can live in a place that is cold are moss and algae.

Statement 3 is not correct : Since 1981, India has completed 40 scientific expeditions and built three permanent research base stations in Antarctica — Dakshin Gangotri (1983), Maitri (1988) and Bharati (2012).

- India has successfully launched the 41st scientific expedition to Antarctica with the arrival of the first batch of its contingent at southern Antarctica.
- Dakshin Gangotri was established in 1983 over the Ice Shelf in the Central Dronning Maud Land region.
 - The station was abandoned in 1990 as it got buried under snow.
 - Currently, Maitri and Bharati are fully operational.

[SOL] In News : The Punjab Mandi Board has decided to send a 'digital form J' on the WhatsApp number of farmers from this Rabi procurement season.

- 'J form' is the sale receipt of a farmer's agricultural produce in mandis (grain market).
- These forms were earlier issued manually by arthiyas (commission agents) because in Punjab, a majority of farmers sell their crops through such agents only.
 - Several arthiyas had the habit of keeping these forms with themselves, instead of providing it to the farmers, which was their right.

- But by getting digitised J form, farmers will now have a clear record of the crop sold and income received in lieu of that and it will save their time as well, ensuring that they do not need to run to arthiyas to get copies of their sale.
- The move, aimed at bringing transparency as well as empowering farmers, will make Punjab the first state in the country to provide 56 digitised form J in real time.

It can also cause life threatening metabolic disturbances. The Supreme Court banned the manufacture, sale, use and export of endosulfan throughout India, citing its harmful health effects.

Statements 1,2 and 3 are correct : IPCC is an intergovernmental body of the United Nations (UN).

• Established by World Meteorological Organisation (WMO) and United Nations Environment Programme (UNEP) in 1988

- It provides objective scientific information in order to understand human- induced climate change.
 - It also covers natural, political & economic impacts of these anthropogenic climate changes and possible response options.
- Its main activity is to prepare Assessment Reports, special reports, and methodology reports assessing the state of knowledge of climate change.
 - However, the IPCC does not itself engage in scientific research. Instead, it asks scientists from around the world to go through all the relevant scientific literature related to climate change and draw up the logical conclusions.

[SOL] In News : Recently ,Delhi High Court sought the Enforcement Directorate's (ED's) response on journalist Rana Ayyub's challenge to its action of restraining her from leaving the country.

• Ayyub was stopped in Mumbai based on a look out circular (LOC) issued by the ED, which is investigating her in a case of alleged money laundering.

Statements 1 and 2 are correct :An Look Out Circular (LOC), is issued to make sure that an individual who is absconding or wanted by law enforcement agencies is not able to leave the country. It is mostly used at immigration checkpoints at international airports and seaports by the immigration branch.In certain cases, the police can approach a court asking for the restriction of a person's movement outside the country, when that person is a suspect and there is an apprehension that they may not join the investigation at a later stage. The subject of an LOC can challenge the circular and get relief from a court.

Statements 3 and 4 are not correct :An LOC can be initiated by a large number of authorised officers, including an officer not below the rank of deputy secretary, an officer not below the rank of joint secretary in the state government, a district magistrate or superintendent of police, designated officers of various law enforcing and security agencies, a designated officer of Interpol, an officer not below the rank of additional director in the Serious Fraud Investigation Office, and the Ministry of Corporate Affairs

- In 2018, the government also empowered the heads of public sector banks to directly request the authorities to issue an LOC against wilful defaulters to prevent them from leaving the country.
 - So now, an officer not below the rank of chairman/managing director/chief executive of any public sector bank can make a request.
- An LOC can be modified/deleted/withdrawn by the Bureau of Immigration only on the specific request of the authorised originator on whose request the LOC was issued.

[SOL] The Supreme Court has suo motu opened a review of the process by which courts award the death penalty.

Statements 1 and 2 are correct: Death penalty or capital punishment is the highest degree of punishment that can be awarded to an individual under any penal law in force in any part of the world.

- Capital punishment in India is a legal penalty for some crimes under the country's main substantive penal legislation, the Indian Penal Code, as well as other laws.
 - Executions are carried out by hanging.
- There must be a very high degree of fairness in a system that is interested in subjecting individuals to the experience of death row, and ultimately taking lives through the instrumentality of law.
- After 1947, India became a democratic state, and the system of awarding death penalties too changed drastically.
 - The Indian Penal Code in accordance with the provisions enshrined in the Constitution of India provided for awarding of capital punishment for certain specific offences.
- Article 21 of the Constitution: which guarantees to every citizen the fundamental right to life, also expressly states, "no person shall be deprived of his life or personal liberty except according to procedure established by law."

[SOL] Option d is correct: Exercise Mitra Shakti, based on counter insurgency and counter terrorism operations in semi urban terrain is the largest bilateral exercise being undertaken by the Sri Lankan Army and it forms a major part of India and Sri Lanka's growing defence partnership.

[SOL] In Context: Facial Recognition System (FRS) will be implemented in a phased manner.

Statement 1 is correct: Facial recognition System is part of the Digi Yatra initiative of the government for providing passengers seamless and hassle-free experience at airports. It is to be implemented in a phased manner.

Statement 2 is correct: Variations of illuminations could reduce the efficiency of FRS. For moderate levels of lighting of the background, face detection and recognition are much difficult to perform. Variation in illumination can vary the total magnitude of light intensity being reflected back from an object. [SOL] A standing committee of Parliament has criticized the functioning of the development programme for denotified, nomadic and semi-nomadic tribes.

Option d is correct: The Renke commission aims to identify Denotified Tribes (DNTs).

- These are communities who are the most vulnerable and deprived.
- Denotified tribes (DNTs) are communities that were 'notified' as being 'born criminal' during the British regime under a series of laws starting with the Criminal Tribes Act of 1871.
 - Nomadic and Semi-nomadic communities are defined as those who move from one place to another rather than living at one place all the time.
- Historically, Nomadic Tribes and De-notified Tribes never had access to private land or home ownership.
- While most DNTs are spread across the Scheduled Castes (SC), Scheduled Tribes (ST) and Other Backward Classes (OBC) categories, some DNTs are not covered in any of the SC, ST or OBC categories.
- Many commissions and committees constituted since Independence have referred to the problems of these communities.
 - These include the Criminal Tribes Inquiry Committee, 1947 constituted in the United Provinces.
 - Ananthasayanam Ayyangar Committee in 1949 (based on the report of this committee the Criminal Tribes Act was repealed).
 - Kaka Kalelkar Commission (also called first OBC Commission) constituted in 1953.

- In 1965, an Advisory Committee constituted for revision of the SC and ST list under the chairmanship of B N Lokur referred to denotified tribes.
- The B P Mandal Commission constituted in 1980 also made some recommendations on the issue.

[SOL] More than 300 bodies have been found in a Kyiv suburb called Bucha. The discoveries have drawn comparisons with the killings of civilians in this area during World War II.

- Ukraine is located in eastern Europe.

Statements 2,3 and 4 are correct : Electoral Bonds Scheme Introduced with the Finance Bill, 2017, the Electoral Bond Scheme was notified on January 29, 2018.

- Electoral bonds is an instrument through which anyone can donate money to political parties
- It is like a promissory note that may be purchased by a person who is a citizen of India or incorporated or established in India.
- The bonds are like banknotes that are payable to the bearer on demand and are interest-free
- Any party that is registered under section 29A of the Representation of the Peoples Act, 1951 (43 of 1951) and has secured at least one per cent of the votes polled in the most recent General elections or Assembly elections is eligible to receive electoral bonds.
- The electoral bonds will not bear the name of the donor. Thus, the political party might not be aware of the donor's identity.
- The State Bank of India (SBI) has been authorised to issue and encash Electoral Bonds through its 29 Authorised Branches.
- The bonds are sold by the SBI in denominations of Rs 1,000, Rs 10,000, Rs 1 lakh, Rs 10 lakh and Rs 1 crore.
- One can purchase these bonds only digitally or through cheques.
- Electoral Bonds shall be valid for fifteen calendar days from the date of issue and no payment is being made to any payee Political Party if the Electoral Bond is deposited after expiry of the validity period.

[SOL] In News: Recently, Asian Development Outlook (ADO) 2022 was released .

The Asian Development Bank (ADB) envisions a prosperous, inclusive, resilient, and sustainable Asia and the Pacific, while sustaining its efforts to eradicate extreme poverty in the region. Despite the region's many successes, it remains home to a large share of the world's poor: 263 million living on less than \$1.90 a day and 1.1 billion on less than \$3.20 a day.ADB assists its members, and partners, by providing loans, technical assistance, grants, and equity investments to promote social and economic development.

[SOL] The Haryana Assembly has passed a resolution seeking completion of the Sutlej Yamuna Link Canal (SYL) Canal, bringing back into focus the contentious issue of sharing of river waters between Haryana and Punjab.

- History: In 1982, then Prime Minister Indira Gandhi launched the construction of the SYL Canal with a groundbreaking ceremony in Kapoori village in Patiala district.
 - $\circ~$ The issue dates back to 1966 at the time of reorganization of Punjab and formation of Haryana.
 - Punjab was opposed to sharing the waters of the two rivers with Haryana, citing riparian principles.
- A stretch of 214 km was to be constructed, out of which 122 km was to cross Punjab and 92 km in Haryana.
 - But the Akalis launched an agitation in the form of Kapoori Morcha against the construction of the canal.
- In July 1985, Prime Minister Rajiv Gandhi and then Akali Dal chief signed an accord agreeing for a new tribunal to assess the water.
- Significance of the Canal: The canal once completed will enable sharing of the waters of the rivers Ravi and Beas between the two states.
- Water is a state subject as per entry 17 of State List with respect to water supplies, irrigation and canals, drainage and embankments, water storage and water power, subject to the provisions of Entry 56 of List 1."
- Entry 56 of Union List gives power to the Union Government for regulation and development of inter-State rivers and river valleys.

[SOL] The Reserve Bank said it has decided not to activate the countercyclical capital buffer at this point in time as it is not required.

Option d is correct: The RBI had proposed the CCCB for Indian banks in 2015 as part of its Basel-III requirements; it hasn't actually required the CCCB to be maintained, keeping the ratio at zero percent ever since.

- This is based on the RBI's review of the credit-GDP gap, the growth in GNPA, the industry outlook assessment index, interest coverage ratio and other indicators, as part of the first monetary policy of every financial year.
- Following Basel-III norms, central banks specify certain capital adequacy norms for banks in a country.

- The CCCB is a part of such norms and is calculated as a fixed percentage of a bank's risk-weighted loan book.
- The CCCB is supposed to be in the form of equity capital, and if the minimum buffer requirements are breached, capital distribution constraints such as limits on dividends and share buybacks can be imposed on the bank.
- It requires banks to build up a buffer of capital in good times, which may be used to maintain the flow of credit to the real sector in difficult times.
- It achieves the broader macro prudential goal of restricting the banking sector from indiscriminate lending in periods of excess credit growth that have often been associated with the building up of system-wide risk.

Option d is correct: The Five Eyes is an intelligence-sharing alliance consisting of:

- This is the first time the Centre will give oil palm farmers a price assurance, with industry mandated to pay the viability gap funding of 14.3% of crude palm oil prices.
- The proposed scheme will subsume the current National Food Security Mission-Oil Palm programme.

- Pangshura tentoria is included in CITES Appendix II, allowing international commercial trade in the species, provided such trade is not detrimental to the species, and subject to national trade legislation
- The Indian tent turtle is listed in Schedule –I of the Wild Life (Protection) Act, 1972 and is thereby provided the highest degree of protection.

Statement 3 is not correct :The IUCN Red List of Threatened Species classifies it as Least Concern.

[SOL] Attempts are being made to popularise Ganoderma lucidum mushroom(fungus) for business and livelihood, by cultivating it on wood logs and sawdust.

• It is a medicinal mushroom in use for centuries to heal diseases like diabetes, cancer, inflammation, ulcer as well as bacterial and skin infections.

- In India, however, the potential of the fungus is still being explored.
- The history of consumption of this mushroom can be traced back to 5,000 years ago in China.
- It also finds mention in the historical and medical records of countries like Japan, Korea, Malaysia and India.
- It thrives well in warm and humid climates, and grows preferably in mixed forests of subtropical to temperate regions.

[SOL] Statement 2 and 3 are correct: Adjournment motion is regarded as an extraordinary device because it interrupts the normal business of the House and needs the support of 50 members to be admitted in the Parliament. It is adopted to draw the attention of the House to a recent matter of urgent public importance having serious consequences. As it involves the element of censure against the government hence Rajya Sabha is not allowed to make use of this option. A no-confidence motion demonstrates to the head of state that the elected Parliament no longer has confidence in the government. In India, the Council of Ministers is collectively responsible to Lok Sabha and it remains in office till it enjoys the confidence of majority of the members in the Lok Sabha. Thus, a motion of no-confidence is moved to remove the council of ministers and oust the government from office.

[SOL] Scientists at Pune's Indian Council of Medical Research – National Institute of Virology were able to detect the presence of IgG antibodies against Nipah virus infection (NiV) in 51 bats that were captured from Karnataka, Kerala, Tamil Nadu and Puducherry.

Statements 1,2 and 4 are correct : Nipah virus (NiV) is a zoonotic virus (it is transmitted from animals to humans) and can also be transmitted through contaminated food or directly between people.Fruit bats of the Pteropodidae family are the natural host of Nipah virus.Nipah virus was first recognized in 1999 during an outbreak among pig farmers in, Malaysia. No new outbreaks have been reported in Malaysia since 1999.

- There are currently no drugs or vaccines specific for Nipah virus infection although WHO has identified Nipah as a priority disease for the WHO Research and Development Blueprint.
- Intensive supportive care is recommended to treat severe respiratory and neurologic complications.

Statement 3 is not correct : Human-to-human transmission of Nipah virus has also been reported among family and caregivers of infected patients.

[SOL] Statement 1 is correct: The 11th BRICS Summit took place from 13th-14th November 2019 in Brasilia, Brazil. The theme of the 2019 BRICS summit is "Economic Growth for an Innovative Future." BRICS countries adopted the Brasilia Declaration. BRICS is an acronym for the grouping of the world's leading emerging economies, namely Brazil, Russia, India, China

and South Africa. In 2001, the British economist, Jim O'Neill, coined the term BRIC to describe the four emerging economies of Brazil, Russia, India and China.

Statement 2 is not correct: BRICS's New Development Bank and BRICS Contingent Reserve Arrangement agreements signed in Fortaleza in 2014.

Statement 3 is not correct: The BRICS was officially formed in 2006, originally including Brazil, Russia, India and China. Its first summit took place in Russia in 2009.

[SOL] Unveiling the first bi-monthly monetary policy review of the fiscal 2022-23 the Monetary Policy Committee of the RBI decided unanimously to leave the key policy rate unchanged and to remain accommodative.

Statement 1 and 2 are correct: It is a new tool for absorbing liquidity at an interest rate of 3.75 per cent, making the reverse repo almost irrelevant.

- The SDF will replace the fixed rate reverse repo (FRRR) as the floor of the LAF (liquidity adjustment facility) corridor.
- In 2018, the amended Section 17 of the RBI Act empowered the central bank to introduce the SDF as an additional tool for absorbing liquidity without any collateral.
- By removing the binding collateral constraint on the RBI, the SDF strengthens the operating framework of monetary policy.
- The SDF is also a financial stability tool in addition to its role in liquidity management.
- The SDF rate will be 25 bps below the policy rate (Repo rate), and it will be applicable to overnight deposits at this stage.

[SOL] The Supreme Court upheld amendments introducing restrictions in the Foreign Contribution Regulation Act (FCRA) while holding that no one has a fundamental or absolute right to receive foreign contributions.

Both the statements are not correct: State Bank of India's New Delhi branch: A new provision that makes it mandatory for all NGOs to receive foreign funds in a designated bank account at the State Bank of India's New Delhi branch was inserted.

- Designated FCRA account: All NGOs seeking foreign donations have to open a designated FCRA account at the SBI branch.
 - The NGOs can retain their existing FCRA account in any other bank but it will have to be mandatorily linked to the SBI branch in New Delhi.
- Only banking channels allowed: Foreign contribution has to be received only through banking channels and it has to be accounted for in the manner prescribed.

- OCI or PIO: Donations given in Indian rupees by any foreign source including foreigners of Indian origin like OCI or PIO cardholders" should also be treated as foreign contribution.
- Sovereignty and integrity: It requires NGOs to give an undertaking that the acceptance of foreign funds is not likely to prejudicially affect the sovereignty and integrity of India or impact friendly relations with any foreign state and does not disrupt communal harmony.

- He and his wife, Savitribai Phule, were pioneers of women's education in India.
 - He started his first school for girls in 1848 in Pune at Tatyasaheb Bhide's residence (Bhidewada).
- He, along with his followers, formed the Satyashodhak Samaj (Society of Truth Seekers) to attain equal rights for people from exploited castes.
 - People from all religions and castes could become a part of this association which worked for the upliftment of the oppressed classes
- He is regarded as an important figure in the social reform movement in Maharashtra. He was bestowed with the honorific Mahatma title by Maharashtrian social activist Vithalrao Krishnaji Vandekar in 1888.
- He was also a reputed author. His well-known books include Gulamgiri (Slavery) and Shetkarayacha Aasud (Cultivator's Whipcord).

[SOL] Recently, the Vice-President of India presented the Sangeet Natak Akademi Awards for the year 2018 and National Awards of Lalit Kala Akademi for the year 2021. - The composition of this basket of currencies is reviewed every five years wherein the weightage of currencies sometimes get altered.
- SDR can be freely exchanged between the member countries instead of relying on the currency of any one particular country.

 - These top 5 sectors include: Roads (27%) followed by Railways (25%), Power (15%), oil & gas pipelines (8%) and Telecom (6%).
- In terms of annual phasing by value, 15% of assets with an indicative value of Rs 0.88 lakh crore are envisaged to be rolled out in the current financial year (FY 2021-22).

[SOL] The tenure of the current President of India is set to end in July 2022.

- The President is elected by an Electoral College, which consists of the elected members of both Houses of Parliament and the elected members of the Legislative Assemblies of all the States and also of NCT of Delhi and the Union Territory of Puducherry

- The East Asia Summit also discussed cooperation in other areas and emerging issues such as food security, trade and economics, maritime security and cooperation, and traditional and non-traditional security issues.

The sharing ratio for the State components will be in the ratio of 60:40 except NE and Hilly States where Central and State Ratio will be 90:10.
- This scheme will extend to all States and UTs of the country and will also include institutions of rural local government in non-Part IX areas, where Panchayats do not exist.

- Oil bonds were issued by several governments in the past.
- Oil bonds are issued by the government to compensate OMCs to offset losses that they suffer to shield consumers from rising crude prices.

Statement 3 is not correct :These bonds do not qualify as statutory liquidity ratio securities, making them less liquid when compared to other government securities.

- National Cyber Security Strategy was Conceptualised by the Data Security Council of India (DSCI) .To implement cybersecurity in the above-listed focus areas, the report lists the following recommendations:
 - A minimum allocation of 0.25% of the annual budget, which can be raised upto 1% has been recommended to be set aside for cyber security(Statement 1 is not correct :)
 - Furthermore, a national framework should be set in collaboration with institutions like National Skill Development Corporation (NSDC) and ISEA (Information Security Education and Awareness) to provide global professional certifications in security. DSCI further recommends creating a 'cyber security services' with cadres chosen from the Indian Engineering Services.(Statement 2 is correct)
 - Cyber diplomacy plays a huge role in shaping India's global relations.
 - The report recommends unburdening the judicial system by creating laws to resolve spamming and fake news.
 - It also suggests charting a 5-year roadmap factoring possible technology transformation, setting up exclusive courts to deal with cybercrimes and removing backlog of cybercrimes by increasing centres providing opinion related to digital evidence under section 79A of IT act.(Statement 3 is correct)

- Haemophilia A It is a more common type of haemophilia. It is due to deficiency of clotting factor VIII (factor eight).

- It is caused by a mutation or change, in one of the genes, that provides instructions for making the clotting factor proteins needed to form a blood clot.
- This change or mutation can prevent the clotting protein from working properly or to be missing altogether. These genes are located on the X chromosome

 - Significance
 - Nidhi companies are very popular in South India and are key players in the financial system as they mobilise funds from their members and give loans to them at a lower interest than commercial banks.
 - No Loan to companies
 - $\circ~$ Only individual members are allowed in Nidhi companies and it cannot give loans to companies.

- Under the centralised procurement system, the procurement of foodgrains in Central Pool is undertaken either by FCI directly or by State Govt. Agencies (SGA).
 - Central pool refers to stocks procured through MSP operations for welfare schemes and calamity relief.
 - Quantity procured by SGAs is handed over to FCI for storage and subsequent issue against GoI (Government of India) allocations in the same State or movement of surplus stocks to other States.
 - The cost of the foodgrains procured by State agencies is reimbursed by FCI as per Provisional per cost-sheet issued by GOI as soon as the stocks are delivered to FCI.
- Under the decentralised procurement system, state governments or their agencies procure, store, and distribute against the GoI's allocation for the targeted public distribution system and other welfare schemes (OWS) rice, wheat, or coarse grains in the state.

[SOL] The government is considering a regulatory framework for special purpose acquisition companies (SPACs) to lay the ground for the possible listing of Indian companies through this route in the future.

All the statements are correct: A special purpose acquisition company (SPAC) is a company that has no commercial operations and is formed strictly to raise capital through an initial public offering (IPO) or the purpose of acquiring or merging with an existing company. They are also known as "blank check companies". The aim of this SPAC is to raise money in an initial public offering (IPO), and at this point in time, it does not have any operations or revenues. Investors in SPACs can range from well-known private equity funds and celebrities to the general public. Once the money is raised from the public, it is kept in an escrow account, which can be accessed while making the acquisition. If the acquisition is not made within two years of the IPO, the SPAC is delisted and the money is returned to the investors.

Regulation in India: the Indian regulatory framework does not allow the creation of blank cheque companies. The Companies Act, 2013 stipulates that the Registrar of Companies can strike off a company if it does not commence operations within a year of incorporation.

[SOL] Statement 1 is not correct: MGNREGA aims to enhance livelihood security in rural areas by providing at least 100 days of guaranteed wage employment in a financial year to every household whose adult members volunteer to do unskilled manual work.

Panchayati Raj in India

- Panchayat raj is the oldest system of local government.
- The word 'Panchayat' is an amalgamation of two words where 'Panch' means 'five' and 'Ayat' means 'assembly' and 'Raj' means 'rule'.
 - Rajasthan was the first state in the country where the Panchayati Raj system was implemented. It was inaugurated by the then Prime Minister Pandit Jawaharlal Nehru on 2nd October 1959 at Nagaur district.

Genesis

- Balwant Rai Mehta Committee, 1957: Suggested a three-tier Panchayati Raj system of Gram Panchayats at the village level, Panchayat Samiti at the block level and Zilla Parishad at the district level.
- Ashok Mehta Committee, 1977: Incorporated novel thinking in the concepts and practice of the Panchayat Raj and recommended a two-tier Panchayat Raj structure consisting of Zilla Parishad and Mandal Panchayat.
- G V K Rao Committee, 1985: Recommended making the district as the basic unit of planning and holding regular elections.

- L M Singhvi Committee, 1986: Recommended providing more financial resources and constitutional status to the panchayats to strengthen them.

- 1991: P V Narashima Rao's government introduced a bill for this purpose in Lok Sabha in September and the bill finally emerged in 1992 and got enforced in 1993.

[SOL] Recently ,Japan's Diplomatic Bluebook for 2022 described the Kuril Islands as being under Russia's "illegal occupation".

Statements 1 and 2 are not correct : Kuril Islands are a set of four islands situated between the Sea of Okhotsk and the Pacific Ocean near the north of Japan's northernmost prefecture, Hokkaido.

- Both Moscow and Tokyo claim sovereignty over them though the islands have been under Russian control since the end of World War II.
 - The Soviet Union had seized the islands at the end of World War II and by 1949 had expelled its Japanese residents.
- Tokyo claims that the disputed islands have been part of Japan since the early 19th century.
- Since 1991, there have been many attempts to resolve the dispute and sign a peace treaty.

[SOL] Maha Harathi and other special rituals marked the grand finale of the 12-day Pranahita river festival.

• The mega river festival is dedicated to worshipping the Pranahita.

Statement 1 and 2 are correct : Pranahita is a perennial river that provides sufficient water and food for wild creatures.

- It is a tributary of river Godavari and flows through Pranahita Wildlife Sanctuary.

[SOL] Statement 1 is correct: Prime Minister Narendra Modi announced the launch of the National Digital Health Mission on August 15, 2020, during his speech on India's 74th Independence Day. With the launch of the historic mission, every Indian will soon have a digital health account. Under the National Digital Health Mission, every Indian will get a Health ID card that will work as a health account comprising information regarding the person's past medical conditions, treatment and diagnosis.

Statement 2 is not correct: National Health Authority (NHA) is leading the implementation of the National Digital Health Mission (NDHM) in coordination with different ministries/departments of the Government of India, State Governments, and private sector/civil society organizations. The NHA is governed by a Governing Board chaired by the Union Minister for Health and Family Welfare, Government of India.

[SOL] In News : The risk for developing Guillain-Barré syndrome after receipt of a COVID-19 vaccine is small, but higher with the Johnson & Johnson shot.

Statements 1 and 3 are correct :Guillain-Barré syndrome (GBS) is a rare condition in which a person's immune system attacks the peripheral nerves.

- The syndrome can affect the nerves that control muscle movement as well as those that transmit pain, temperature and touch sensations.
 - This can result in muscle weakness and loss of sensation in the legs and/or arms.
- It is more common in adults and in males, people of all ages can be affected.

Statement 2 is not correct :

• Guillain-Barré syndrome is often preceded by an infection. This could be a bacterial or viral infection. Guillain-Barré syndrome may also be triggered by vaccine administration or surgery.

[SOL]: Recently ,the Ministry of Home Affairs (MHA) released the annual report for the Citizenship Amendment Act (CAA) .

Statement 1 is not correct : The Citizenship (Amendment) Act, 2019 (CAA) is an act that was passed in the Parliament on December 11, 2019.

- The 2019 CAA amended the Citizenship Act of 1955 allowing Indian citizenship for Hindu, Sikh, Buddhist, Jain, Parsi, and Christian religious minorities who fled from the neighboring Muslim majority countries of Pakistan, Bangladesh and Afghanistan before December 2014 due to "religious persecution or fear of religious persecution".
 - However, the Act excludes Muslims.

Statement 2 is correct :The Citizenship (Amendment) Act does not apply to tribal areas of Tripura, Mizoram, Assam and Meghalaya because of being included in the Sixth Schedule of the Constitution.

• Established

- In March 2020
- It has been registered as a Public Charitable Trust.
- Objective
 - To undertake and support relief or assistance of any kind relating to a public health emergency or any other kind of emergency, calamity or distress, either man-made or natural, including the creation or upgradation of healthcare or pharmaceutical facilities, other necessary infrastructure, funding relevant research or any other type of support.
 - To render financial assistance, provide grants of payments of money or take such other steps as may be deemed necessary by the Board of Trustees to the affected population.
 - To undertake any other activity, this is not inconsistent with the above Objects.
- Composition
 - Prime Minister is the ex-officio Chairman of the PM CARES Fund and Minister of Defence, Minister of Home Affairs and Minister of Finance, Government of India are ex-officio Trustees of the Fund.
 - The Chairperson of the Board of Trustees shall have the power to nominate three trustees to the Board of Trustees who shall be eminent persons in the field of research, health, science, social work, law, public administration and philanthropy.
 - Any person appointed a Trustee shall act in a pro bono capacity.
- Funding
 - The fund consists entirely of voluntary contributions from individuals/organisations and does not get any budgetary support.
- Exemptions
 - Donations to PM CARES Fund would qualify for 80G benefits for 100% exemption under the Income Tax Act, 1961.
 - Donations to PM CARES Fund will also qualify to be counted as Corporate Social Responsibility (CSR) expenditure under the Companies Act, 2013
 - PM CARES Fund has also got exemption under the FCRA and a separate account for receiving foreign donations has been opened.

- Registration
 - The trust deed of PM CARES Fund has been registered under the Registration Act, 1908.

[SOL] Recently, the United States Commission on International Religious Freedom (USCIRF) recommended that India be designated a 'Country of Particular Concern' (CPC).

Statement 1 is not correct: The Indian constitution's Preamble was amended in 42nd Constitutional Amendment, 1976 to state that India is a secular state.

Statement 2 is correct: The freedom of religion guaranteed under the Indian Constitution is not confined to its citizens but extends to all persons including an alien.

[SOL] Recently, the Cabinet Committee on Economic Affairs approved the continuation of lending under the PM SVANidhi beyond March 2022 till December 2024.

Statement 1 and 2 are correct : PM SVANidhi is a Central Sector Scheme .

- It is fully funded by Ministry of Housing and Urban Affairs with the following objectives:
 - \circ To facilitate working capital loan up to 10,000 at subsidized rate of interest
 - To incentivize regular repayment of loan
 - To reward digital transactions
- It aims to focus on enhanced collateral free affordable loan corpus, increased adoption of digital transactions and holistic socio-economic development of the Street Vendors and their families.
- The scheme will help formalize the street vendors with above objectives and will open up new opportunities to this sector to move up the economic ladder.

Statement 3 is not correct : The Scheme is available for beneficiaries belonging to only those States/UTs which have notified Rules and Scheme under Street Vendors (Protection of Livelihood and Regulation of Street Vending) Act, 2014.

- Beneficiaries from Meghalaya, which has its own State Street Vendors Act may, however, participate.
- 117. [ANS] d

[SOL] The Indian Space Research Organisation (ISRO) is hoping to have all three development flights planned for its 'baby rocket' — the Small Satellite Launch Vehicle (SSLV) — in 2022 itself.

Statements 1,2 and 3 are correct : Small Satellite Launch Vehicle (SSLV) is a 3 stage Launch Vehicle configured with three Solid Propulsion Stages and liquid propulsion based Velocity Trimming Module (VTM) as a terminal stage.

- All three stages of the SSLV will be solid propulsion stages.
- The SSLV can carry satellites weighing a maximum 500 kg to low orbit, while the PSLV can launch satellites weighing above 1000 kg.
- The key features of SSLV
 - Low cost, with low turn-around time, flexibility in accommodating multiple satellites, Launch on demand feasibility, minimal launch infrastructure requirements, etc.

[SOL] The Union government plans to revamp the Civil Registration System (CRS) to enable real-time recording of birth and deaths, the annual report of the Home Ministry mentioned.

- History: The history of the Civil Registration System (CRS) in India dates back to the middle of the 19th century.
 - In 1886 a Central Births, Deaths and Marriages Registration Act was promulgated to provide for voluntary registration throughout British India.
- Post-independence: The Registration of Births and Death Act (RBD Act) was enacted in 1969 to promote uniformity and comparability in the registration of Births and Deaths across the country and compilation of vital statistics based thereon.
 - With the enactment of the Act, registration of births, deaths and stillbirths has become mandatory in India.
- Registration: The Registrar General, India (RGI) at the Central Government level coordinates and unifies the activities of registration throughout the country.
 - However, implementation of the statute is vested with the State Governments.
 - The registration of births and deaths in the country is done by the functionaries appointed by the State Governments.
- Uniform birth and death reporting: The Act mandates the use of uniform birth and death reporting forms and certificates throughout the country.
- 119. [ANS] a

[SOL] Statement 1 is not correct: The Collegium System is not prescribed in the constitution nor in any statute. It came into existence through the 2nd Judges case..

Statement 2 is not correct: The 2nd Judges Case recommended the CJI+ 2 senior most judges but 3rd Judges cases upgraded it to CJI+4 senior most judges.

Statement 3 is correct: National Judicial Appointment Commission Act, 2014 was brought to replace commission. But it was declared unconstitutional by SC.

[SOL] Statement 1 is correct: Kaziranga National Park lies partly in Golaghat District and partly in Nagaon District of Assam. It is the oldest park in Assam covering an area of 430 sq km along the river Brahmaputra on the North and the Karbi Anglong hills on the South.

It is a world heritage site that is famous for the Great Indian one-horned rhinoceros.

- It later became the residence of the descendants of the Nawab of Awadh and has been neglected since the death of the last of the royal family in September 2017.
 - It is said that it came to be known as 'Wilayat Mahal' after Begum Wilayat Mahal of Awadh, who claimed that she was a member of the royal family of Oudh.
 - She was given the palace by the government in 1985.
- The monument is not ASI-protected and, therefore, no attention was paid to it in all these years in order to conserve it.

Statement 2 is correct : Malcha Mahal is located in Delhi.

[SOL] Women in Chhattisgarh recreate the 'Chipko movement' to save Hasdeo Aranya forest.

Statements 1 and 3 are correct : Chipko Movement/Andolan was a forest conservation movement in India. It created a precedent for starting non-violent protest in India. It was a movement that practised methods of Satyagraha where both male and female activists from Uttarakhand played vital roles, including Gaura Devi, Suraksha Devi, Sudesha Devi, Bachni Devi and Chandi Prasad Bhatt, Virushka Devi and others. The support for the movement came mainly from the womenfolk. Today, beyond the eco-socialism hue, it is being seen increasingly as an ecofeminism movement. Although many of its leaders were men, women were not only its backbone, but also its mainstay. Statement 2 is not correct : Chipko movement began in 1973 in Uttarakhand, then a part of Uttar Pradesh (at the foothills of Himalayas) and went on to become a rallying point for many future environmental movements all over the world.

[SOL] The Uttarakhand administration imposed Section 144 CrPC in Roorkee to prohibit assembly of more than four persons in a Dharam Sansad.

Statement 1 is not correct: Section 144 CrPC gives power to a district magistrate, a sub-divisional magistrate or any other executive magistrate empowered by the state government to issue orders so as to prevent any untoward incident related to law and order situation.

Statement 2 is not correct: The order remains in force for not more than two months. The state government can extend the same by another two months subject to a maximum six months period. The state government can withdraw the order at any point of time if it feels that the situation has come back to normalcy.

[SOL] Recently, the seventh edition of the Raisina Dialoge was held in New Delhi.

Statement 1 is not correct: The Raisina Dialogue is India's premier foreign policy conference on geopolitics and geoeconomics committed to addressing the most challenging issues facing the global community. The first session was held in 2016. It brings together leaders from the global strategic and policy-making community to discuss key geopolitical developments and strategic issues facing the world.

Statement 2 is not correct: It is organized on the lines of the Shangri La Dialogue which takes place annually in Singapore and is co-hosted by the Ministry of External Affairs (MEA) and the Observer Research Foundation (ORF).

[SOL] Recently, the Indian Computer Emergency Response Team (CERT-In) has issued new guidelines for cyber incidents.

Statement 1 is correct: CERT-In is the national nodal agency for responding to computer security incidents as and when they occur.

Statement 2 is not correct: CERT-In is empowered under Section 70B of the Information Technology Act to collect, analyse and disseminate information on cyber security incidents.

[SOL] The Democratic Republic of the Congo (DRC) has reported a fresh outbreak of Ebola virus disease (EVD).

Statement 1 is correct: Ebola virus disease (EVD), formerly known as Ebola haemorrhagic fever, is a rare but severe, often fatal illness in humans.

- It is thought that fruit bats of the Pteropodidae family are natural Ebola virus hosts.
- Supportive care rehydration with oral or intravenous fluids and treatment of specific symptoms improve survival.

Statements 2 and 3 are not correct: The virus is transmitted to people from wild animals and spreads in the human population through human-to-human transmission

• EVD first appeared in 1976 in 2 simultaneous outbreaks, one in what is now Nzara, South Sudan, and the other in Yambuku, DRC. The latter occurred in a village near the Ebola River, from which the disease takes its name.

127. [ANS] b

[SOL] The Office of Economic Adviser, Department for Promotion of Industry and Internal Trade released the Index of Eight Core Industries (ICI) for the Month of March, 2022. (Statement 1 is not correct)

Statement 2 and 3 are correct : CI measures combined and individual performance of production in selected eight core industries viz. Coal, Crude Oil, Natural Gas, Refinery Products, Fertilisers, Steel, Cement and Electricity.

- The Eight Core Industries comprise 40.27 percent of the weight of items included in the Index of Industrial Production (IIP).
- The base year of the index has been revised to 2011-12 from 2004-05 in alignment with the new series of IIP.

[SOL] Indonesia has decided that it will be banning the exports of palm oil to give relief to domestic shortage in wake of rising oil prices.

Option b is correct: NMEO-OP is a Centrally Sponsored Scheme aimed at increasing area and productivity under Oilseeds and Oil Palm. It subsumed the erstwhile National Food Security Mission-Oil Palm Scheme of the Central government. It aims to increase the area under oil palm cultivation to 10 lakh hectares by 2025-26 and 16.7 lakh hectares by 2029-30. Under the scheme, farmers will be provided financial assistance and will get remuneration under the viability formula. The Viability Formula is an MSP like mechanism and the government will decide the price level.

[SOL] The Centre will soon accord the Hatti community of Himachal Pradesh in the list of Scheduled Tribes (ST).

Option B is correct:

• Location

- Hatti community is of the Trans-Giri region of Himachal Pradesh.
- They share social as well as cultural similarities with the Jaunsar community of the Jaunsar-Bawar area of Uttarakhand.
- This is because the Trans-Giri area and Jaunsar Bawar area, were part of the erstwhile Sirmaur princely state.
- It is cut off from Sirmaur by two rivers called Giri and Tons.
- Haat
 - The community is named after their age-old professional practice of selling their home grown crops at small markets called 'Haat' in nearby cities.
- Economy
 - The members of this community haven't been mainstreamed and most are dependent on animal rearing and agriculture.
- Khumbli (Governance)
 - They even still follow the Khumbli the traditional council despite the establishment of the panchayat system.
- Demand for ST status
 - For the past 55 years, the Hatti community has been demanding for inclusion in the ST list.
 - Granting the ST status would ensure that people come into the mainstream and ensure a special budget for the area's overall development.
 - The move will benefit a population of about 3 lakh people in 154 panchayats in the trans-Giri area in the state.
- 130. [ANS] d

[SOL] Recently, Madras High Court stated that Mother Nature is a 'living being' with legal entity.

All the statements are correct: Legal Status has been accorded to the following:

- In 2018, a High Court bench had accorded the status of "legal person or entity" to animals in Haryana.
- Uttarakhand high court, in 2017, declared the Ganga and Yamuna as living entities, a verdict that was later stayed by the Supreme Court.
- In June 2019, the Punjab and Haryana High Court had ruled that all animals, birds and aquatic life in Haryana would be accorded the status of legal persons or entities.

• In 2020, Sukhna Lake was declared a legal entity for its survival, preservation and conservation.
