History of 6th June

- ♦ 1674: Shivaji Maharaj was crowned in the Raigarh fort and also assumed the title of Chhatrapati.
- ♦ 2005 : India and Pakistan agreed on the Iran Gas Pipeline Plan.
- ◆ 1981 : A train fell into the Baghmati River in Bihar, killing about 800 of the 1000 people on board.
- 1997: Bangkok formed an economic cooperation group called BISTEC with India, Bangladesh, Sri Lanka and Thailand.

Current Affairs Related to 6th June 2024

- Bengaluru-based Canara Bank has given approval to its subsidiary, Canara HSBC Life Insurance Company, to commence the process through an initial public offering at an interest rate of 14.50%. The move is subject to the approval of the Reserve Bank of India and the Department of Financial Services. Currently Canara Bank Life Insurance Company has 51% majority followers, while HSBC Insurance has 26% followers, and Punjab National Bank has the remaining 23% followers.
- ♦ Sweden has announced the donation of two Sub Airborne Surveillance and Control 890s in a significant step to strengthen Ukraine's defense against Russia. This radar surveillance aircraft will play a key role in Ukraine's long-range detection and support the integration of the F-16 fighter aircraft inventory provided by other Western countries. Sweden's contribution is considered an important part of a \$1.3 billion commercial aid package aimed at strengthening Ukraine's combat capability.
- The Insurance Regulatory and Development Authority of India has approved the appointment of Sandeep Batra as the Chairman of the Board of Directors of ICICI Prudential Life Insurance Company. The company has announced this development. Batra's appointment as Chairman of the ICICI Prudential Board will be effective from June 30, 2024. He currently serves as an Executive Director on the Board of ICICI Bank since July 2018, overseeing the Corporate Centre.
- The Asian Development Bank has given a sovereign loan of \$ 2.6 billion to India in the calendar year 2023. The loans supported by ADB in 2023 will be used to finance urban development projects, boost the power sector, support the development of industrial chains, support horticulture, enhance the environment, and strengthen India's climate resilience.

- The latest report by CRISIL Ratings predicts a deceleration in bank credit growth to 14% for FY2025, which represents a decline of 200 basis points from 16% growth for FY2024. The slowdown is being attributed to various factors, including higher base effect, revision in risk weights and slightly slowing growth.
- Tata Consultancy Services has entered into an India Partnership with the Indian Institute of Technology Bombay to develop India's first quantum diamond microchip imager. This advanced communications device aims to revolutionize the testing of semiconductor chips, reduce failures, and increase the energy efficiency of electronic equipment. Over the next two years, TCS expert Dr. Bombay worked as an Associate Professor in the Department of Electric Engineering. Will collaborate with Kasturi Saha.
- Reliance Industries Limited and Tata Group, India's two leading commercial conglomerates, have been named among the world's 100 most influential companies. This recognition highlights his global influence and importance. Reliance Industries Limited has been placed in the Titans category of Time Profit's list, acknowledging its position as a titan of Indian industry.
 - France has elected Dr. Emmanuel Souberon as the World Organization for Animal Health's head for the term 2024-2029. He was elected to this post at the World Assembly held in Paris and thanked all the member countries and regions for their confidence. Her candidacy fulfilled France's commitment to the organization to promote animal health and welfare.
- The Reserve Bank of India has been asked by Credit Agriculture Society General Deutsche Bank and BNP Paribas to approve the third party origination model. They have demanded that audit oversight be put in place to resolve the impasse between its domestic authorities and Indian policy makers.


6. Which state has recently included artificial intelligence in the school curriculum?
