History of 24 February

- ♦ 1949 : Israel and Egypt sign an armistice agreement.

Current Affairs Related to 24 February

- Verde a malaria-free country. Cape Verde is currently the third country in the African region to be certified malaria free by WHO, along with Mauritius and Algeria. A country is certified by WHO as malaria-free when it demonstrates prevention of malaria transmission throughout the country for at least 3 years and has functional surveillance and monitoring systems to prevent re-introduction of indigenous transmission. There is a feedback system.
- ◆ Dr S Jaishankar co-chaired the 6th India Nigeria Joint Commission meeting with his Nigerian counterpart Yusuf Tuggar. He also addressed the Indian community in Lagos. He spoke to them about India's Covid response, economic recovery, ease of living, space achievements and migrant concerns.
- The Board of Control for Cricket in India will honor exemplary performances in Indian cricket at the Naman Awards ceremony in Hyderabad. Held for the first time since 2019, the prestigious event celebrates the achievements of Indian cricketers over the past year. Representing Gujarat Titans in the Indian Premier League, Gill won the Orange Cap after scoring an astonishing 890 runs in the 2024 edition.
- In an important step towards promoting multilingualism in education, the Central Government has launched an Artificial Intelligence based platform Nidalini App. The initiative aims to make study material available in digital form for all school and higher education courses, exclusively in the languages ??listed in the 8th Schedule of the Indian Constitution. The move is in line with the recommendations of the National Education Policy 2020, which emphasizes the importance of studying in one's mother tongue.

- Union Home Minister Shri Amit Shah released
 Braveheart of Assam Lachit Barphukan in Guwahati,
 highlighting the inspiring story of Lachit's resistance
 against fanaticism and power-hungry elements.
 Underlining the importance of the Battle of Saraighat,
 Mr Shah said that if Lachit had not been victorious,
 Assam might have become a part of Bangladesh.
 He credited Lachit with fending off invasions from
 Khilji to Aurangzeb, protecting Assam, and contributing to the integration of the region with India.
- Two important components in the field of government financial planning are capital budget and revenue budget. While both contribute to the overall fiscal framework, they have different effects on the assets and liabilities of the government. Capital budget includes transactions that directly affect the assets and liabilities of the government. This budget includes both capital receipts and capital expenditure. In contrast, the revenue budget includes those items which do not affect the assets and liabilities of the government.
- Asian Infrastructure Investment Bank has invested Rs 4.86 billion in Sustainable Energy Infra Trust, India's largest renewable energy infrastructure investment trust. Ampz, backed by Mahindra Sustain Pvt Ltd and Ontario Teachers' Pension Plan, boasts eight operational solar power assets across India with a combined capacity of 1.54 GW peak.
- The inaugural flight, operated by Indian Air Force pilots, airlifted 11 passengers from Kargil to Jammu and seven passengers from Jammu to Kargil. This initiative will play an important role in enhancing regional connectivity and promoting economic growth. The AN-32 courier service aims to streamline travel and improve connectivity to Kargil. Dr. Mohammad Jafar Akhoon, Chairman and CEC, Ladakh Autonomous Hill Development Council, welcomed the Indian Air Force pilots for the launch of this important service.




