[SOL] **International North-South Transport Corridor (INSTC):**

- **Origin:**

- The legal framework for the INSTC is provided by a **trilateral agreement** signed by India, Iran and Russia at the **Euro-Asian Conference on Transport** in **2000**. Hence, **statement 1 is not correct**.

- To **reduce the carriage cost** between India and Russia by about 30% and reduce the transit time from 40 days by more than half.

[SOL] **Kessler Syndrome**

- This is an idea proposed by **NASA scientist Donald Kessler** in 1978.
- It states that if there was **too much space junk in orbit**, it could result in a **chain reaction** where more and more objects collide and create new space junk in the process, to the point where Earth's orbit becomes unusable.
 - It is also known as **“collisional cascading”**.
- This cascade of collisions first came to NASA's attention in the 1970s when **derelict Delta rockets** left in orbit began to explode creating shrapnel clouds.
- Kessler proposed it would take 30 to 40 years for such a threshold to be reached and today, some experts think we are already at critical mass in low-Earth orbit at about 560 to 620 miles (900 to 1,000 kilometres).

4. [ANS] d

[SOL] **Statement 1 is not correct:** The Representation of the People Act, 1950 provided for the allocation of seats in and the delimitation of constituencies for the purpose of elections to the Lok Sabha and Legislatures of States. On the other hand, the Representation of the People

Act, 1951, deals with **the actual conduct of elections**, the qualifications and disqualifications of candidates, corrupt practices and other election offences.

Statement 2 is not correct: As per Section 4 of RPA 1951, a person who is a member of Schedule Caste in a particular State **can contest** election from any other State from **a seat reserved** for Scheduled Castes for Lok Sabha (House of People).

5. [ANS] a

[SOL] Statement 1 is correct: The Jute Corporation of India Limited (JCI) was incorporated by the Government of India (GOI) in 1971 as a price support agency with a clear mandate for the procurement of raw jute without any quantitative limit from the growers at the Minimum Support price (MSP) declared in each year by the GOI based on the recommendations made by Commission for Agricultural Cost & Prices (CACP).

Statement 2 is not correct: The Cabinet Committee on Economic Affairs chaired by the Prime Minister has approved reservation norms for mandatory use of jute in packaging for the Jute Year 2021 -22 (1st July 2021 to 30th June 2022). The Mandatory packaging norms approved for Jute Year 2021-22 provide for **100% reservation of the foodgrains** and 20% of sugar to be compulsorily packed in jute bags.

6. [ANS] c

[SOL] Recently, the Weapons Of Mass Destruction (WMD) Bill was passed by voice vote in Rajya Sabha.

India is signatory to both, Biological Weapons Convention of 1972, and Chemical Weapons Convention of 1993, but is **not signatory to the Nuclear Non-proliferation Treaty**, which is another international arrangement to fight the growth of WMDs.

7. [ANS] b

[SOL] Statement 1 is correct: Article 44 of the Indian Constitution defines a Uniform Civil Code. Article 44 says, 'The State shall endeavour to secure for the citizens a Uniform Civil Code throughout the territory of India.' The article is a part of the Directive Principles of State Policy.

Statements 2 and 3 are not correct: Goa has a common family law, thus being the only Indian state to have a uniform civil code and the 1954 Special Marriage Act allows any citizen to marry outside the realm of any special religious personal law. The Law Commission (2018) was against the implementation of the Uniform Civil Code, stating that it is neither necessary nor desirable at this stage.

8. [ANS] d

[SOL] National Legal Services Authority of India (NALSA):

- It was formed in 1995 under the authority of the **Legal Services Authorities Act 1987**.
- Its purpose is to **provide free legal services** to eligible candidates and to **organize Lok Adalats** for the **speedy resolution of cases**.
- **District Legal Services Authorities (DLSAs):**
 - There are a total **676 District Legal Services Authorities (DLSAs)** in the country.
 - DLSAs are **headed by the District Judges** who acts as **Chairman of the authority**. Hence statement 1 is correct.
 - Various **legal aid** and **awareness programmes** are run by NALSA through DLSAs and **State Legal Services Authorities (SLSAs)**.
 - The DLSAs also contribute towards **reducing the burden on courts** by **regulating Lok Adalats** conducted by NALSA. Hence statement 2 is correct.

- DLSAs have been mandated to hold weekly meetings of undertrial review committees (UTRCs) to discuss progress, review additional cases and to discuss further action including filing of bails in high courts and the Supreme Court, if required. **Hence statement 3 is correct.**

9. [ANS] a

[SOL] **Option A is correct.** The Bhagoria festival, also known as the Bhagoria Haat festival, is celebrated by the tribal people (Bhil, Bhilala, Pateliya, etc.) of the Indian states of Madhya Pradesh and Maharashtra. It has an agricultural significance attached to it as it coincides with the end of harvesting of crops. People celebrate it to mark the completion of harvesting. Also, this festival provides an opportunity for thousands of tribal men and women to choose a life partner of their own choice.

10. [ANS] b

[SOL] Recently, as part of reforms to make Regional Rural Banks (RRBs) financially sustainable, the government has asked them to move towards digitisation.

- Statement 1 is not correct: Regional Rural Banks (RRBs) were set up as government-sponsored, regional based rural lending institutions under the Regional Rural Banks Act, 1976. The RRBs were established as per the recommendations of the Narasimham Committee to cater to the rural credit needs of the farming and other rural communities.
- **Statement 2 is correct:** The Prathama Grameen Bank was the first bank to be established on 02nd October 1975. The Syndicate Bank became the first commercial bank to sponsor the Prathama Grameen Bank RRB
- **Statement 3 is not correct:** The equity of the Regional Rural Banks is held by the stakeholders in a fixed proportion. This proportion is 50:35:15, distributed as:
 - Central Government – 50%
 - Sponsor Bank – 35%
 - State Government – 15%

11. [ANS] c

[SOL] Recently, the Parliament passed the **Indian Antarctic Bill, 2022.**

Indian Antarctic Bill, 2022

- **About:**
 - It is the **first domestic legislation** with regard to Antarctica in India.
 - Applicable to **Indian citizens as well as foreign citizens.**
- **Objective:**
 - To demilitarise Antarctica; use of Antarctica for peaceful purposes; promote international scientific cooperation in Antarctica.
 - The Bill seeks to give effect to the **Antarctic Treaty, the Convention on the Conservation of Antarctic Marine Living Resources, and the Protocol on Environmental Protection to the Antarctic Treaty.**
- **Key Features:**
 - Prohibit Indian expedition to Antarctica **without a permit or written authorisation** of another party to Antarctic Treaty.
 - **Extend jurisdiction of Indian courts to Antarctica** and lays out penal provisions for crimes on the continent by Indian citizens, and foreign citizens who are part of Indian expeditions.
 - The act directs the creation of a **fund called the Antarctic fund** that will be used

for protecting the Antarctic environment.

- The Bill also establishes a ‘**Committee on Antarctic Governance and Environmental Protection.**’
- **Prohibits mining, dredging and activities** that threaten the pristine conditions of the continent.

12. [ANS] d

[SOL] **All the statements are correct:** All the statements are not correct. It is an inter-governmental body established in 1989 during the G7 Summit in Paris. It has 37 members currently and India is also a member. Its objectives are to set standards and promote effective

- implementation of legal, regulatory and operational measures for combating money laundering, terrorist financing and other related threats to the integrity of the international financial system. Putting a country in “grey list” does not involve a direct legal or penal action but involves increased scrutiny from watchdogs, regulators and financial institutions. There are only two countries on the FATF's blacklist - North Korea and Iran.

13. [ANS] b

[SOL] **Statement 1 is not correct:** CBI is the main investigation agency of the central government for cases relating to corruption and major criminal probes. It has its origin in Special Police

The establishment was set up in 1941 to probe bribery and corruption during World War II. CBI was set up by a resolution of the Ministry of Home Affairs in 1963 after the Santhanam committee recommendation. Presently it acts as an attached office under DOPT. Although the DSPE Act gives legal power to CBI, CBI is not a statutory body as:

- Word ‘CBI’ is not mentioned in the DSPE act.
- The executive order of MHA did not mention CBI to be constituted under the DSPE Act.

Statement 2 & 3 is correct: It is the nodal agency in India which coordinates investigation on behalf of Interpol Member countries. CBI can suo-moto take up investigation of offences only in the Union Territories. The Central Government can authorize CBI to investigate a crime in a State but only with the consent of the concerned State Government. The Supreme Court and High Courts, however, can order CBI to investigate a crime anywhere in the country without the consent of the State.

14. [ANS] a

[SOL] **Statement 1 is correct:** African swine fever (ASF) is a highly contagious hemorrhagic viral disease of domestic and wild pigs, which is responsible for serious economic and production losses.

Statement 2 is correct: According to the World Organisation for Animal Health, ASF is caused by a large DNA virus of the Asfarviridae family. African swine fever virus is the only virus with a double-stranded DNA genome known to be transmitted by arthropods.

Statement 3 is not correct: As of now, there is no approved vaccine against ASF unlike classical swine fever (‘Hog Cholera’) which is caused by a different virus. Classical Swine Fever (CSF) is one of the most important viral diseases of domestic pigs and wild boar. It is also called Hog Cholera.

15. [ANS] c

[SOL] **Option c is correct:** Convention on International Trade in Endangered Species of Wild Fauna and Flora (CITES) is an international legally binding agreement aimed at ensuring “that international trade in specimens of wild animals and plants does not threaten their survival”. India is a signatory to this convention and has also ratified it in 1976. It has three appendices: Appendix I includes species threatened with extinction. Trade-in specimens of these species are permitted only in exceptional circumstances. Appendix II provides a lower level of protection. Appendix III contains species that are protected in at least one country, which has asked other CITES Parties for assistance in controlling.

16. [ANS] d

[SOL] **In News:** The Reserve Bank of India’s Financial Inclusion Index (FI-Index) has improved to 56.4 in March 2022 vis-à-vis 53.9 in March 2021, with **growth witnessed across all the sub-indices.**

Statement is not correct: Financial inclusion index is published annually in July by the Reserve Bank of India.

Statements 2 and 3 are correct: The RBI developed the composite financial inclusion index to capture the extent of financial inclusion across the country by including details of banking, investments, insurance, postal as well as the pension sector.

- The index comprises three parameters including access, usage and quality.
 - It comprises three broad parameters -- access with 35% weightage, usage with 45% weightage and quality with 20% weightage. It incorporates details of banking, investments, insurance, postal as well as the pension sector.
- The Index is **responsive to ease of access, availability and usage of services, and quality of services.**
- The **index captures information on various aspects** of financial inclusion in a single value ranging between 0 and 100, where 0 represents complete financial exclusion and 100 indicates full financial inclusion.
- The index has been constructed without any base year and reflects cumulative efforts of all stakeholders over the years towards financial inclusion.

17. [ANS] b

[SOL] There isn’t formal legislation against blasphemy.

- The closest equivalent to a blasphemy law is the section in IPC relating to Hate speech. **Hence statement 1 is incorrect.**
- It is often argued that **Section 295A is not a section for blasphemy but a section against Hate Speech.**
- **Sections 295 and 295A of the IPC:**
 - Involves **imprisonment** in the case, which involves destruction, damage to or defiling of a “**place of worship**”, or “**any object held sacred**”. **Hence statement 2 is correct.**
 - It is a **cognizable offence**, which means that the police are authorised to arrest accused persons without the need of a judicially sanctioned warrant.
- This law was added only in **1927.**
- **Constitutional Rights:**
 - The word secular in the preamble of the Constitution, makes it very clear that India is a **secular country and is not biased towards any particular religion.**
 - If the state abridged an Indian of his right to religion then he may move to the apex court under **Article 32. Hence statement 3 is correct.**

18. [ANS] a

[SOL] Option 1 is correct.

- Both India and Maldives are founding members of the **South Asian Association for Regional Cooperation (SAARC)**, the **South Asian Economic Union** and signatories to the **South Asia Free Trade Agreement**.
- They have consistently supported each other in multilateral areas such as the **UN**, the **Commonwealth**, the **NAM**, and the **SAARC**.
- **Option 2 is incorrect.**
- China, Russia and four Central Asian states — Kazakhstan, Kyrgyzstan, Uzbekistan and Tajikistan — were the founding members of the **SCO**, while India and Pakistan joined the grouping in 2017 in its first round of expansion.
- **Option 3 is incorrect.**
- ASEAN is an intergovernmental organization of ten Southeast Asian countries:
- Brunei, Cambodia, Indonesia, Laos, Malaysia, Myanmar, the Philippines, Singapore, Thailand, and Vietnam.

19. [ANS] a

[SOL] Recently, India updated its **Nationally Determined Contribution (NDC)**.

- **Updation of the pledge:**
- As per the Paris Agreement's provisions, countries must 'update' their pledges **every five years** to make higher commitments to greenhouse gas (GHG) emissions reductions. **Hence statement 1 is correct.**
- **Updated pledge:**
- India now stands committed to **reducing the emissions intensity** of its GDP by **45 percent** by **2030** from its 2005 levels, as per the updated NDC.
- The country will also target about **50 percent of cumulative electric power installed capacity** from **non-fossil fuel-based energy** resources by 2030.
- To further a healthy and sustainable lifestyle, '**LIFE**' '**Lifestyle for Environment**' as a **key to combating climate change**" has been added to India's NDC.
- **No sector-specific mitigation:**
- India will not be bound to any sector-specific mitigation obligation or action. **Hence statement 2 is incorrect.**
- The Indian delegation at the **UN's mid-year climate change conference (SB 56)** held in **Bonn** in **June 2022** was opposed to the **imposition of binding targets** for any sector, fuel or greenhouse gas.
- This was done **to avoid specific demands being placed** on its coal sector, or on **emissions of GHGs** such as **methane**.

20. [ANS] d

[SOL] Recently, the National Socialist Council of Nagalim (Isak-Muivah) marked **25 years of ceasefire** with the Government of India (GoI).

Statement 1 is not correct: Directorate of Enforcement enforces the following laws: -

- Foreign Exchange Management Act, 1999 (**FEMA**) - A **Civil Law**, with officers empowered to conduct investigations into suspected contraventions of the Foreign Exchange Laws and Regulations, adjudicate contraventions, and impose penalties on those adjudged to have contravened the law.
- Prevention of Money Laundering Act, 2002 (**PMLA**) - A **Criminal Law**, with the officers empowered to conduct investigations to trace assets derived out of the proceeds of crime, to provisionally attach/ confiscate the same, and to arrest and prosecute the offenders found to be involved in Money Laundering.

Statement 2 is not correct: is a specialized financial investigation agency under the **Department**

of Revenue, Ministry of Finance, Government of India.

21. [ANS] a

[SOL] Anti-Tank Guided Missiles (ATGM)

- **About:**
 - It is a guided missile primarily designed to **hit and destroy heavily armored military vehicles. Hence statement 1 is correct.**
 - ATGMs range in size from **shoulder-launched weapons**, which can be transported by a single soldier, to **larger tripod-mounted weapons**, which require a squad or team to transport and fire, to vehicle and aircraft-mounted missile systems.
- **HELINA & ATGM:**
 - **HELINA (Helicopter based NAG)** is a third-generation fire and forget class **Anti-tank Guided Missile (ATGM) system** mounted on the Advanced Light Helicopter (ALH). **Hence statement 2 is correct.**
 - **More about HELINA:**
 - The system has **all weather day and night capability** and can defeat battle tanks with conventional armour as well as explosive reactive armour.
 - **The HELINA missile** can engage targets both in direct hit mode as well as top attack mode.

22. [ANS] d

[SOL] International Atomic Energy Agency

- Popularly known as the world's "**Atoms for Peace and Development**" organisation, the IAEA is the **international centre for cooperation** in the nuclear field. **Hence statement 1 is correct.**
- It was **established on 29th July 1957** as an **autonomous organisation**, at the height of the Cold War (1945-1991) between the **US and the Soviet Union**.
- Post World War II (1945), the world got divided into two power blocs dominated by two superpowers, the **Soviet Union and the US**.
- The two superpowers were primarily engaged in an ideological war between the capitalistic ideals of the **West versus the communist ideals of the East**.
- It came to an end after the disintegration of the Soviet Union in 1991.
- **Though established independently** of the UN through its own international treaty, the agency **reports to both the UN General Assembly and the Security Council. Hence statements 2 and 3 are correct.**
- It works with the **member states and multiple partners** worldwide to promote the **safe, secure and peaceful use of nuclear technologies**.

23. [ANS] d

[SOL] Statement 1 is incorrect.

- Some REEs are available in India — such as **Lanthanum, Cerium, Neodymium, Praseodymium and Samarium**, etc.
- India has the world's fifth-largest reserves of rare earth elements, nearly twice as much as Australia
- Others such as Dysprosium, Terbium, and Europium, which are classified as HREEs, are **not available** in Indian deposits in extractable quantities.

Statement 2 is incorrect:

- Minerals Security Partnership (MSP) is a US-led partnership initiative that **aims to bolster critical mineral supply chains**.
- The new grouping is aimed at **catalysing investment** from **governments** and the **private sector** to develop **strategic opportunities**.
- **The US and 10 partners** — Australia, Canada, Finland, France, Germany, Japan, the

Republic of Korea (South Korea), Sweden, the United Kingdom, and the European Commission — have come together to form the MSP. - India is not the part of MSP

Statement 3 is correct.

- **Electric vehicles:**
- Minerals like Cobalt, Nickel, and Lithium are required for batteries used in **electric vehicles**.

24. [ANS] d

[SOL] LIBOR rose for the fourth straight session, rising roughly 2.5 basis points to 2.83229%, the highest since November 2008.

Statements 1, 2 and 3 are correct: LIBOR is a **benchmark interest rate** at which major global banks lend to one another in the **international interbank market for short-term loans**.

- It serves as a **globally accepted key benchmark interest rate** that indicates **borrowing costs between banks**.
- **Administered by**
- **the Intercontinental Exchange**, which asks major global banks how much they would charge other banks for short-term loans.
- The rate is calculated using the **Waterfall Methodology**, a standardised, transaction-based, data-driven, layered method.
- It has been subject to manipulation, scandal, and methodological critique, making it less credible today as a benchmark rate.
- It is being replaced by the Secured Overnight Financing Rate (SOFR) on June 30, 2023, with phase-out of its use beginning after 2021.

25. [ANS] b

[SOL] Collegium System

- It is the system of appointment and transfer of judges that has evolved through **judgments of the Supreme Court**, and **not by an Act of Parliament** or by a provision of the Constitution. **Hence statement 1 is incorrect.**
- The Supreme Court collegium is **headed by the Chief Justice of India** and comprises **four other senior-most judges** of the court. **Hence statement 2 is correct.**
- **A High Court collegium** is led by **its Chief Justice and four other senior-most judges** of that court.
- Names recommended for appointment by a High Court collegium reaches the government only after approval by the CJI and the Supreme Court collegium.
- Judges of the higher judiciary are appointed only through the collegium system, and the government has a role only after names have been decided by the collegium.

Role of Government in Judicial Appointment

- The government's role is limited.
- It can only get an inquiry conducted by the Home Ministry if a lawyer is to be elevated as a judge in a High Court or the Supreme Court. **Hence statement 3 is incorrect.**
- It can also raise objections and seek clarifications regarding the collegium's choices.
- But if the collegium reiterates the same names, the government is bound, under Constitution Bench judgments, to appoint them as judges.

26. [ANS] d

[SOL] Ocean thermal energy conversion (OTEC) is a form of energy conversion that **makes use of the temperature differential** between the **warm surface waters** of the oceans, **heated by solar radiation**, and the **deeper cold waters**

- OTECs are used to **generate power** in a **conventional heat engine**.
Beyond the production of clean power, the OTEC process also provides several useful by-products.
- The delivery of cool water to the surface has been used in **air-conditioning systems** and in **chilled-soil agriculture** (which allows for the cultivation of temperate-zone plants in tropical environments). **Hence options 1 and 2 are correct.**
- Open-cycle and hybrid processes have been used in **seawater desalination**, and OTEC infrastructure allows access to **trace elements present in deep-ocean seawater**. **Hence option 3 is correct.**
- In addition, **hydrogen can be extracted** from water through **electrolysis** for use in fuel cells. **Hence option 4 is correct.**

27. [ANS] d

[SOL] Salient features of the “Medical Termination of Pregnancy Act 2021”:

- **Abortions before 20 weeks of pregnancy:**
 - Terminating a pregnancy up to 20 weeks will only require the medical advice of one doctor. **Hence statement 1 is incorrect.**
- **Abortions upto or beyond 24 of pregnancy:**
 - Abortion is legal for women in certain circumstances **up to 24 weeks**.
 - It would include:
 - survivors of rape, victims of incest and other vulnerable women (like differently-abled women, minors) etc.
 - Opinion of 2 providers is required for termination of pregnancy of 20-24 weeks of gestation.
 - A **state-level medical board** will be set up to decide:
 - if pregnancy may be terminated beyond 20 months till 24 months.
 - Such a decision can be taken by the medical board only after
 - due consideration and
 - ensuring that the procedure would be safe for the woman.
 - The time frame available to the Medical Board is 3 days.
 - **The upper gestation limit does not apply** in cases of **substantial foetal abnormalities** diagnosed by the **Medical Board**.
- **Increase in Gestational limit only in certain cases:**
 - It enhances the **gestational limit for legal abortion from 20 to 24 weeks** only for specific categories of women.
 - A woman who does not fall into these categories would not be able to seek an abortion beyond 20 weeks.
- **Intentionally causing a miscarriage:**
 - Section 312 of the Indian Penal Code holds intentionally causing a miscarriage as a criminal offence. **Hence statement 2 is incorrect.**

28. [ANS] d

[SOL] The Criminal Procedure (Identification) Act:

- The Act **replaces** the similar **colonial-era Identification of Prisoners Act, 1920**.
- The new law allows **investigators** to collect certain **identifiable information** of convicts and other persons for purposes of **identification and investigation in criminal matters**.
- The new law provides a legal sanction to the police to take physical and biological samples of **convicts as well as those accused of crimes**. **Hence option 1 is correct.**
- **Records of juveniles:**
 - The Act **does not** explicitly bar **taking measurements of juveniles**. **Hence option 2 is correct.**
- The provisions of the (Special Act) **Juvenile Justice Act, 2015** regarding the destruction

- of records of conviction under the Act, shall apply.
 - The Act also seeks to apply to persons detained under any preventive detention law. **Hence option 3 is correct.**
29. [ANS] c
[SOL] In News : Recently, the Monetary Policy Committee (MPC) of the Reserve Bank of India **hiked the policy repo rate** by 50 basis points to 5.4 per cent, a three-year high owing to inflation concern.
Statements 1 and 2 are correct: Repo Rate: The interest rate at which the Reserve Bank provides liquidity under the liquidity adjustment facility (LAF) to all LAF participants against the collateral of government and other approved securities.
Marginal Standing Facility (MSF) Rate: The penal rate at which banks can borrow, on an overnight basis, from the Reserve Bank by dipping into their Statutory Liquidity Ratio (SLR) portfolio up to a predefined limit (2 per cent). This provides a safety valve against unanticipated liquidity shocks to the banking system. The MSF rate is placed at 25 basis points above the policy repo rate.
30. [ANS] a
[SOL] In News : Recently, **China** launched aggressive and unprecedented military exercises near **Taiwan** in response to **US** House Speaker Nancy Pelosi's visit to the island that China claims as part of its territory.
- It was adopted by Taiwan in 2017 when Lee Hsi-Ming, then-chief of the Taiwanese military forces, referred to it as the "Overall Defence Concept" (ODC).
31. [ANS] a
[SOL] Composition of NITI Aayog:
- **Chairperson:** Prime Minister of India. **Hence statement 1 is correct.**
 - **The Governing Council** consists of the Chief Ministers of all the States and Lt. Governors of Union Territories in India. **Hence statement 2 is incorrect.**
 - The NITI Aayog's governing council is the premier body tasked with evolving a shared vision of national priorities and strategies with the involvement of the States and Union Territories.
 - It presents a platform to discuss **inter-sectoral, inter-departmental** and **federal issues**.
 - **Chief Executive Officer:**
 - The CEO will be appointed by the Prime Minister for a fixed tenure. **Hence statement 3 is incorrect.**
 - He will be in the rank of Secretary to the Government of India.
32. [ANS] c
[SOL] Peninsular Rock Agama (*Psammophilus dorsalis*)
- It is a type of garden lizard that has a **strong presence in southern India**.
 - It is a **large animal, strikingly** coloured in orange and black.
 - They **do not generate their own body heat**, so they need to seek warmth from external **sources like a warm rock or a sunny spot on the wall**.
 - They are important in ecology from different aspects — they can indicate **which parts of the city are warming, and their numbers show how the food web is changing**.
33. [ANS] c
[SOL] Recently, an **annual long-term monitoring** report by the Australian Institute of

Marine Science (AIMS) was released on the Great Barrier Reef's recovery and vulnerability to climate threats.

Statement 1 is correct: A coral reef is an underwater ecosystem characterized by reef-building corals. Reefs are formed of colonies of coral polyps held together by calcium carbonate. The coral polyps live in an endosymbiotic relationship with algae. Algae provides up to 90 percent of the coral's energy.

Statement 2 is not correct: The temperature of the water should not be below 20°C. The most favorable temperature for the growth of the coral reefs is between 23°C to 25°C. The temperature should not exceed 35°C.

Statement 3 is correct: Corals can survive only under saline conditions with an average salinity between 27% to 40%.

[SOL] According to the Home Ministry data, **only three** Indian Police Service (IPS) officers have **offered themselves to be available** for Central deputation.

The position is a cadre post for the Indian Administrative Services (IAS). The appointee for the office is approved by the state Chief minister. The appointment is made in the name of the **Governor of the State**. There is no fixed tenure imposed on the office but the term can be extended for 6 months.

Statement 2 is not correct: In his capacity, the CS is a member of the State Disaster Management Authority (SDMA). He is equivalent in rank to a Secretary to Government of India. The Chief Secretary is in charge of overall Law and Order of the State. He has powers to transfer any officer of any rank **after consulting** the Chief Minister. His signature in all Government Orders passing any law in the state is necessary.

[SOL] ASEAN - India Relations

● **Delhi Dialogue:**

- The 'Delhi Dialogue' (DD) mechanism is hosted by **India annually**. Hence **statement 1 is correct**.

- However, **scheduled areas**, predominantly inhabited by the **tribal population**, were **exempted** from the new amendments.
- Thus Parliament enacted special legislation called **Panchayat (Extension to Scheduled Areas) Act (PESA) in 1996**.
- **Objectives:**
- To **extend the provisions of Part IX** of the Constitution relating to the Panchayats to the

- Scheduled Areas with **certain modifications**. Hence statement 1 is correct.
- To provide **self-rule** for the bulk of the tribal population.
- To have **village governance** with **participatory democracy** and to make the Gram Sabha a nucleus of all activities.
- To evolve a **suitable administrative framework** consistent with traditional practices.
- To **safeguard and preserve** the **traditions and customs** of tribal communities.
- **Applicability:**
- It is now applicable in the **Fifth Schedule areas**, which deals with the **administration of the districts** dominated by the **tribal communities**.
- It is in force in 10 states of the country.
- **Six States** namely Andhra Pradesh, Himachal Pradesh, Gujarat, Maharashtra, Rajasthan and Telangana have notified PESA Rules.
- The **remaining four States** namely Chhattisgarh, Jharkhand, Madhya Pradesh and Odisha should also frame PESA Rules and **start implementing them soon**. Hence statement 2 is incorrect.
- **In conflict with other legislations:**
- After enacting PESA, the Union Government brought **several other legislations** and included many provisions of PESA into these laws, shadowing its purpose and significance.
- For instance, the **Land Acquisition Act, 2013** empowered Gram Sabhas immensely.
- Similarly, **the Forest Right Act, 2006** has provisions of PESA and now when people need to protect their rights and resources, they look up to these laws. Hence statement 3 is incorrect.

[SOL] **The Convention on the Elimination of all Forms of Discrimination Against Women:**

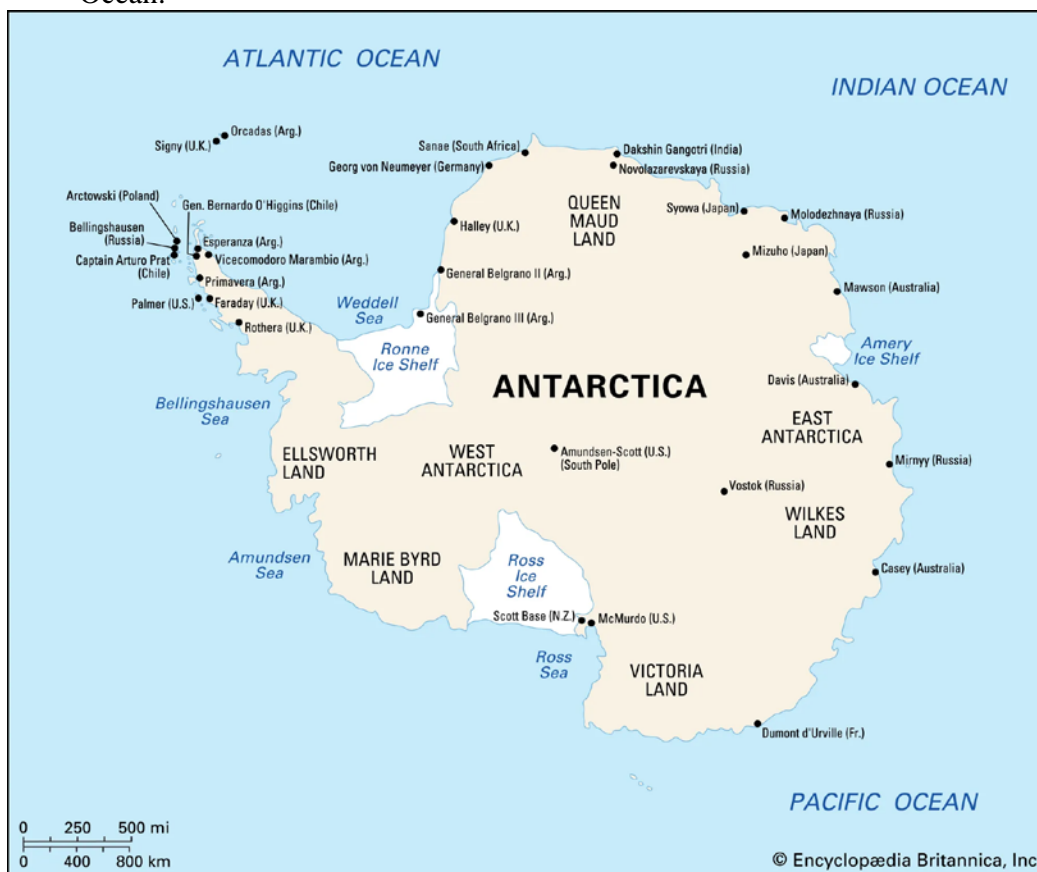

 - **Italy, Indonesia, and India** are the **Troika countries** right now. **Hence statement (d) is incorrect.**

[SOL] Criminal Procedure (Identification) Act, 2022

- **About:**
 - The Act **replaces** the similar **colonial-era Identification of Prisoners Act, 1920**.
 - The new law allows **investigators** to collect certain **identifiable information** of convicts and other persons for purposes of **identification and investigation in criminal matters**.
- **Key provisions:**
 - **Legal sanction of data collection:**
 - The new law provides a legal sanction to the police to take **physical and biological samples of convicts** as well as those **accused** of crimes. **Hence statement 1 is correct.**
 - It empowers police to collect:
 - Fingerprints
 - Palm prints and footprints
 - Photos
 - Iris and retina scans
 - Analysis of physical and biological samples
 - Behavioural attributes
 - Signature and handwriting
 - **Role of National Crime Records Bureau (NCRB):**
 - The law also empowers the **National Crime Records Bureau (NCRB)** to **store, preserve, share** with any law enforcement agency and destroy the record of measurements at the national level.
 - The records can be stored **up to a period of 75 years**. **Hence statement 2 is incorrect.**

[SOL] Monsoon Trough:

- Monsoon Trough is an **elongated low-pressure area** that extends from heat low over Pakistan to the Head Bay of Bengal. **Hence statement 1 is correct.**
- This is one of the semi-permanent features of monsoon circulation.
- Monsoon trough may be a characteristic of the east-west orientation of Himalayan ranges and the north-south orientation of Khasi-Jaintia Hills.
- The monsoon trough's **location, oscillation, and duration** over a specific location, all directly affect the rainfall activity over the regions exactly to the south of its position.
- That is, when it is **located to the south of its normal position**, there is active or **vigorous rainfall over most parts of central, peninsular India** regions. **Hence statement 2 is correct.**
- When it **shifts to the north of its normal position** or lays along the **Himalayan foothills**, Uttar Pradesh, Bihar, Jharkhand, West Bengal and the northeastern states benefit.

- **Active Euthanasia:** It is also known as 'Positive Euthanasia' or 'Aggressive Euthanasia'. It

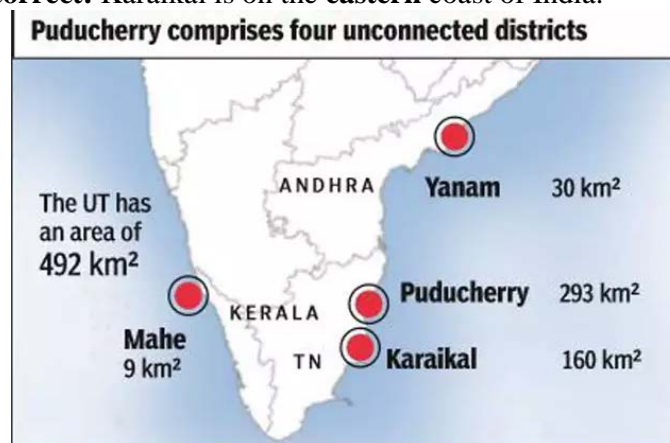
refers to causing intentional death of a human being by direct intervention. It is a direct action performed to end useless life and a meaningless existence.

- For example, by giving lethal doses of a drug or by giving a lethal injection. Active euthanasia is usually a quicker means of causing death and all forms of active euthanasia are illegal.
- **Passive Euthanasia:** It is also known as 'Negative Euthanasia' or 'Non-Aggressive Euthanasia'. It is intentionally causing death by not providing essential, necessary and ordinary care or food and water.
- It implies discontinuing, withdrawing or removing artificial life support systems.
- Passive euthanasia is usually slower and more uncomfortable than active. Most forms of voluntary, passive and some instances of non-voluntary, passive euthanasia are legal.

[SOL] **Statement 1 is not correct:** The Union Territory of Puducherry consists of **four small** unconnected districts: Puducherry district (293 km²), Karaikal district (161 km²) and Yanam district (20 km²) on the Bay of Bengal and Mahé district (9 km²) on the Laccadive Sea, covering a total area of 483 km².

 - **Birth:** Born on August 15, 1872, in Calcutta.
 - **Early life and Education:** At the **age of seven** he was taken to England for education.
- **Roles played as a**
 - **Service officer and professor:**
 - In 1893 returned to India and worked in the Princely State of Baroda in the service of the Maharaja and as a professor at Baroda College.
 - **Revolutionary:**
 - In 1906, he quit the job in **Baroda and went to Calcutta**.
 - Became one of the **leaders of the Nationalist movement** and took a leading role in secret preparations for an **uprising against the British Government in India**.
 - He was the **first political leader in India** to openly put forward the idea of **complete independence** for the country in his **newspaper Bande Mataram**.
 - Aurobindo's pragmatic strategies to get rid of British rule marked him as "**the Prophet of**

Indian Nationalism”.

- **Yogi**
- In 1910 he withdrew from politics and went to Pondicherry in order to devote himself entirely to his inner spiritual life and work.
- He evolved a new method of spiritual practice, which he called **Integral Yoga** and founded the Sri Aurobindo Ashram in 1926
- **Literary works:**
- The Life Divine, The Synthesis of Yoga and Savitri.
- He wrote a series on **Bankim Chandra’s Vande Mataram**, attributing divine nationhood to “**Mother India**” and depicting the independence struggle as the sacred cause of freedom.
- In 1943, he was nominated for the Nobel Prize for literature and then again in 1950 for the Nobel Peace Prize.

[SOL] Jhalkari Bai

- **Jhalkari Bai & Rani Laxmibai:**
- Jhalkari Bai was a soldier in Rani Laxmibai’s women’s army, **Durga Dal**.
- She rose to become one of the **queen’s most trusted advisers**.
- She is known for putting her own life at risk to keep the queen out of harm’s way.
- **Legacy:**
- To date, the story of her valour is recalled **by the people of Bundelkhand**, and she is often presented as a representative of **Bundeli identity**.
- According to the Ministry of Culture’s Amrit Mahotsav website, “Many **Dalit communities** of the region look up to her as an **incarnation of God** and also celebrate Jhalkaribai Jayanti every year in her honour.”

- [SOL] Recently, a **flare-up began between Azerbaijan and Armenia** after Azerbaijan claimed that it had captured the territory in Karabakh in a retaliatory campaign.
- **Statement 1 is not correct:** Nagorno-Karabakh region is a mountainous land-locked region in the South Caucasus. It is a forested region and geographically lies within the boundary of Azerbaijan. South Caucasus or Transcaucasia is a region on the southern Caucasus Mountains on the border of Eastern Europe and Western Asia. It roughly comprises of the modern countries of Azerbaijan, Armenia and Georgia.



- **Statement 2 is not correct:** Armenia is a landlocked country and does not share a border with the Caspian Sea.

[SOL] Fundamental Duties

- **Incorporation of Fundamental Duties:**
 - When the Constitution was adopted in the year 1949, there were no provisions regarding **Fundamental Duties to the Citizens** though there was a **Part III for Fundamental Rights**. Hence **statement 1 is incorrect**.
 - The Fundamental Duties of citizens were added to the Constitution by the **42nd Amendment in 1976**, upon the recommendations of **the Swaran Singh Committee** that was constituted by the Government.
 - The Committee suggested that steps needed to be taken to ensure that the individual did not overlook his duties while in the exercise of his Fundamental Rights.
 - The fundamental duties were incorporated in **Part IV-A of the Constitution**.
 - The concept of Fundamental duties was taken from the former **USSR**.
 - It **helps the Court** in determining the **constitutionality of the law**. Hence **statement 3 is correct**.
- **Article 51(A) describes 11 fundamental duties.**
 - 10 came with the 42nd Amendment;
 - 11th was added by the 86th Amendment in 2002
- **Fundamental Rights are justiciable, the Fundamental Duties are non-justiciable.** Hence **statement 2 is correct**.
 - It means that the violation of fundamental duties, i.e. the non-performance of these duties by citizens is not punishable.
 - These duties are not enforceable by law. However, a court may take them into account while adjudicating on a matter.

[SOL] Statement 1 is not correct: The Genetic Engineering Appraisal Committee (GEAC) functions in the Ministry of Environment, Forest and Climate Change (MoEF&CC). As per Rules, 1989, it is responsible for the appraisal of activities involving large scale use of hazardous microorganisms and recombinants in research and industrial production from the environmental angle. The committee is also responsible for the appraisal of proposals relating to the release of genetically engineered (GE) organisms and products into the environment including experimental field trials.

Statement 2 is not correct: Currently, the only GM crops permitted for cultivation in India is Bt Cotton. But several cases of cultivation of illegal GM crops (Brinjal, Soyabean etc) have been reported from across states in the last few months. A GM crop has a gene artificially inserted into it from another species to give it some desired properties like – pest resistance, herbicide tolerance, drought resistance etc.

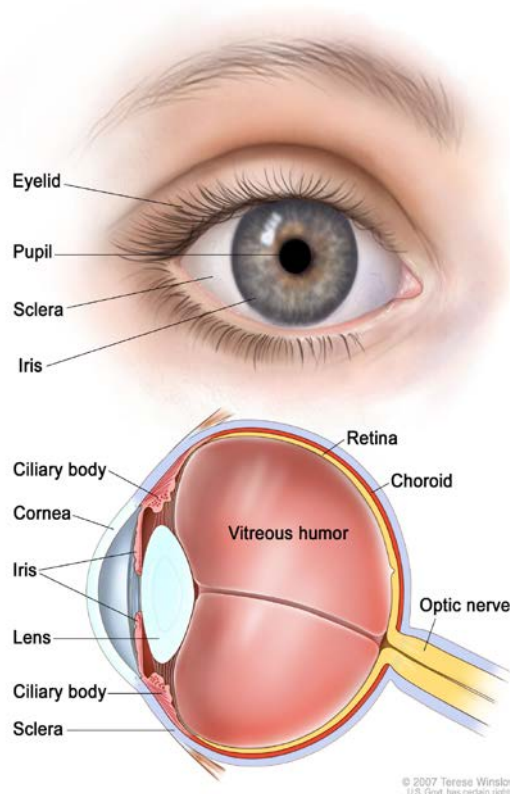

- Disturbances in the Earth's magnetosphere due to solar wind cause Auroras.
- These disturbances occur because of **enhancements in the speed of the solar wind from coronal holes and coronal mass ejections**. "
- While the skylights, **STEVE and the Auroras** might seem similar, they are **nothing alike**.

What is West Nile Virus?

- It is a mosquito-borne, single-stranded RNA virus.
- It is a member of the flavivirus genus and belongs to the Japanese encephalitis antigenic complex of the family Flaviviridae.
- It is commonly found in Africa, Europe, the Middle East, North America and West Asia.
- Transmission : Culex species of mosquitoes act as the principal vectors for transmission.
- It is transmitted by infected mosquitoes between and among humans and animals, including birds, which are the reservoir host of the virus.
- It can also spread through blood transfusion, from an infected mother to her child, or through exposure to the virus in laboratories.
- It is not known to spread by contact with infected humans or animals.
- To date, no human-to-human transmission of WNV through casual contact has been documented.
- Impact :It can cause neurological disease and death in people.
- Detection of WNV
- The virus was first isolated in a woman in the West Nile district of Uganda in 1937.
- It was identified in birds (crows and columbiformes like doves and pigeons) in the Nile delta region in 1953.
- Before 1997, WNV was not considered pathogenic for birds, but then, a more virulent strain caused the death in Israel of different bird species, presenting signs of encephalitis and paralysis.
- Preventive measures
- This vector-borne disease can be prevented by protecting one-self from mosquito bites.
- Other steps are wearing clothing that acts as a barrier to exposure to bites, reducing breeding sites, covering water storage containers, eliminating puddles and drainage of places where water accumulates, eliminating unusable containers where water pools, and controlling garbage in yards and gardens.

- Immobilization of toxic nitrogen species occurs more rapidly in biofloc because the growth rate and microbial production per unit substrate of heterotrophs are ten times greater than that of the autotrophic nitrifying bacteria.
- This technology is based on the principle of flocculation within the system.

 - Not all instances of very heavy rainfall, however, are cloudbursts.
 - A cloudburst has a very specific definition: **Rainfall of 10 cm or more in an hour** over a

- roughly **10 km x 10-km area** is classified as a cloudburst event.
- By this definition, 5 cm of rainfall in a half hour period over the same area would also be categorized as a cloudburst.
 - During a cloudburst event, a place receives about 10% of this annual rainfall within an hour.
 - **Frequency of Cloudbursts:**
 - Cloudbursts are **not uncommon events**, particularly during the monsoon months.
 - Most of these happen in the **Himalayan states** where the **local topology, wind systems, and temperature gradients** between the **lower and upper atmosphere** facilitate the occurrence of such events.
 - **Consequences:**
 - **Flash floods** are mostly the result of cloudbursts.
 - Even if cloudburst & flash floods is a localized activity, the consequences of these events are not confined to the small areas.
 - Because of the nature of terrain, the heavy rainfall events often trigger landslides and flash floods, causing extensive destruction downstream.

 - The apex court has also stated that the **Governor, in no way, shall favour any party** when it comes to the timing of the trust vote.
- **In cases of disqualification of rebel MLAs:**
 - The Supreme Court has also specified that the **Governor can go ahead and call for a trust vote even if there are cases of disqualification** of rebel MLAs pending before the Speaker of the House, and **not wait for the Speaker's decision. Hence statements (a) and (b) are correct.**
- **The 2019 Pratap Gowda Patil vs State of Karnataka case:**
 - The top court, in this case, ruled that the rebel MLAs have the right to skip the floor test voting process in the House. **Hence statement (c) is correct.**

[SOL] Statements 1 and 2 are not correct: It is caused by the infection of cattle or buffalo with the poxvirus Lumpy skin disease virus (LSDV). The virus is one of three closely related species within the genus capripoxvirus, the other two species being Sheeppox virus and Goatpox virus. Historically, LSD has remained confined to **Africa**, where it was first **discovered in 1929**, and parts of West Asia. LSD was first reported in Asia and the Pacific region in 2019 in northwest China, Bangladesh and India.

[SOL] Recently, a tripartite MoU was signed for the swift development of a **modern Multi Modal Logistics Park (MMLP)** under Bharatmala Pariyojna.

Statement 1 is not correct: The **Ministry of Road Transport and Highways** has conducted a thorough study of the NH network and has approved overall investment for the construction of about 34,800 km (including 10,000 km of residual NHDP segments) at a cost of Rs 5,35,000 crore.

Statement 2 is correct: The creation of Multimodal Logistics Parks and the removal of chokepoints would improve the efficiency of current routes.

Multimodal Logistics Parks are an important policy effort of the Indian government to enhance the country's logistics industry by lowering total freight costs, reducing vehicle pollution and congestion, and lowering storage expenses.

[SOL] Option D is correct: It is a **blood** disorder in which the body has less haemoglobin than normal. The disorder results in extreme damage of red blood cells, which leads to a condition where the body doesn't have sufficient regular healthy red blood cells. This condition in medical terms is called Anaemia. The disorder is primarily inherited by individuals from their parents.

[SOL] Option D is correct: The Singapore Convention on Mediation is a uniform and efficient framework for international settlement agreements resulting from mediation. It applies to international settlement agreements resulting from mediation, concluded by parties to resolve a commercial dispute.

101. [ANS] c

[SOL] Scheduled Castes and Tribes (Prevention of Atrocities) Act:

- In **1989**, the Government of India enacted the **Scheduled Castes and Tribes (Prevention of Atrocities) Act** in order to prevent atrocities against SC/STs.
- The purpose of the Act was **to prevent atrocities** and help in the social inclusion of Dalits into society.
- **Cognizable offence:**
 - All offences listed in the Act are cognizable. **Hence statement 1 is correct.**
 - The police can arrest the offender **without a warrant and start an investigation** into the case without taking any orders from the court.
- **Punishments:**
 - The Act prescribes **both minimum as well as maximum punishment**. **Hence statement 4 is correct.**
 - The minimum in most cases is six months imprisonment while the maximum is five years sentence and with a fine.
 - In some cases, the minimum is enhanced to one year while the maximum goes up to life imprisonment or even death sentence.
- **Creation of Special Courts:**
 - The POA mandated the creation of Special Courts precisely to circumvent this problem; only **a few states have created separate Special Courts** in accordance with the law. **Hence statement 2 is correct.**
- **Conviction:**
 - Even if cases make it to trial, the POA also suffers from **abysmal rates of conviction**. **Hence statement 3 is incorrect.**
 - **Judicial bias against Dalits** is rampant and unchecked, and court decisions frequently bear the mark of such bias.

[SOL] Statement 1 is correct:

- **One Nation One Ration Card (ONORC)** aims to ensure **hassle-free delivery** of **subsidised food grains** to all **migratory beneficiaries** anywhere in the country through **nation-wide portability** under National Food Security Act (NFSA).

- ONORC is rolled out by the **Ministry of Consumer Affairs, Food and Public Distribution**.
- The Union Labour Ministry has developed a National Database of **Unorganised Workers (NDUW) portal** and the **eShram portal** for registration of labourers spread over 400 occupations including in constructions, agriculture, fishing, dairy, self-employed and even ASHA and anganwadi workers.

[SOL] Statement 1 is not correct: The Geological Survey of India (GSI) is a scientific agency of India. It was founded in 1851, is a Government of India organization under the **Ministry of Mines**, one of the oldest of such organisations in the world and the second oldest survey in India after Survey of India (founded in 1767), for conducting geological surveys and studies of India.

Statement 2 is correct: GSI is the official participant in steel, coal, metals, cement, power industries and international geoscientific forums. It is also the prime provider of basic earth

science information to the government, industry and general public.

104. [ANS] d

[SOL] Rani Gaidinliu was born on January 26, 1915, in the present-day **Tamenglong district of Manipur and died in 1993.**

- She was the **Naga spiritual and political leader** who belonged to the **Rongmei tribe (also known as Kabui).**
- She led an armed uprising against the British in Manipur, Nagaland and Assam
- In 1927, at the age of 13, Gaidinliu, along with her cousin **Haipou Jadonang, joined the Heraka movement**, which aimed at the **revival of the Naga tribal religion and establish self-rule of the Nagas (Naga Raj) ending the British rule.**
- Jawaharlal Nehru called her the “**Daughter of the Hills**” and gave her the title “**Rani**” or **queen** acknowledging her role in the struggle against the British,
- In 1972, she was awarded Tamara Patra by the Government of India for her contribution to the freedom movement.
- She also received the Padma Bhushan in 1982.
- In 1996, the Union government issued a commemorative postage stamp in her honour.
- **Vivekananda Sewa Summan in 1983, and Stree Shakti Puraskar in 1991.**
- She posthumously was awarded the **Bhagwan Birsa Munda Puraskar in 1996.**
- The Government of India also issued a commemorative stamp in her honour in the same year.
- **The Centre also released a Rs 100 commemorative coin in 2015 on the occasion of her 100th birth anniversary.**
- The Indian Coast Guard commissioned a **Fast Patrol Vessel “ICGS Rani Gaidinliu”** in 2016.

[SOL] **Statement 1 is not correct:** He is appointed by the Appointments Committee of the Cabinet.

Statement 2 is correct: The main role of CEA is to produce an Economic Survey.

Statement 3 is correct: He is head of the Economic Division of the Department of Economic Affairs, Ministry of Finance.

[SOL] **Battery Waste Management Rules, 2022:**

- The new rules **replace the Batteries (Management and Handling) Rules, 2001.**
- The new rules **cover all types of batteries -**
 - Electric Vehicle batteries,
 - Portable batteries,
 - Automotive batteries and
 - Industrial batteries.
- **Extended Producer Responsibility (EPR):**
- The rules function based on the concept of Extended Producer Responsibility (EPR). **Hence statement 1 is correct.**
- The **producers (including importers)** of batteries are responsible for the **collection and recycling/refurbishment** of waste batteries
- They are also responsible for the **use of recovered materials** from **wastes** into new batteries.
- **Recycling:**

- EPR mandates that **all waste batteries** to be collected and sent for recycling/refurbishment, and its **prohibits disposal in landfills and incineration. Hence statement 3 is correct.**
- **Environmental compensation:**
- On the principle of **Polluter Pays Principle**, environmental compensation will be imposed **for non-fulfilment** of Extended Producer Responsibility targets, responsibilities and obligations set out in the rules. **Hence statement 2 is correct.**

[SOL] Context

Recently, India and Bangladesh have finalized the text of Memorandum of Understanding (MoU) on interim water sharing of Kushiya river.

[SOL] Statement 1 is not correct: The Kushiya River is a distributary river in **Bangladesh and Assam, India**. From its origin at the mouth of the Barak, also known as the Amlshid bifurcation point, the Kushiya flows westward forming the boundary between Assam, India, and the Sylhet District of Bangladesh. It forms on the India-Bangladesh border as a branch of the Barak River, when the Barak separates into the Kushiya and Surma.

Statement 2 is correct: The waters of the Kushiya thus originate in the state of Nagaland in India and pick up tributaries from Manipur, Mizoram and Assam.

[SOL] Net Zero: A state in which a **country's emissions are compensated by absorption and removal** of greenhouse gases (GHGs) from the atmosphere is called Net Zero State; it is also referred to as carbon-neutrality. **Hence statement 1 is correct.**

- The report is recently released in **New Delhi** and it is named as ‘**Getting India to Net Zero**’.
- **Statement 2 is incorrect. The report was released by:**
- Former Australian prime minister **Kevin Rudd**, also the president of Asia Society Policy Institute,
- Former UN Secretary-General and Global Green Growth Institute President & Chair **Ban Ki-moon**,
- International Finance Corporation’s Head and Director of Climate Business, **Vivek Pathak** and
- Former Indian foreign secretary **Shyam Saran**.

Panchamrit strategy:

- Hon. PM Narendra Modi's **Panchamrit strategy** was announced at the COP 26 in Glasgow conference into enhanced climate targets.
- India will increase its **non-fossil fuel energy capacity to 500 gigawatt (GW) by 2030**.
- It will meet **50 percent of its energy requirements** from renewable sources **by 2030**.
- The total projected carbon emissions will be reduced by **1 billion tonnes** from now through 2030.
- The carbon intensity of its economy will be brought down **to less than 45 percent**.
- India will achieve its target of **net zero by 2070. Hence statement 3 is incorrect.**

[SOL] In Context India is to develop two hydropower projects in Nepal, namely the West Seti Hydropower Project and the Seti River Hydropower Project.

- The Seti Gandaki River is also known as the Seti River or the Seti Khola.
- The Seti river is a river of western Nepal.
- It originates from the glaciers around the twin peaks of Api and Nampa in the south facing slopes of the main Himalayas. The area is near the tri junction of the borders of Nepal, India (Uttarakhand), and China.

- The river finally joins the Karnali or Ghagra River (which is Nepal's longest river).

[SOL] In News : Recently, the ministry of chemicals and fertilizer has issued directions to all companies to use the new brand name, Bharat, and logo of the subsidy scheme on the bags.

- The concept of **One Nation-One Fertilizer (ONOF)** will be implemented from October 2, 2022.
- As part of the initiative, crop nutrients -- urea, di-ammonium phosphate (DAP) or muriate of potash (MOP) will be **sold under a single brand name**, 'Bharat' irrespective of the manufacturing companies.
- All fertilizer bags, whether containing urea or di-ammonium phosphate (DAP) or muriate of potash (MOP) or NPK will sport the brand name '**Bharat Urea**', '**Bharat DAP**', '**Bharat MOP**' and '**Bharat NPK**' irrespective of the company that manufacturers (private or public)

[SOL] In News : Recently, the 13th edition of the 21-day **India-US Joint Special Forces Exercise Vajra Prahar 2022** culminated at Bakloh in Himachal Pradesh.

- The Vajra Prahar series of joint exercises aims to share best practices and experiences in areas such as joint mission planning and operational tactics as also to improve interoperability between the Special Forces of both Nations.
- This annual exercise is hosted alternatively between India and the United States.

[SOL] In News : The CWRC near Kaziranga National Park has completed 20 years of providing emergency care, treatment and rehabilitation to indigenous wild animals displaced due to various reasons.

CWRC is a joint initiative of the Assam Forest Department, the Wildlife Trust of India (WTI) and the International Fund for Animal Welfare (IFAW)

- It was established on August 28, 2002.
- It currently has two satellite facilities called mobile veterinary services. These are located in eastern Assam at Guijan in Tinsukia district (Dibru Saikhowa National Park) and in western Assam at Charaikhola (Chakrashila Wildlife Sanctuary).
- It continues to be the only facility in India to have successfully addressed the welfare and conservation of 357 species including elephant, leopard, rhino, tiger, clouded leopard, black bear, wild buffalo, hog deer, muntjac, wild boar and monkeys.

[SOL] In News : Recently, the Union Minister of Education and Skill Development presented certificates to NDMC workers for completing the Recognition of Prior Learning (RPL) program in Delhi.

Statement 1 is not correct : The Ministry of Skill Development and Entrepreneurship launched Pradhan Mantri Kaushal Vikas Yojana in the year 2015.

- Recognition of Prior Learning is a component of the PMKVY Scheme. It is being implemented under the SANKALP Programme. The implementing agency for the programme is the National Skill Development Corporation (NSDC).

Statement 2 is correct : Recognition of Prior Learning (RPL) program is a process used to evaluate a person's existing skill sets, knowledge and experience gained either by working

on-the-job or learning over the years.

114. [ANS] c

[SOL] In News : Pradhan Mantri Jan Dhan Yojana (PMJDY) - **National Mission for Financial Inclusion** recently completed eight years of its implementation. PMJDY is National Mission for Financial Inclusion to ensure access to financial services, namely, Banking/ Savings & Deposit Accounts, Remittance, Credit, Insurance, Pension in an affordable manner. The scheme was launched based upon the following 6 pillars:

- Universal access to banking services – Branch and BC
- Basic savings bank accounts with overdraft facility of Rs. 10,000/- to every eligible adult(**Statement 1 is not correct**)
- Financial Literacy Programme– Promoting savings, use of ATMs, getting ready for credit, availing insurance and pensions, using basic mobile phones for banking
- Creation of Credit Guarantee Fund – To provide banks some guarantee against defaults(**Statement 2 is correct**)
- Insurance – Accident cover up to Rs. 1,00,000 and life cover of Rs. 30,000 on account opened between 15 Aug 2014 to 31 January 2015(**Statement 3 is correct**)
- Pension scheme for Unorganized sector(**Statement 4 is correct**)

115. [ANS] c

[SOL] In News : **Artemis I** is set to lift off from the Kennedy Space Center launching an Orion spacecraft toward the **moon** for 42 days.

Artemis I, formerly Exploration Mission-1 and It will be the first integrated flight test of NASA's Deep Space Exploration Systems:

- the Orion spacecraft, Space Launch System (SLS) rocket, with the newly upgraded Exploration Ground Systems at Kennedy Space Center in Cape Canaveral, Florida.
- It is an uncrewed mission but the first step toward putting humans back on the moon since the 1972 Apollo 17 mission. It is essentially a safety test. But future missions will include people.
- The primary operating goal of the mission is to assure a **safe crew module entry, descent, splashdown, and recovery.**

[SOL] In News : Recently, Bihar's newly formed government called for withdrawing the general consent to the CBI.

Statement 1 is not correct : Central Bureau of Investigation (CBI) is the premier investigating police agency in India.

- It has its origin in the **Special Police Establishment set up in 1941** to probe **bribery and corruption during World War II.**
- It was set up by a **resolution of the Ministry of Home Affairs in 1963** after the **Santhanam committee recommendation.**

Statement 2 and 3 are correct : It functions under the **Department of Personnel, Ministry of Personnel, Pension & Public Grievances, Government of India.**

The CBI is governed by The **Delhi Special Police Establishment (DSPE) Act, 1946.**

- **It must mandatorily obtain the consent of the state government concerned** before beginning to investigate a crime in a state.
- The state government's consent to CBI can be **either case-specific or general.**

- **General consent** is usually given by states **to help the CBI in the seamless investigation of cases of corruption** against central government employees in their states.
- This is consent by default, in the absence of which the CBI would have to apply to the state government in every case, and before taking even small actions.

[SOL] In News : Recently, the Union Social Justice Ministry received 402 applications online from across the country for benefits under the **Scheme for Economic Empowerment of Denotified, Nomadic, Semi-nomadic (SEED) Tribes**.

Various Committees Set up for Empowerment of DNTs

- **Ayyangar Committee, 1949:**
 - After the independence of India, there had been a persistent demand by the Central Legislature that the Criminal Tribes Act be repealed as it seeks to classify particular classes of people as criminals and is not aligned with the dignity of free India.
 - For this, The Criminal Tribes Enquiry Committee was set-up 1949-1950 chaired by M Ananthasayanam Ayyangar.
 - After a detailed study of the working of the Criminal Tribes Act throughout the country, it submitted its report in 1950, in which it made several recommendations for the repeal of the Act.
 - The Committee also emphasized the need for allocation of adequate funds for their welfare and rehabilitation.
 - The Government of India accepted some of the recommendations of the Ayyangar Committee. It repealed the Criminal Tribes Act with effect from 31 August 1952 by the Criminal Tribes (Repeal) Act, 1952 (Act No XXIV of 1952).
- **Kalelkar Committee, 1953:**
 - The first Backward Class Commission was appointed on 29 January 1953 under the Chairmanship of Mr. Kakasaheb Kalelkar.
 - This Commission suggested that the erstwhile „Criminal Tribes“ should not be called „Tribes“ nor should the names „Criminal“ or „Ex-Criminal“ be attached to them. They could be called Denotified Communities.
 - It further recommended that “these groups may be distributed in small groups in towns and villages where they would come in contact with other people, and get an opportunity for turning a new leaf.
 - This would help in their eventual assimilation in society”.
- **Idate Commission, 2014:**
 - In February 2014, the Ministry of Social Justice & Empowerment took a historic decision to constitute a National Commission for De-Notified, Nomadic and Semi Nomadic Tribes for a period of three years.
 - The Commission gave its report in December, 2017. In its report, the commission prepared draft lists of DNT/NT/SNT Communities.
 - This Commission was tasked among others to identify and proper listing of these communities in different states, to evaluate the progress of development of these communities in the states so that a systematic approach can be developed for the development of these communities.
 - Based on the recommendations of the Idate Commission, the Government of India constituted the **Development and Welfare Board for DNTs, SNTs & NTs (DWBDNCs)** in 2019.

118. [ANS] d

[SOL] In News : Recently, **India’s largest telecom company Reliance** announced the launch of its **5G services in Delhi, Mumbai, Kolkata, and Chennai** this year with an aim to expand and cover the entire country by 2023.

- The company said it will launch its 5G services on **standalone 5G architecture**.

Statements 1 and 2 are not correct : In the standalone mode the 5G network operates with dedicated equipment, and runs parallel to the existing 4G network, while in the non-standalone mode, the 5G network is supported by the 4G core infrastructure.

Given that the non-standalone networks are built on existing infrastructure, the initial cost and the time taken to roll out services through this track is significantly less than standalone networks. Jio has committed an investment of Rs 2 lakh crore for its standalone 5G network.

[SOL] In News : Recently, the Supreme Court has reiterated that **bail is the rule and jail is the exception.**

- The jurisprudence of bail in post-independent India, is anchored on the bedrock of **Article 21 of the Constitution** which safeguards not only life but also liberty by commanding that liberty can be deprived only through the procedure established by law, which must be “just, fair and reasonable”

[SOL] In News : India Council for Research on International Economic Relations (ICRIER), in collaboration with India Cellular and Electronics Association (ICEA) prepared a report titled as ‘Globalise to Localise: Exporting at Scale and Deepening the Ecosystem are Vital to Higher Domestic Value Addition.

ICRIER Established in August 1981, ICRIER is a policy-oriented, not-for-profit, economic policy think tank.

- ICRIER conducts thematic research in the following five thrust areas:
 - Growth, Employment and Macroeconomics (GEM)
 - Trade, Investment and External Relations (TIER)
 - Agriculture Policy, Sustainability and Innovation (APSI)
 - Digital Economy, Start-ups and Innovation (DESI)
 - Climate Change, Urbanisation and Sustainability (CCUS)

[SOL] A team of officials from the International Atomic Energy Agency (IAEA) arrived in Ukraine to assess the **condition of the Zaporizhzhia Nuclear Plant**

- Zaporizhzhia is an important town in the Ukraine’s southeast that houses the largest nuclear power plant in Europe.
 - It is about 40 km (25 miles) up the **Dnieper River** from the nuclear plant
- Ukraine has four nuclear power stations comprising 15 reactors.
 - The plant at **Zaporizhzhia** has six reactors, which together produce about **5,700 MW of electricity**. Nuclear energy caters to about half of **Ukraine’s power demand**.

[SOL] Mission Karmayogi:

- It was launched **in 2020** with the objective of enhancing governance through “**Civil Service Capacity Building**”.
- **Focus:**
 - On promoting ease of living and ease of doing business, by considerably enhancing the **citizen-government interface. Hence statement 1 is correct.**
 - This involves creation of both **functional and behavioural competencies** among the civil servants.
- **Significance:**
 - It will improve human resource management practices among the officers.
 - It will focus more on **role based management**. It will aim to **allocate roles and jobs based**

- on competencies of the officers.
- **‘Lateral Entry’ into Bureaucracy:**
 - The term lateral entry means the **appointment of specialists and experts**, mainly those from the **private sector**, in government organizations and ministries.
 - **Aim:**
 - To recruit **outstanding individuals**, with expertise in **revenue, financial services, economic affairs, agriculture, cooperation and farmers’ welfare, road transport and highway, civil aviation, commerce** among many other sectors to serve for the benefit of the country.
 - **Details:**
 - These lateral entrants into the civil service will be offered a **three-year contract**, which the government can extend to five years depending on performance. **Hence statement 2 is correct.**

[SOL] The Special Marriage Act, 1954

- **About:**
 - The Special Marriage Act, 1954 is an **Act of the Parliament of India** with provision for **civil marriage or "registered marriage"**.
 - The Act deals with **inter-caste and inter-religion marriages**. **Hence statement (a) is correct.**
 - **Inter caste marriage** is a marriage between people of two different castes.
 - **Inter religion marriage** is a marriage between people of two different religions.
- **Applicability:**
 - Any **person, irrespective of religion**.
 - This Act is applicable to the **entire territory of India** and extends to **intending spouses** who are **both**,
 - **Indian nationals**.
 - Indian national **living abroad**. **Hence statement (b) is correct.**
- **Notice of 30 days:**
 - The SMA **requires couples getting married** under it to give a notice to the **Marriage Officer** 30 days before the date of marriage. **Hence statement (c) is correct.**
 - Such a notice is then entered into the **Marriage Notice Book** maintained by the Marriage Officer, which **can be inspected by “any person desirous of inspecting the same”**.
- **Displaying the notice & objections:**
 - These notices have to be also **affixed at a “conspicuous place”** in the office of the **Marriage Officer** so that anyone **can raise an objection** to the marriage. **Hence statement (d) is incorrect.**

124. [ANS] b

[SOL] **Option b is correct:** They are microscopic multicellular organisms known to tolerate extreme physiochemical conditions through a latent state of life known as cryptobiosis.

125. [ANS] a

[SOL] **Statement 1 is correct:** Western Disturbance (WD is an **extra-tropical storm** that originates in the **Mediterranean region**.

- The disturbance travels from the **“western” to the eastern direction** and gradually travels across the middle-east from Iran, Afghanistan and Pakistan to enter the Indian sub-continent.
- Disturbance means an area of **“disturbed” or reduced air pressure**.
- Equilibrium exists in nature due to which the air in a **region tries to normalize its**

pressure.

- In the term “extra-tropical storm”, the storm refers to low pressure.
- “Extra-tropical” means outside the tropics (as WD originates outside the tropical region).
- **Statement 2 is not correct:** The WD is not always the harbinger of good weather and Sometimes, they can cause extreme weather events like floods, flash floods, landslides, dust storms, hail storms and cold waves killing people, destroying infrastructure and impacting livelihoods.
