### History of December 30

- ♦ 1943 : Freedom fighter Subhash Chandra Bose hoisted the flag of India's independence in Port Blair.
- ◆ 1919: The first female student was admitted to law school in London.
- ◆ 1906 : All India Muslim League was established in Dhaka (now Bangladesh).
- ♦ 1803 : Britain's East India Company took control of Delhi, Agra and Bharuch.

### Current Affairs Related to 30 December

- The Government of India is on a mission to achieve comprehensive coverage for Ayushman Bharat Pradhan Mantri Jan Arogya Yojana by January 26, a massive undertaking to cover an additional 270 million individuals in its flagship health scheme. New instructions have been issued to central ministries and agencies that oversee welfare schemes. Emphasizing the need for rapid saturation of beneficiaries, thereby ensuring inclusion of all intended recipients.
- ♠ Arunachal State Rural Livelihood Mission has partnered with SBI to provide comprehensive banking services to Self Help Groups in the state, a strategic alliance for financial empowerment. The MoU signed between the two institutions aims to provide comprehensive banking services to the SHGs operating in the state.
- ▼ Telecom Bill 2023 has also got approval from Rajya Sabha. The Telecom Bill 2023 will replace the Telegraph Act 1885, the Indian Wireless Telegraphy Act 1933 and the Telegraph Wires Act 1950. The bill, led by Communications Minister Ashwini Vaishnaw, outlines provisions to stop and intercept transmission of messages in case of public emergency. It emphasizes that such measures are necessary to prevent incitement to commit crimes in times of crisis.
- Tamil Nadu government said that Tamil Nadu has retained the achiever status in the recently released ranking of better logistics system 2023 among various states. The LEADS initiative, launched in 2018 by the Union Ministry of Commerce and Industry, serves as a standard mechanism to assess the performance of logistics across states and union territories.
- ♦ Bhupendra Yadav unveiled the G20 report, Green and Sustainable Development Agenda for the Global Economy, in New Delhi addressing environment, labor and climate change concerns.

- The Reserve Bank of India unveiled a draft framework for self-regulatory organizations targeting banks and NBFCs. Its objective is to supervise banks, non-banking financial companies and other entities under its regulatory purview. Seeking public input by January 25, 2024, the draft outlines the eligibility criteria and operational guidelines for potential SROs.
- Rajasthan and Andhra Pradesh are leading in solar park planning capacities. Two major Indian states, Rajasthan and Andhra Pradesh, have made significant progress in deploying high capacities under the scheme Development of Solar Parks and Ultra Mega Solar Power Projects. The initiative, launched in December 2014 with an initial capacity of 20,000 MW, was later expanded to 40,000 MW in March 2017, with the aim of setting up at least 50 solar parks by 2023.2024.
- ♦ Crompton Greaves Consumer Electricals Limited has been awarded the National Energy Conservation Award 2023. Business Head Sachin Fartiyal accepted the award on behalf of the company. This honor was presented by the President of India Draupadi Murmu and the Ministry of Power.
  - The Institute of Chartered Accountants of India, recognized as the world's largest professional body of Chartered Accountants, has recently released a new logo that reflects its commitment to the India First approach and its role as a trusted partner in nation building. Reflect the role. The unveiling took place at the Global Professional Accountants Convention in Gandhinagar, where Vice President Jagdeep Dhankhar and Commerce and Industry Minister Piyush Goyal were present.
- ♦ Shri Pradeep Kumar Das, Chairman and Managing Director, Indian Renewable Energy Development Agency Limited, has been awarded the prestigious CMD of the Year award under the Mini Ratna category at the 13th PSE Excellence Awards.
