History of 4th April

- ♦ 1910: The theorist Sri Aurobindo Ghosh moved to the Pondicherry area where he established a yoga and spiritual centre.
- ◆ 1997: The World Bank declared India as the fifth largest economy in the world.
- ♦ 1995 : India's famous magician, freedom fighter and educationist Hansa Mehta passed away.
- 2013 : Nine people were killed in a salt murder incident in Chhattisgarh.

Current Affairs Related to 4th April

- Former Indian team captain Mahendra Singh Dhoni has achieved another special achievement in T20 cricket. Dhoni took his 300th wicket in T20 cricket when he took the catch of Prithvi Shaw against Delhi in IPL 2024. It became the world's first equity, with 300 victims behind it. Indian cricket team's legendary player Mahendra Singh Dhani was the first person to earn money in the world. He achieved this feat against Delhi Capitals in IPL. Dhoni has become the first player in the world to reach this figure.
- More than 60 products across India have been granted the Geographical Indication tag. This is the first time that such a large number of GI tags have been given simultaneously. Among these, six traditional crafts of Assam - Ashrikandi terracotta craft, Pani Meteka craft, Sarthebari metal craft, Jaapi, Mishing handloom products and Bih Dhol have been provided GI tag.
- Wipro-G Study, a leading player in medical technology and digital solutions, is set to invest Rs 8,000 crore in India in the next five years. This investment aims to strengthen its manufacturing production and R&D capabilities. The company is focused on initial expansion of its Make in India for the World initiative to include local localization of medical devices and products.
- ♦ Kotak Mahindra Bank has acquired Sonata Finance. Kotak Mahindra Bank has purchased 100 percent of Sonata Finance. The bank has given this information in the return filing. Now after this acquisition, Sonata Finance has become a wholly owned subsidiary of Kotak Mahindra Bank. Sonata 549 car is operational in 10 states.
- ♦ According to the latest data from the Reserve Bank of India, India's foreign exchange reserves reached a new peak in the week ending at 642.631 bank dollars, marking a consecutive prosperous week of growth.

- In a significant step to reshape India's aerospace, new space and defense industry, Indian Institute of Management Mumbai has partnered with Starburst, a leading European aerospace, new space and defense accelerator. The objective of this collaboration is to strengthen the mechanism for leveraging ASD studios and expertise in India.
- Axis Bank has announced a digital US dollar fulfillment deposit located in Bhagwan City, Gujarat. Axis Bank launches digital US fixed dollar for NRIs in UK. The bank said in a statement that it has become the first bank to launch digital travel in collaboration with Axis Bank. Bank N customers can now deposit US dollars in full at Give City through Open by Axis Bank.
- ♦ SATCOM Association of India and Brazilian Satellite Communications Association ABRASAT, have joined forces to promote progress in the space sector. The objective of this designation is to promote cooperation between India and Brazil and to promote innovative enterprises and technological cooperation.
- ◆ Jammu and Kashmir High Court Chief Justice N Kotiswar Singh administered the oath of office to Mohammad Yousuf Wani as additional judge. Jammu and Kashmir High Court General Shekhawat Azim conducted the swearing-in ceremony in the Chief Justice's chamber.
- Arnab Banerjee, Managing Director and CEO of CEAT Limited, has been elected as the new President of the Automotive Tire Manufacturers Association. ATMA is the national industry body representing the automotive tire sector in India. Urban Banerjee joined CEAT in 2005 as Vice President Sales and Marketing.
