## History of 6th July

- ♦ 1787: The Indian Botanical Garden was established in Shibpur, West Bengal.
- ♦ 1885 : Louis Pasteur conducted the final test for the treatment of rabies.
- ♦ 1783 : Richard III became king of England.
- ♦ 1944: Netaji Subhash Chandra Bose called Mahatma Gandhi the Father of the Nation for the first time.
- ♦ 1962: Nathula was closed again due to the India-China war.

## Current Affairs Related to 6th July 2024

- The Bureau of Financial Advisers has selected Challa Srinivasulu Seddi as the next Portfolio Director of State Bank of India. Ashwini Tiwari and Vinay Tons were also two other candidates for this post. Setty will replace current Dinesh Khara when he turns 63, which is the highest age limit for the post of Chief of Duty. His term is planned to end in August 2024.
- The next phase of conservation of Great Indian Bustard and Lesser Florican has been approved by the Ministry of Environment, Forest and Climate Change. The government has allocated Rs 56 crore for this next phase of the conservation scheme. The plan includes habitat development, in situ conservation, completing the construction of a conservation breeding centre, and releasing captive-bred birds. Wildlife Institute of India will estimate the population of GIB in Jaisalmer and other states.
- ↑ The Indian Trust Code, the Indian Civil Protection Code and the Indian Evidence Act were passed in Parliament in December 2023. They will replace the Indian Penal Code 1860, the Code of Criminal Procedure 1973 and the Indian Evidence Act 1872 respectively. Three new criminal laws received Parliament's approval on 21 December 2023.
- ◆ Japan issues new bank notes. It is the world's first
  use of state-of-the-art holography to show moving
  portraits of historical figures in 3D. Due to new
  technology, blind or sighted people will be able to
  feel and recognize the posture they have. For people
  who are blind or visually impaired, tactile symbols
  will also help with identification. By the end of March
  2025, approximately 7.5 billion new banknotes will
  have been printed.
- ◆ Indian Navy has successfully developed and certified a new explosive bomb named MTHMG 2. It is 2.01 times more powerful than standard TNT.

- The Reserve Bank of India has increased the limit of aggregate ways and means advance for states and union territories by 28% from Rs 47,010 crore to Rs 60,118 crore. This amendment aims to help states and union territories manage temporary mismatches in their financial flows.
- Ministry of Provident Fund and Program Implementation has launched eSankhyiki portal to improve data access and revolutionize user experience. The initiative aims to centralize and make accessible access to key national level data to aid planners, policy makers, debates and the public. The Data Catalog module of the portal integrates over 2291 datasets, including national audits, consumer price indices and more.
- Vienna, Austria has secured first place in the Global Liveability Index for the third consecutive year. The city has achieved a score of 98.4 on the global index. The Global Liveability Index ranks 173 cities in five categories, including sustainability, healthcare, culture and environment, education and infrastructure.
- Ravi Aggarwal has been appointed as the new deputy commissioner of the Central Board of Direct Taxes. He is a 1988 batch IAS officer. Ravi Aggarwal has replaced Indian Revenue Service officer Nitin Gupta. Agarwal is currently serving as a member on the board. He will remain on this post till June next year. Their scheduled appointments have been made in September this year, but their appointment orders have asked them to be re-appointed on contract basis till June 30 next year.
- ♦ Union Bank of India has launched Union Premier branches for high value customers in the rural and semi urban marketplace. These platforms are designed to provide a wide range of personal banking services and products under one roof.
