History of January 10

- ◆ 1616: British ambassador Sir Thomas Roe met Jahangir in Ajmer.
- ♦ 1863: The world's first underground railway service started in London.

Current Affairs Related to 10 January

- Researchers have developed new electronic soils. It will be used for soil-less farming methods like hydroponics. Researchers found that e-soil helped barley plants grow an average of 50% more. E-soil is made of cellulose. It is a biopolymer blended with a conductive polymer called PEDOT. High voltage has been used before by researchers to stimulate roots. Researchers are not sure whether e-soil can solve the problem of food security.
- After talks with truck drivers, the central government will implement the new hit and run law. Truck drivers' unions called off their nationwide protest against new penal provisions in the Indian Judicial Code regarding hit-and-run cases. The Home Ministry said this after discussing the strike with representatives of the second All India Motor Transport Congress. The new law provides that if drivers cause a serious road accident by negligent driving and run away without informing the police or any administrative officer, they can be punished with imprisonment of up to 10 years or a fine of Rs 7 lakh.
- Flipkart co-founder Binny Bansal has come up with a new startup, Oppdoor, that will help e-commerce companies expand operations globally by providing end-to-end solutions. The company is registered in Singapore and was founded in May 2021, according to the filing. According to a Moneycontrol report, Oppador was previously known as Three State Ventures Pvt. Ltd.
- Ravindra Kumar Tyagi has been appointed as the new Chairman and Managing Director of Power Grid Corporation of India Limited. He previously held the post of Director in POWERGRID. He has extensive experience of over three decades. He has also served as the North Eastern Region Head of POWERGRID.

- The interest rate on three-year fixed deposits has been increased by 10 basis points to 7.1% for the months of January to March 2024. The interest rate on Sukanya Samriddhi Account Scheme has been increased by 20 basis points to 8.2% for the period January March 2024. All other small savings schemes will continue to be offered at the same interest rates.
- CM Yogi Adityanath unveiled UP's inaugural floating air-conditioned restaurant managed by UPSTDC at Sangam City, which promises a transformative dining experience along the banks of the beautiful Yamuna river. The restaurant, managed by the Uttar Pradesh State Tourism Development Corporation, will redefine the dining experience for visitors on the picturesque Yamuna River.
- ♦ The government of Chad has taken an important step towards establishing civilian rule by appointing former opposition leader Success Massara as Prime Minister of Chad. Masra, who recently returned to the country from exile, is expected to play a key role.
- Uttar Pradesh has stood first for the third consecutive year in registering the highest admission rate on the Inter-Operable Criminal Justice System Platform. The Directorate of Prosecution Uttar Pradesh has so far registered 1,56,22,514 entries on the ICJS platform. The ICJS platform has been conceptualized by the e-Committee of the Supreme Court and implemented by the Ministry of Home Affairs.
- M S Swaminathan Award was given to Professor B R Kamboj. He has been honored with this prestigious award in recognition of his contribution as a scientist and extension specialist in the field of agricultural science. The award ceremony took place at the International Conference on One Health One World at Rajmata Vijayaraje Scindia Agricultural University in Gwalior, Madhya Pradesh.
- ♦ GST revenue growth slowed to a 3-month low in December. Gross GST revenue collection in December 2023 stood at Rs 1,64,882 crore.
