History of February 16

- ◆ 1987: The submarine-to-submarine missile was inducted into the Indian Navy.
- ♦ 1918 : Luthiana declared itself independent.
- ♦ 2001 : Iraq was attacked by American and British planes.
- ◆ 1982 : The Jawaharlal Nehru International Gold Cup football tournament was organized for the first time in Calcutta.
- ◆ 1745: Thorale Madhavrao, the fourth Peshwa of the Maratha Empire, was born.

Current Affairs Related to 16 February

- The Union Cabinet has extended the refund scheme for apparel and made-up exports till March 31, 2026. The Cabinet had earlier approved this scheme till 31 March 2020. After this the scheme was approved till 31 March 2024. The expansion of the scheme will help in improving export competitiveness. The objective of the scheme is to offset the State and Central taxes and levies on exports of apparel/garments and made ups through rebates other than duty drawback scheme.
- ◆ India has doubled the amount of sovereign gold bond issuance to Rs 3500 crore for the next financial year, underscoring the success of SGBs in shifting investor interest away from physical gold.
- The ancient tradition of the Olympic torch relay will continue its journey at Paris 2024, with the flame crossing the Mediterranean Sea and embarking on a 68-day adventure across France. Abhinav Bindra, India's first individual Olympic gold medalist and IOC Athletes Commission member, is one of the 11,000 torchbearers selected to carry the iconic symbol.
- India has officially launched the Unified Payment Interface at the iconic Eiffel Tower in Paris, an important step towards realizing Prime Minister Narendra Modi's vision of globalizing UPI. The initiative follows the Digital Payments Sector Agreement signed between India and France in July last year, making France the first European country to adopt India's UPI for retail transactions.
- Prime Minister Narendra Modi launched the Commonwealth Legal Education Association Commonwealth Attorneys and Solicitors General Conference 2024 at Vigyan Bhawan, New Delhi, focusing on cross-border challenges in justice delivery.
- Reserve Bank of India announced the successful withdrawal of 97.50% of Rs 2000 notes from circulation.

- The Government of India has announced that Lal Krishna Advani, one of the most prominent figures of Indian politics, will be honored with the Bharat Ratna, the country's highest civilian award. This prestigious honor is a testimony to Advani's indelible contribution to Indian politics and society over many decades.
- In a concerted effort to strengthen child protection measures, the Ministry of Women and Child Development has taken up the development of two important portals: Track Child Portal and GHAR Go Home and Re-Unite Portal. These platforms play an important role in tracking missing and found children, enhancing restitution and repatriation processes, and protecting the welfare of vulnerable minors within the scope of the juvenile justice system.
- The University Grants Commission has issued guidelines to provide equal opportunities for socioeconomically disadvantaged groups in higher education institutions. The guidelines are in line with the recommendations of the National Education Policy 2020. It emphasizes access, equity and inclusivity in higher education for socioeconomically disadvantaged groups. The University Grants Commission recommended that all universities and higher education institutions should follow these guidelines to improve the educational opportunities of socioeconomically disadvantaged students.
- PM Modi inaugurated the Commonwealth Legal Education Association Commonwealth Attorneys and Solicitors General Conference in New Delhi. Important issues of law and justice will be discussed during the conference. Some of these issues are judicial change and the ethical dimensions of legal practice, executive accountability and revisiting modern legal education.
- UPI has been formally launched at the Eiffel Tower in Paris, France. Indian tourists can now buy tickets for Eiffel Tower through UPI. Eiffel Tower is the first merchant to offer UPI payments in India. France has become the first European country to accept UPI.


