- PNB MetLife India Insurance has announced Sameer Bansal as its new Managing Director and Chief Executive Officer, effective July 1, 2024. Bansal, who currently serves as Chief Distribution Officer, brings over 25 years of financial leadership experience to his new role. He succeeds Ashish Srivastava, who is relocating to India as MD of MetLife Inc's Global Shared team.
- ◆ Pakistan, Somalia, Panama, Denmark and Greece will hold the positions for a two-year term starting January 1, 2025, replacing Japan, Malta, Mozambique, Ecuador and Switzerland. These newly elected members will join Algeria, Guyana, Republic of Korea, Sierra Leone and Slovenia as other permanent members.
- ♦ 900 crew members have been successful in the main tunnel of Arun 3 hydropower project being built with the help of India. The Prime Minister of Nepal, Shri Pushpa Kamal Dahal Prachanda inaugurated the tunnel by conducting the final blast to mark the completion of the excavation for the 11.8 km long Head Race Tunnel of the 900 km Arun-3 Hydroelectric Project in Sankhuwasabha district of Nepal.
- National Human Rights Commission has issued notices to four states Uttar Pradesh, Madhya Pradesh, Rajasthan and Gujarat. The notice follows a 2020 case in which a father sold his daughter for Rs 2.5 lakh and a complaint was filed with the commission after her death was later reported.
- In the first meeting of the joint venture on investment between India and Qatar, steps have again been taken towards strengthening the global credibility. The Finance Ministry said the meeting of the Joint Task Force was co-chaired by Ajay Seth, Secretary of the Department of Financial Affairs, and Mohammed bin Hassan Al Malki, Under Secretary of the Ministry of Commerce and Industry of Qatar.

- National Company Law Promotion Board approved the merger of Air India and Vistara. Therefore, the path has been cleared to become one of the largest airlines networks in the world. After the merger, Singapore Airlines will have 25.1 percent stake in Air India. Vistara is a joint venture between Singapore Airlines and the Tata Group. The Chandigarh bench of NCPT, in a 31-page judgment, approved the overall arrangement plan related to Air India and Vistara. All are part of Tata Group. Air India expects the merger to be completed by the end of this year.
- Telematics Development Centre, a major telecommunication research and development center, was established by the Government of India on 24 August 1984. Its mission is to revolutionize the telecommunication sector in India by developing cutting-edge technologies and products tailored to Indian conditions.
- All India Tennis Association has announced to give Dilip Bose Award to coach Nar Singh. The first award will be given to 69-year-old Rohini Lokhande, who was a member of the national team along with Kiran Bedi, Nirupama Mankad, Susan Das and Uday Kumar before getting into coaching. The All India Tennis Association instituted the Talent Award in the name of Dilip Bose in 2002.
- The Reserve Bank of India has launched its third global hackathon, Transforming Change 2024, which aims to develop innovative technology-based solutions to predict, detect and prevent financial fraud in real time. The hackathon has two main themes: zero financial fraud and disabled-friendly. Development of prototype to investigate, detect and prevent financial fraud in real time using alternative sources of data including publicly available information.
- India has formed a new alliance with America, South Korea, Japan and the European Union.






